

Commonwealth v. Brabham-Lawrence

Crimes and Criminal Procedure — Attempted Murder — Weight of the Evidence.

Defendant appealed the denial of his post-sentence motion, in which he argued that his conviction for attempted murder was against the weight of the evidence.

- 1. A trial judge cannot grant a new trial because of a mere conflict in testimony or because the trial judge on the same facts would have arrived at a different conclusion. Instead, a new trial should be granted only in truly extraordinary circumstances, i.e., when the jury's verdict is so contrary to the evidence as to shock one's sense of justice and the award of a new trial is imperative so that right may be given another opportunity to prevail. *Commonwealth v. Edwards*, 903 A.2d 1139, 1148-49 (Pa. 2006).
- 2. To sustain an attempted murder conviction, the Commonwealth must offer proof that the actor took a substantial step toward the commission of a killing with the specific intent to kill. *Commonwealth v. Anderson*, 650 A.2d 20, 24 (Pa. 1994); *Commonwealth v. Geathers*, 847 A.2d 730, 734 (Pa. Super. 2004). The necessary element of intent may be inferred from the circumstances even though direct evidence thereof is lacking. *Commonwealth v. Cross*, 331 A.2d 813, 814 (Pa. Super. 1974); see also *Commonwealth v. Blakeney*, 946 A.2d 645, 596 Pa. 510 (Pa. 2008), 129 S.Ct. 1317 (U.S. 2009).

Turgeon, J., January 14, 2013. – Defendant has filed an appeal from an order issued October 4, 2012, denying his post-sentence motion. Defendant argues that his conviction for attempted murder was against the weight of the evidence. This opinion is written in support of the judgment of sentence and of the order denying defendant's post sentence motion, pursuant to Pa.R.A.P. 1925(a).

BACKGROUND

Following a trial held February 27 through 29, 2012, a jury found defendant guilty of attempted homicide, carrying a firearm without a license, discharging a firearm into an occupied structure and recklessly endangering another person. These charges arose from defendant's shooting of the victim at his home around 10:30 p.m. on July 16, 2011, in retaliation for the victim's failure to provide defendant with two handguns defendant believed he had purchased from the victim.

The relevant testimony offered at trial is as follows: the victim, Michael Richards (a/k/a Michael Adams), knew defendant through mutual friends prior to being shot by defendant. (N.T. 140) At some point prior to the shooting, possibly on July 8, 2011, defendant, whom Richards knew as Izzy, contacted Richards through text messages inquiring whether Richards could sell him two handguns, indicating he had \$290 for the purchase. (N.T. 143-44, 148, 176-79; Exbt. C-29) Richards arranged the sale with defendant primarily through text messages, though Richards admittedly never intended to sell guns to defendant. (N.T. 179) Instead, Richards packed a backpack with car tools and a CD which he gave to defendant in exchange for cash in front of Richards' residence at 1309 Berryhill Street in Harrisburg. (N.T. 145-49) Defendant did not look inside the backpack at the time of purchase. (N.T. 150)

According to Richards, about a half hour later defendant called his then-girlfriend Kadija Smith, with whom he was living at 1309 Berryhill Street, threatening to kill Richards next time he saw him. (N.T. 150-51) In a statement he gave to police shortly after the shooting, however, Richards denied that defendant tried to contact him after the purchase (after defendant would have discovered he had not received the guns). (N.T. 368)

Kadija Smith testified that in 2011 she was living at her older sister Ethyl Green Alkarin in her second floor apartment at 1309 Berryhill Street. Michael Richards had moved to that apartment with Smith about a year earlier. (N.T. 106-07; see 342) Smith testified that Richards told her about the fraudulent gun transaction shortly after it happened. According to Smith, almost immediately thereafter, she answered a phone call from defendant to the cell phone which she shared with Richards, Ethyl and her brother John, all residents of the apartment. Defendant, who identified himself as Izzy, asked for Mike (Richards) after which he told Smith that "something's going to happen if I don't get my money back." He also allegedly said in the call that "I'm going

to kill Michael." (N.T. 121-24) Smith received about four more calls from defendant demanding his money back. She handed over later calls to her sister who told defendant to stop calling. (N.T. 123-24) Smith testified that she informed Richards about the threatening calls. (N.T. 126) Phone records showed that defendant called and/or texted the shared cell phone used by Richards 57 times around the time of the fraudulent sale. (N.T. 188-89; Exbt. C-29)

In a statement Smith gave to police just ten days following the shooting, she denied that Richards told her about the fraudulent gun sale after it happened. At trial, Smith admitted that statement had been a lie. (N.T. 128) Smith also admitted at trial that there was no mention in her police statement about defendant having made phone calls to her in which he made threats against Richards. (N.T. 133) Smith explained that she did tell the detective about the threats but that information did not get into her statement. (N.T. 133)

Smith also described an incident between defendant and Richards which occurred approximately a week before the shooting. While walking on the street with Richards, they ran into defendant and two of his friends. According to Smith, defendant and Richards had "fighting words" concerning the theft. (N.T. 116-19) Richards described a similar incident after the theft. He testified that while he and Smith were outside a local bar, he ran into the defendant who told him that "next time he see my face he was going to kill me." (N.T. 152, 190-91)

Richards testified that on the evening of the shooting, while walking to a local store for cigarettes, he was followed by a juvenile later identified as Erick Colon. Richards asked Colon what the problem was and Colon told him "you are the wrong person." (N.T. 157) Colon continued to follow Richards to and from the store during which Colon appeared to be talking on his cell phone. (N.T. 158)

Richards testified that after he reached his front porch and began to smoke a cigarette. He saw Colon across the street on the corner, still on his phone. (N.T. 160) Defendant soon approached Richards from his right, standing directly in front of the porch at 1309 Berryhill. (N.T. 163, 165) Richards watched as defendant reached into a black bag, pulled out a handgun and started to shoot at him from a distance of five to ten feet. (N.T. 163-64, 196) Richards stated that he was on the porch for four or five shots until he was able to run in the front door into the vestibule area leading upstairs to his second floor apartment. When just inside the door, he felt himself get shot in the leg. He ran upstairs while defendant continued to shoot through the house structure. (N.T. 166-67) Richards heard a total of ten or eleven shots. (N.T. 164-65)

Erick Colon, sixteen years old at the time of the shooting, was dating defendant's sister and considered defendant a friend. (N.T. 213-14) Defendant told Colon at some point that Richards had ripped him off by not selling him weapons for which Richards had paid. (N.T. 216-18) Colon stated that defendant was angry about that. (N.T. 218) On the evening of the shooting, Colon observed Richards walking on the street and began to follow him. He contacted defendant by text message to let him know of Richards' location in order to help defendant get his money back from Richards. (N.T. 221-23) Colon and defendant exchanged fourteen text messages between 10:00 and 10:16 that evening. (N.T. 245-47,252; Exbt. C-29, C-32, D-2)

Colon updated defendant about Richards' location while following him. When Richards was near his home, Colon lost sight of him and so he wandered off to find defendant. (N.T. 27) Shortly thereafter, Colon heard ten or so gunshots and ran back in the direction of Richards' home where he saw defendant holding a black bag. (N.T. 227, 229) Defendant met up with Colon and while leaving the area, defendant stopped, pulled a gun from his bag and threw it into a dumpster. (N.T. 230) According to Colon's trial testimony, during their flight from the shooting scene defendant told Colon he "was trying to scare Mike." (N.T. 230-31) Colon admitted, however, that in a statement he gave to police shortly after the shooting, he never mentioned that defendant said he had only been trying to "scare" Richards. Instead, Colon said in his police statement that defendant told him "he [Richards] wouldn't give him his money so he had to shoot him." (N.T. 232; Exbt. C-31) Colon explained at trial that the reason for his inconsistent trial statement was because he was trying to help the defendant, who he still considered a friend. (N.T. 237)

Colon was charged as an adult as an accomplice to aggravated assault and conspiracy to commit aggravated assault. His case was still pending as of defendant's trial. He claimed he had been offered no deals by the Commonwealth in exchange for his testimony, though he hoped his cooperation would assist his case and that a prosecutor had told him if he was lucky his case would be de-certified back to the juvenile system. (N.T. 211-12, 248-49)

Ethyl Green Alkarin testified that on the night of the shooting she was watching out her window waiting for Richards to return with her cigarettes. (N.T. 304, 324) While watching Richards walk back on the street toward her apartment, she noticed a boy (Colon) standing on the corner looking back and forth. (N.T. 305, 324) As Richards entered the

apartment, she noticed another person, later identified as defendant, approach on a bike, get off and walk across the street toward her home while holding a book bag. (N.T. 305-06, 311-12) She testified that defendant seemed to be looking for Richards but was unsure into which home he had entered. (N.T. 305, 313) She then heard someone try to open her front door which she assumed was her husband so she told Richards to open the front door for him. (N.T. 306, 314) While her husband walked around to the back door of the apartment, Richards walked down the stairs and opened the front door at which point Alkarin heard gun shots. (N.T. 306) Alkarin heard Richards slam the door shut and run back up the steps where they all took cover as numerous gun shots were fired into the house. (N.T. 306) After she got up, she returned to the window and saw defendant quickly move across the street while putting a gun in his book bag. Defendant then rode away on his bike. (N.T. 315-16)

Richards was taken by ambulance to a hospital. He was treated for a superficial abrasion to the lower right leg and a slightly deeper, non-penetrating abrasion of his lower left leg. Neither wound required sutures; both were cleansed and gauze dressings applied. Richards was given Tylenol for pain and discharged the same day. (N.T. 170, 196-98, 348-49; Exbt. C-51)

Police recovered ten 10 mm shell casings generally located in two areas on the sidewalk and street in front of 1309 to 1313 Berryhill Street. (N.T. see 346) Three casings were located directly in front of 1309 Berryhill and the others closer to 1313 Berryhill, between 25 and 50 feet away. (N.T. 69-73; Exbt. C-4) Testimony offered by police was that bullets caused interior structural damage to 1309 Berryhill, in both the lower and upper level apartments. (N.T. 80) Five bullets were recovered from inside the lower level apartment at 1309 Berryhill and there was damage to a bedroom, bathroom and closet. (N.T. 78-81, 93; Exbts. C-5 to C-13) In addition, a number of bullets struck the entrance area to the upper level apartment at 1309 and many of the bullet strikes were centered in the area of the doorway to the upper apartment used by Richards to flee from defendant's gunshots. (N.T. 87) These included two strikes just below a mailbox right outside that doorway, one strike on the door itself and one strike to a chair on the porch just outside the door. (N.T. 84-87; C-14 to C-24) No firearm was recovered though police testified that the bullets were likely fired from a semi-automatic weapon, given the number of casings found. (N.T. 94)

An officer who arrived on the scene within minutes of the shooting testified that although it was dark outside upon his arrival, the area was well lit and he had no trouble seeing up and down the street outside the home in question. (N.T. 48)

Following the conclusion of the trial, the jury found the defendant guilty of attempted murder, carrying a firearm without a license, discharging a firearm into an occupied structure, and recklessly endangering another person. I sentenced defendant on May 30, 2012 to an aggregate term of 100 to 236 months' imprisonment. Defendant filed a timely post sentence motion and following the submission of briefs by counsel, I denied the motion on October 4, 2012. Defendant filed a timely appeal therefrom, currently pending.

LEGAL DISCUSSION

Defendant raises one issue in his statement of errors raised on appeal: that the verdict for attempted murder was against the weight of the evidence whereby it merely showed that "defendant shot at the victim with the intent to scare and not kill him."

As set forth by our supreme court:

... a weight of the evidence claim is primarily addressed to the discretion of the judge who actually presided at trial. *Armbruster v. Horowitz*, 572 Pa. 1, 813 A.2d 698, 702 (Pa. 2002). It is axiomatic that it is the function of the jury as the finder of fact to determine the credibility of the witnesses. *Commonwealth v. Champney*, 574 Pa. 435, 832 A.2d 403, 408 (Pa. 2003), *cert. denied*, 542 U.S. 939, 124 S. Ct. 2906, 159 L. Ed. 2d 816 (2004) (citing *Commonwealth v. Johnson* 542 Pa. 384, 668 A.2d 97, 101 (Pa. 1995), *cert. denied*, 519 U.S. 827, 117 S. Ct. 90, 136 L. Ed. 2d 46 (1996)). Thus, the trial judge possesses only narrow authority to upset a jury verdict on a weight of the evidence claim:

A trial judge cannot grant a new trial "because of a mere conflict in testimony or because the trial judge on the same facts would have arrived at a different conclusion." [Commonwealth v. Brown 538 Pa. 410, 648 A.2d 1177, 1189 (Pa. 1994)], quoting [Thompson v. City of Philadelphia, 507 Pa. 592, 493 A.2d 669, 672-73 (Pa. 1985)]. Instead, a new trial should be granted only in

truly extraordinary circumstances, i.e., "when the jury's verdict is so contrary to the evidence as to shock one's sense of justice and the award of a new trial is imperative so that right may be given another opportunity to prevail." *Id.* [emphasis removed].

Armbruster, 813 A.2d at 703.

Commonwealth v. Edwards, 903 A.2d 1139, 1148-49 (Pa. 2006). The jury's verdict in this case was not contrary to the evidence but was, in fact, quite consistent with the credible evidence.

Under Pennsylvania law, "[a] person commits an attempt when, with intent to commit a specific crime, he does any act which constitutes a substantial step toward the commission of that crime." 18 Pa.C.S.A. § 901(a). "A person is guilty of criminal homicide if he intentionally, knowingly, recklessly or negligently causes the death of another human being." 18 Pa.C.S.A. § 2501 (a). "A criminal homicide constitutes murder of the first degree when it is committed by an intentional killing." 18 Pa.C.S.A. § 2502(a). Thus, to sustain an attempted murder conviction, the Commonwealth must offer proof that the actor took a substantial step toward the commission of a killing with the specific intent to kill. Commonwealth v. Anderson, 650 A.2d 20, 24 (Pa. Commonwealth v. Geathers, 847 A.2d 730, 734 (Pa. Super. 2004). "[T]he necessary element of intent may be inferred from the circumstances even though direct evidence thereof is lacking." Commonwealth v. Cross 331 A.2d 813, 814 (Pa. Super. 1974); see also Commonwealth v. Blakeney, 946 A.2d 645, 596 Pa. 510 (Pa. 2008), 129 S.Ct. 1317 (U.S. 2009) (whether the defendant had specific intent to kill can be inferred from the surrounding circumstances of the killing).

Defendant argues it was not proven that he had specific intent to kill. Defendant argues that the evidence proved instead that he intended only to scare Richards and not kill him. I disagree. The jury's finding that the Commonwealth presented evidence that defendant harbored the specific intent to kill by proof beyond a reasonable doubt was not shocking to one's sense of justice. The credible evidence was that on the day of the shooting, upon being alerted by Colon of Richards' whereabouts, defendant, with this short notice, appeared at Richards' home and pulled out what was likely a 10 mm semi-automatic handgun. Defendant then fired ten shots at Richards from a distance of between five and ten feet while Richards scrambled back behind the front door to his upstairs

apartment. Numerous bullets struck the immediate area from which Richards was fleeing including strikes just below a mailbox right outside that doorway, one strike to the door itself and one to a chair on the porch just outside the door. At the time of the shooting, defendant was described as angry at Richards for having been ripped off for the fraudulent gun sale/theft. In fact, following the theft, defendant attempted dozens of times to reach Richards on the cell phone he used. Some of these communications included threats against Richards, including at least one threat conveyed to his then girlfriend Kadija Smith that he intended to kill Richards. Richards ignored defendant's communications. Later, during the chance meeting between defendant and Richards outside a local bar, Richards claimed defendant told him that the next time he saw him he would kill him. Richards' girlfriend partially verified defendant's version of this confrontation, agreeing that defendant and Richards exchanged "fighting words."

The only testimony presented supporting defendant's claim that he shot at Richards merely to scare him was provided by Erick Colon, who testified that immediately after the shooting, defendant volunteered that he shot at Richards to "scare Mike." Colon admitted, however, that he never mentioned this alleged utterance by defendant in a statement he gave to police shortly after the shooting. Instead, Colon said in his police statement that defendant indicated almost the opposite: that defendant had to shoot Richards because Richards wouldn't give him his money back. Colon further explained at trial that the reason for his inconsistent trial testimony was because he was trying to help defendant, whom he still considered a friend.

Defendant also argued at trial that because Richards suffered only two superficial lower leg wounds this conclusively established that defendant never intended to kill Richards. This argument lacks merit given all the other evidence of an intent to kill, including defendant's motive, his multiple threats to kill Richards, his incessant attempts to contact Richards following the sale, and most notably, his discharge of a up to ten bullets from a semi-automatic weapon at Richards from close range. The fact the victim escaped with superficial wounds did not establish a lack of intent to kill but Richards' good fortune. "The offense of attempt with intent to kill is completed by the discharging of a firearm at a person with intent to kill, despite the fortuitous circumstances that no injury is suffered." *Commonwealth v. Cross* at 814. Accordingly, the credible evidence inferred from all the circumstances surrounding the shooting was that defendant shot at Richards with the intent to kill. *Id.; Blakeney, supra.*

Accordingly, I issued an order denying defendant's post sentence motion.




