windfall he had received absent a court order directing him to do so, and that father had an existing charge in Dauphin County for payment of arrears. Given the broad discretion afforded this court, it was entirely proper for this court to add mother's Berks County credit to father's Dauphin County arrears.

This decision is further consistent with the provisions of the Support Rules. Rule 1910.2-l(b) states that "if courts in two or more counties must be involved in the establishment and enforcement of an obligation for support: ... the case must proceed pursuant to the Intrastate Family Support Act.⁸" Pa.R.C.P. Rule 1910.2-1(b)(1). As noted, this court's involvement was in part necessitated by the Berks County case closure and by mother's inability to obtain relief there. That Intrastate Family Support Act applies to actions between parties from different counties in Pennsylvania. 23 Pa.C.S.A. § 8102. It includes provisions by which a support order issued by one tribunal may be registered for enforcement in any other tribunal of competent jurisdiction. 23 Pa.C.S.A. §§ 8401-02. Though this Act, like the Support Rules and the Domestic Relations Code, is generally addressed to the collection and enforcement of support and arrears, as opposed to overpayments, it must be considered as extending to the collection of overpayments in light of this court's broad discretion to enforce and correct overpayments. Mother's contact with Dauphin County in March 2010, by which she provided a notarized copy from Berks County of its "Statement of Arrears" there, should be considered as effectively in compliance with the registration requirements of the Act. See 23 Pa.C.S.A. § 8402(a).

Accordingly, I entered an order of support on September 20, 2010, directing that mother's overpayment of support in the Berks County action be added to father's support arrearage in this case.

Mihelich v. Fenstermacher

Domestic Relations — Child and Spousal Support — Income Calculation — Earning Capacity.

Obligee/Mother appealed a support order, contending that the Court erred in assigning incomes to each party for the purpose of calculating Obligor/Father's child and spousal support obligation. Her employment situation had changed from a forty (40) to a thirty-two (32) hour work

week, but the Court held her earning capacity to a full-time, forty-hour work week. Obligor's assigned income was based upon actual earnings.

1. A person's support obligation is determined primarily by the parties' actual financial resources and their earning capacity. Although a person's actual earnings usually reflect his earning capacity, where there is a divergence, the obligation is determined more by earning capacity than actual earnings. Earning capacity is defined as the amount that a person realistically could earn under the circumstances, considering his age, health, mental and physical condition, training, and earnings history. *Baehr v. Baehr*, 889 A.2d 1240, 1244-45 (Pa. Super. 2005).

2. A court may reduce a support obligation where a parent is fired for cause but has attempted to mitigate lost income. *Grigoruk v. Grigoruk*, 912 A.2d 311, 314-15 (Pa. Super. 2006).

TURGEON, J., February 28, 2011. – Support obligee Laureen Mihelich appeals to the superior court from a support order entered by this Court on November 30, 2010. She takes issue with the incomes assigned to each party for the purpose of calculating obligor Christopher Fenstermacher's child and spousal support obligation. This opinion is written in support of the support order entered, pursuant to Pa.R.A.P. 1925(a).

BACKGROUND

The parties were married in 1997 and separated in January 2009. They are the parents of two minor children over whom obligee maintains primary physical custody. On April 16, 2009, obligee filed a complaint seeking child and spousal support. Following a Domestic Relations Section conference, I signed the conference officer's recommended interim support order, dated May 15, 2009. Obligee thereafter filed a request seeking a *de novo* hearing. She argued that in calculating the support order, obligor should have been held to the income he was making in December 2008 as a pharmacist, when he was terminated by his employer for cause, instead of to the lower income he received thereafter working in his own newly formed pharmaceutical consulting company, Naritas. The sole issue addressed at the September 2, 2009 *de novo* hearing concerned obligor's income/earning capacity. I held that his gross annual income should be \$165,200 and directed that the Domestic

Relations Section calculate support assigning him that income.¹ My reasoning for determining obligor's income is set forth in *Mihelich v. Fenstermacher*, 124 Dauph. Co. Rptr. 158 (Jan. 8, 2010). Obligor filed a timely appeal which was denied by the superior court. *Mihelich v. Fenstermacher*, 1784 MDA 200 (Sept. 29, 2010) (unpublished).

As part of my September 25, 2009 orders, I directed an automatic review conference be scheduled for January or February 2010. That conference was eventually held on April 29, 2010 before a Dauphin County Domestic Relations Section conference officer. I signed the officer's recommended interim support order on April 29, 2010, effective February 1, 2010, directing that obligor pay support of \$1,339 per month, plus \$100 per month on arrears, allocated \$963 for child support, \$73 for spousal support and \$303 as a mortgage contribution. In arriving at these figures, the conference officer assigned obligor a gross income of \$80,559, or a net monthly income of \$5,155. These figures were based upon obligor's actual earnings in 2009. Obligee was assigned a net monthly income of \$3,607, which was derived from her income teaching at HACC.

Obligee Mihelich sought timely review and a *de novo* hearing was held before me on August 5, 2010. At the *de novo* hearing, obligee notified the court that her employment situation had changed whereby she had not been re-hired as an instructor by HACC. Instead, as of May 12, 2010, she began employment as a case manager nurse at Pinnacle Health, working thirty-two (32) hours per week. (N.T. 6) This admission prompted obligor's attorney to request that obligee be held to an earning capacity reflecting a forty (40) hour work week. (N.T. 9)

The issue of obligee's income was then discussed on the record. (N.T. 7-12) I agreed that obligee should be held to an earning capacity which reflected a full-time, forty-hour work week. (N.T. 9-10) According to obligee, she is limited to working thirty-two hours in her new job and claimed that it would be unlikely she could find an eight-hour per week position which paid her a rate near what she makes at Pinnacle Health or previously made at HACC. (N.T. 9-10) The issue was thus whether to

^{1.} I subsequently signed an order of support on September 25, 2009, which was calculated using this income. The order required as follows: (1) effective April 16, 2009, obligor was directed to pay \$3,633 per month, plus \$100 per month on arrears, allocated \$1,910 for children, \$1,607 for spouse and \$116 as a mortgage contribution; and (2) effective September 14, 2009, obligor's obligation was \$3,571 per month, plus \$100 per month on arrears, allocated \$1,896 for children, \$1,569 for spouse and \$106 for mortgage.

assign obligee her current income (35.17/hour), minimum wage (7.15/hour) or some figure in between for the additional eight hours. (N.T. 9-10) 1 took this issue under advisement.

The only other issue raised at the *de novo* hearing was a legal issue concerning obligee's contention that this court lacked jurisdiction to issue any orders of support because obligor's appeal to the superior court, from the September 25, 2009 support order, was still pending. (N.T. 12-21)

On November 30, 2010, I issued a support order with two effective dates and in two amounts. The first part of the order, effective February 1, 2010, basically adopted the prior recommended interim order whereby obligor was directed to pay \$1,339 per month plus \$100 per month on arrears, allocated \$963 for children, \$73 spouse and \$303 as a mortgage contribution. This order used the net monthly incomes assigned by the conference officer of \$5,155 for obligor and \$3,607 for obligee. The second part of the order, made effective May 12, 2010 (the date the new Support Guidelines became effective and also the date obligee agreed her new employment with Pinnacle commenced), reduced support to \$1,040 per month plus \$100 on arrears, allocated \$773 for children and \$267 for the mortgage contribution. Spousal support was not ordered.

In arriving at this figure, I assigned obligor the same \$5,155 net monthly income based upon his actual earnings. I increased obligee's net monthly income from \$3,607 to \$4,161. As noted, \$3,607 was obligee's net monthly income until May 12, 2010, based upon her employment with HACC in a teaching position. Thereafter, she began working thirty-two hours per week earning \$35.17 per hour. (N.T. 7-9) I ultimately decided to assign to her an hourly rate of \$10 for the additional eight hours per week she needed to make full-time hours. This income, when added to her actual income of \$35.17 per hour over a 32-hour work week, resulted in a total gross income of \$62,683 per year/\$5,224 per month, which translated to a net monthly income of \$4,161.² Obligee filed a timely appeal to the superior court from the second portion of the November 30, 2010 support order.

^{2.} This net monthly income figure was calculated under PACSES, which is the acronym for the Pennsylvania Automated Child Support Enforcement System. PACSES is a statewide computer system installed by the Pennsylvania Department of Public Welfare (DPW) for child support enforcement, as required under federal Title IV-D of the Social Security Act (42 U.S.C.A. §§ 651-69b). See, 55 Pa. Code § 108.2.

LEGAL DISCUSSION

In her statement of errors complained of on appeal, obligee argues as follows: (1) there was no material and substantial change in circumstances warranting a modification request by obligor; (2) the trial court erred by assigning to obligor an earning capacity that was too low whereby obligor "failed to obtain appropriate employment given his age, education, health, training and work experience"; and (3) the trial court erred by improperly assigning obligee an earning capacity higher than her actual income when her actual income reflected gainful employment.

With regard to the first issue raised – that there was no material and substantial change in circumstances warranting a modification request by obligor – I would note that obligor did not in fact request a modification. The support conference was scheduled pursuant to this court's September 25, 2009 order directing the Domestic Relations Section hold what was essentially a six-month automatic review. (N.T. 13-14) My reason for the shortened review period was due to the fact that the income figure used to determine obligor's support obligation included significant projections for what he might earn and it was unknown to this court whether such an income was in fact realistic. Furthermore, he had been assigned this higher income effective April 16, 2009 such that a review in early 2010 would encompass sufficient earnings history and reveal whether his income was accurate. Thus, the purpose of the review hearing was, effectively, to determine whether there had been a material and substantial change in his circumstances warranting modification of support, pursuant to the support rules. Pa.R.C.P. 1910.19(a). As it turned out, this was indeed the case.

Obligee's other issues on appeal concern the parties' incomes. The applicable Support Guidelines addressing a party's income for support purposes, are as follows:

Rule 1910.16-2. Support Guidelines. Calculation of Net Income.

(d) Reduced or Fluctuating Income.

(1) Voluntary Reduction of Income. When either party voluntarily assumes a lower paying job, quits a job, leaves employment, changes occupations or changes employment status to pursue an education, or is fired for cause, there generally will be no effect on the support obligation.

(2) Involuntary Reduction of, and Fluctuations in, Income. No adjustments in support payments will be made for normal fluctuations in earnings. However, appropriate adjustments will be made for substantial continuing involuntary decreases in income, including but not limited to the result of illness, lay-off, termination, job elimination or some other employment situation over which the party has no control unless the trier of fact finds that such a reduction in income was willfully undertaken in an attempt to avoid or reduce the support obligation.

(3) Seasonal Employees. ...

(4) *Earning Capacity*. If the trier of fact determines that a party to a support action has willfully failed to obtain or maintain appropriate employment, the trier of fact may impute to that party an income equal to the party's earning capacity. Age, education, training, health, work experience, earnings history and child care responsibilities are factors which shall be considered in determining earning capacity. In order for an earning capacity to be assessed, the trier of fact must state the reasons for the assessment in writing or on the record. Generally, the trier of fact should not impute an earning capacity that is greater than the amount the party would earn from one full-time position. Determination of what constitutes a reasonable work regimen depends upon all relevant circumstances including the choice of jobs available within a particular occupation, working hours, working conditions and whether a party has exerted substantial good faith efforts to find employment.

Pa.R.C.P. 1910.16-2(d).³

"[A] person's support obligation is determined primarily by the parties' actual financial resources and their earning capacity. Although a person's actual earnings usually reflect his earning capacity, where there is a divergence, the obligation is determined more by earning capacity than actual earnings. Earning capacity is defined as the amount that a

^{3.} The Rules of Civil Procedure promulgated by the Supreme Court, have the force of statute. *Maddas v. Dehaas*, 816 A.2d 234, 238 (Pa. Super. 2003), *appeal denied*, 827 A.2d 1202 (Pa. 2003).

person realistically could earn under the circumstances, considering his age, health, mental and physical condition, training, and earnings history." *Baehr v. Baehr*, 889 A.2d 1240, 1244-45 (Pa. Super. 2005) (citing *Woskob v. Woskob*, 843 A.2d 1247, 1251 (Pa. Super. 2004) (citations omitted)). "Where a party assumes a lower paying job or willfully fails to obtain appropriate employment, the support obligation is determined by his assessed earning capacity." *Woskob* at 1254 (citation omitted). It is the obligor's burden to prove that any income reduction was involuntary. *Grimes v. Grimes*, 596 A.2d 240, 242 (Pa. Super. 1991).

Obligee argues that this court erred by assigning obligor his current gross annual income of \$80,559 instead of a higher earning capacity similar to that earned under his prior job in the amount of approximately \$165,200. She claims that obligor, following his termination, failed to obtain appropriate employment given his age, education, health, training and work experience.

Notably, obligee failed to raise the issue of obligor's income at the *de novo* hearing. There was no discussion or evidence presented whatsoever by either party on this issue and as such, this court considers it waived. This court is cognizant that a *de novo* hearing amounts to a full consideration of the case anew; that is, the parties are not limited to the issues they can raise. *See, D'Arciprete v. D'Arciprete*, 470 A.2d 995, 996 (1984). Though there is no limitation on what issues might be addressed at a *de novo* hearing, a party must nevertheless raise an issue and present evidence in support of it if he or she wishes the court to address it. *Capuano v. Capuano*, 823 A.2d 995, 1002 (Pa. Super. 2003) ("the very essence of a *de novo* hearing entails that parties be permitted to present evidence"). As such, I had no reason to disturb that portion of the interim support order addressing obligor's income.

To the extent obligee did not waive this issue, this court initially notes that the order I issued on September 25, 2009, assigning obligor a gross annual income \$162,500 effective back to April 16, 2009, was not an earning capacity per se but was his projected actual income. As I recited in my opinion addressing obligor's income issue, he had been employed since 2005 as a pharmacist and pharmaceutical consultant with SAI Healthcare/IMS. He earned a base salary of \$128,800, which steadily increased to \$167,300 in 2008. His 2008 gross income, including miscellaneous income, was approximately \$182,000. Obligor was terminated by IMS for cause on December 1, 2008. In January 2009, following his termination, obligor started his own consulting company, Naritas. Obligor created a business plan by which he projected certain

net profits for Naritas as well as his annual income. I assigned him \$165,200 based upon Naritas' projected first year net profit of \$57,200, the \$60,000 in salary he intended to pay himself as well as \$48,000 income from a pending sale.

Because much of obligor's income was a projection based upon him embarking on a new business, the issue of whether he could actually meet this income projection was unclear. As such, I directed that the Domestic Relations Section hold a six month review. At this early review (April 29, 2010), the conference officer was able to assess obligor's income by reviewing his 2009 W-2 income statements, 1099 miscellaneous income statements and his S-corporation income. These documents revealed that his annual gross income was \$80,559, and that his prior income projection had been overly optimistic.⁴ As such, obligor was assigned an income reflecting this reality.

Furthermore, to the extent that obligor's income reduction in December 2008 was considered voluntary because I found he had been terminated for cause, I find that he has since attempted to mitigate his loss such that he is no longer subject to an assignment of that higher income; a parent's duty to mitigate such an income loss does not extend indefinitely. *See, Grigoruk v. Grigoruk*, 912 A.2d 311, 314-15 (Pa. Super. 2006) (a court may reduce a support obligation where a parent is fired for cause but has attempted to mitigate lost income).

Obligee lastly argues that it was error for this court to assign her a net monthly income of \$4,161. As noted, the current charging support order, effective May 12, 2010, was based upon my assignment to obligee of an annual gross income of \$62,683, or a \$4,161 net monthly income. The gross figure included \$58,523 she has/will earn making \$35.17 per hour over a 32-hour week, plus an additional \$4,160 gross per year she can earn making \$10 per hour eight hours per week. The attribution to obligee of a near minimum-wage hourly income over that eight-hour gap in her not-quite fulltime job was certainly a realistic figure given obligee's earnings history as a nurse and college level instructor.

Accordingly, I entered an order of support on November 30, 2010.


