#### Summary of Verdicts from the January/February 2012 Civil Jury Term

The Judges have completed the January/February 2012 civil jury term. Two civil cases reached verdict during the January/February civil term and the summary is as follows:

# PROGRESSIVE NATIONAL INSURANCE COMPANY v. TRICIA SATTAZAHN, ANDREA MURPHY, EUGENE KOZENSKIE AND STATE FARM INSURANCE COMPANY (2004 CV 5077)

This was a declaratory judgment action to determine whether or not the operator of a vehicle was a permissive user. A passenger was injured in this one vehicle accident. A group of friends were out drinking at a bar near the Penn National Racetrack in Grantville, PA. Defendant Murphy was the owner of the vehicle. Defendant Sattazahn was the driver and Defendant Kozenskie was the passenger who was injured. There is a separate tort action for the injuries sustained by Kozenskie. At some point, Murphy stayed in the bar while Defendant Sattazahn, Defendant Kozenskie and another took the car to get cigarettes and later cocaine. Defendant Murphy's automobile insurance carrier is State Farm. The language of the State Farm policy in question was "did Sattazahn use the vehicle within the scope of consent of Defendant Murphy."

#### Summary of Verdicts from the February/March 2012 Civil Jury Term

The Judges have completed the February/March 2012 civil jury term. Six civil cases reached verdict during- the February/March civil term and the summary is as follows:

# RONALD A. WIEST, ADMINISTRATOR OF THE ESTATE OF REGINA WIEST v. JOHN D. CONROY, JR., D.O. AND CENTRAL PA HEMATOLOGY AND MEDICAL ONCOLOGY ASSOCIATES (2003 CV 286)

This medical negligence claim arose due to the death of Regina M. Wiest on January 22, 2001. Ronald Wiest is the son of Regina Wiest and is the administrator of her estate. This action included a claim for wrongful death and a survivor's action for her suffering prior to her death. Plaintiff's experts contended that Plaintiff died because her visible signs and symptoms of diabetic imbalance and potential sepsis were not recognized by Dr. Conroy and were not treated and caused her death. Defendants argued that Dr. Conroy met the standard of care in his treatment of Mrs. Wiest and that she died as a result of Klebsiella sepsis due to immunosuppression after chemotherapy, a complication which the family had been counseled by Dr. Conroy.
