#### Des-Ogugua v. For Sale By Owner Real Estate, Inc., et al.

#### Practice — Terminated case — Notice — Petition to reopen — Activity of record.

Plaintiff appealed the denial of her petition to reopen a terminated case. She contended that her attorney had not received either the notice of proposed termination or the subsequent termination order, but she did not dispute that the notice and order were properly mailed, nor did she allege that they were sent to an incorrect address. Upon discovering that the matter had been terminated, she waited three additional months to petition for reinstatement.

1. It is well established that, under the "mailbox rule," proof that a letter was properly mailed raises a rebuttable presumption that the letter was received. *Donegal Mutual Insurance Company v. Insurance Department*, 719 A.2d 825, 827 (Pa.Commw.Ct. 1998). This presumption is not nullified solely by testimony denying receipt of the item mailed. *Breza v. Don Farr Moving & Storage Company*, 828 A.2d 1131 (Pa.Super. 2003).

2. Termination proceedings are proper in a case where there has been no activity *of record* for two years or more. Pa.R.Civ.P. 230.2(a) (emphasis added).

#### [PURSUANT TO Pa.R.A.P. 1925(a)]

Before the court are the matters complained of on appeal of plaintiff Brigid Des-Ogugua (hereinafter "plaintiff"). Plaintiff appeals our denial of her Petition to Reopen Terminated Case following a hearing on July 12, 2005.

A complaint was filed in this matter on October 27, 1999. On November 12, 1999, the defendants filed preliminary objections. The defendants filed an answer to the plaintiff's complaint on February 17, 2000. On February 22, 2000, the Honorable John F. Cherry of this court issued an order denying the defendants' preliminary objections.

On May 12, 2000, the defendants filed a motion for summary judgment. Attorney Albert J. Hajjar, Esquire, entered his appearance on behalf of the plaintiff on August 17, 2000. After a hearing on the matter, the Honorable Lawrence F. Clark, Jr. of this court denied the defendants' motion for summary judgment by Memorandum and Order filed January 18, 2001.

On August 9, 2001, Judge Clark, upon defendants' motion to compel the plaintiff to attend depositions, directed the plaintiff to show cause 14 (2006)]

why the defendants' motion should not be granted. The plaintiff responded to the rule on August 22, 2001. This filing is the last recorded docket entry in this matter before a notice of proposed termination of court case pursuant to Pa.R.Civ.P. 230.2 was entered on December 15, 2003. On December 16, 2003, the Prothonotary mailed a copy of this notice to plaintiff's counsel at 3003 North Front Street, Harrisburg, PA 17110, an address at which Mr. Hajjar regularly received, and continues to receive, his mail. Mr. Hajjar claims that he never received the notice.

On March 9, 2004, noting that the time for filing a statement of intention to proceed had expired and that the notice of proposed termination had not been returned as undeliverable, Judge Clark entered an order terminating the case with prejudice in accordance with Pa.R.Civ.P. 230.2. A copy of this termination order was mailed to plaintiff's counsel the following day at 3003 North Front Street. Mr. Hajjar claims that he never received a copy of the termination order.

On May 17, 2005, more than 14 months after the instant matter was terminated, the plaintiff filed her petition to reinstate the case. The defendants filed a response on June 2, 2005. Oral argument was held on July 12, 2005, at which time we issued an order denying plaintiff's motion.

On appeal, the plaintiff argues that we erred by failing to find that:

- (1) Plaintiff had not received notice that the case was scheduled for termination and, therefore, that plaintiff's petition to reopen should have been granted; and,
- (2) The case had been active during the two year period preceding termination and, therefore, that plaintiff's petition to reopen should have been granted.

Rule 230.2(d)(3) of the Pennsylvania Rules of Civil Procedure provides that, where a petition to reinstate a terminated case is filed more than thirty days after the entry of a termination order, a terminated case may be reinstated upon a showing that:

(i) the petition was timely filed following the entry of the order for termination and,

(ii) there is a reasonable explanation or a legitimate excuse for the failure to file both:

(A) the statement of intention to proceed prior to the entry of the order of termination on the docket and,

(B) the petition to reinstate the action within thirty days after the entry of the order of termination on the docket.

#### Pa.R.Civ.P. 230.2(d)(3).

Here, the plaintiff fails to make the required showing. First, the petition to reinstate the action was not promptly filed. Mr. Hajjar avers that he learned the case had been terminated when he inquired as to its status at the Office of Prothonotary on February 15, 2005. Nevertheless, it was not until May 4, 2005, when Mr. Hajjar consulted with Deborah Freeman, Esquire, Deputy Court Administrator, for advice on how to proceed in this matter, that the plaintiff took any sort of action toward reinstating the case. No explanation is given for this delay. Finally, on May 17, 2005, nearly fourteen months after the case was terminated, the plaintiff petitioned the court to reinstate the matter. We find such delay to be inexcusable.

Second, the plaintiff has offered no reasonable explanation for failing to object to the termination of the matter or for failing to file a timely petition to reinstate the action. The plaintiff claims that her failure to file was a consequence of having never received either the notice of termination or the subsequent termination order. However, the plaintiff does not dispute that the notice and order were properly mailed. Neither does she allege that the notice and order were sent to an incorrect address.

It is well established that, "[u]nder the 'mailbox rule,' proof that a letter was properly mailed raises a rebuttable presumption that the letter was received." *Donegal Mutual Insurance Company v. Insurance Department*, 719 A.2d 825, 827 (Pa. Commw. Ct. 1998); see also, Breza v. Don Farr Moving & Storage Company, 828 A.2d 1131 (Pa. Super. 2003); Pa.R.Civ.P. 440(b). This presumption is not nullified solely by testimony denying receipt of the item mailed. *Breza, supra; see also, Wheeler v. Red Rose Transit Authority*, 2006 Pa. Commw. LEXIS 27 (January 27, 2006). Thus, the plaintiff is not entitled to relief on this basis.

Finally, the plaintiff argues that we erred by dismissing her petition when, although not reflected on the docket, the case had been active in the two years prior to the entry of the termination. Specifically, the plaintiff avers that depositions were taken in April 2002 and that plaintiff's counsel apparently sought to locate an expert to review a document at some point in 2003. However, Rule 230.2 specifically states that termination proceedings are proper in a case where "there has been no activity *of record* for two years or more. . . ." Pa.R.Civ.P. 230.2(a) (emphasis added).

The last activity of record in this case prior to the entry of the notice of proposed termination was plaintiff's August 22, 2001 response to a rule to show cause why defendant's motion to compel the plaintiff to attend depositions should not be granted. Because the docket then remained inactive for more than two years, a notice of proposed termination was entered on December 15, 2003. The parties were duly notified of the proposed termination and no objection was filed. The action was ultimately terminated on March 9, 2004. Thus, the matter having been properly terminated under Rule 230.2, we find the plaintiff's second claim of error to be meritless.

In conclusion, we note that virtually all docket activity in this matter was initiated by the defendants or the court. Although not reflected on the docket, it appears that the only actions taken by the plaintiff in furtherance of her claim between August 21, 2001 (the last recorded docket activity before the entry of the notice of proposed termination) and February 15, 2005 (the date the plaintiff learned that the case had been terminated) were the taking of two depositions in April 2002 and consulting with an expert at some point in 2003. Further, defense counsel states that he last corresponded with Mr. Hajjar in July 2002. Had the plaintiff been at all diligent in the prosecution of her claim, she would not have neglected this matter for a period of years and, upon discovering that the matter had been terminated, waited three months to petition the court to reinstate the case. We conclude that the plaintiff is not entitled to reinstatement and that her claims of error are without merit.


