Practice — Sealing Records.

The Court declined a request to seal the pleadings, motions, and replies contained in a civil action which had been referred to a Receiver.

1. It is unconstitutional, absent an unmistaken authorizing statute or a clearly recognized common law prerogative of a trial court, to seal a public record related to official court filings or proceedings. *P.A. CONST. art. I, § 11.* There is a common law presumption of public access to judicial proceedings and records. *Zurich Am. Ins. Co. v. Rite Aid Corp., 345 F. Supp. 2d 497, 503 (D. Pa. 2004).* Furthermore, it is not a sufficient basis to seal a record just because the parties agree amongst themselves that it would be in their best interests to seal part or all of the record. Doing so would deprive the citizens of the Commonwealth of Pennsylvania of their fundamental constitutional right to access such information.

CLARK, J., April 19, 2011. – This writing is necessary to address the issue of sealing public judicial records. In the case at hand, the proceeding was referred to a Receiver. A Stipulation was then submitted by the parties, followed by the Plaintiff's Contested Motion to Seal All Pleadings, Motions, and Replies Contained on the Above Docket. We will accept the Stipulation but we will not grant the matter of sealing.

Our distinguished colleague, the Honorable Todd A. Hoover, now President Judge, had clearly articulated the Court's position on the issue of sealing records as it pertains to minors settlements in his thorough and thoughtful Opinion issued in the matter of *Executors v. Defendant, M.D.*¹ on January 30, 2002. We wholeheartedly concur with our distinguished colleague's Opinion in that matter and take this opportunity to clarify those matters of law pertaining to the sealing of public judicial records so as to hopefully avoid any confusion or misconstruction of such matter in the future.

It is unconstitutional, absent an unmistaken authorizing statute or a clearly recognized common law prerogative of a trial court, to seal a public record related to official court filings or proceedings. Article I, Section 11 of the Constitution of the Commonwealth of Pennsylvania states that, "All courts shall be open; and every man for an injury done him in his lands, goods, person or reputation shall have remedy by due course of law, and eight and justice administered without sale, denial or

delay." P.A. CONST. art. I, § 11. There is a common law presumption of public access to judicial proceedings and records. *Zurich Am. Ins. Co. v. Rite Aid Corp.*, 345 F. Supp. 2d 497, 503 (D. Pa. 2004) (*citing, In re: Cendant*, 260 F. 3d 183, 192 (3d Cir. 2001). The public's right of access to judicial records and proceedings is extremely broad, envisioning "a pervasive common law right 'to inspect and copy public records and documents, including judicial records and documents." *Id.* Obviously, in modern times there has been a grand impetus toward the accessibility of public information. Furthermore, it is not a sufficient basis to seal a record just because the parties agree amongst themselves that it would be in their best interests to seal part or all of the record. Doing so would deprive the citizens of the Commonwealth of Pennsylvania of their fundamental constitutional right to access such information.

In the past, the courts have summarily sealed records. It was unconstitutional then and it is unconstitutional today. Every judicial officer from the newest Magisterial District Judge to the Chief Justice of the Supreme Court takes the same oath of office before commencing their duties, which oath binds them to "support, obey and defend the Constitution of the United States and the Constitution of this Commonwealth and that I will discharge the duties of my office with fidelity." P.A. CONST. art. VI, § 3. There is no way that a judge, for even the most personally important reasons advanced by one or more of the litigants in a civil action, may deprive the other citizens of the Commonwealth of knowing what their courts are doing without openness, indeed transparency; since the alternative is an invitation to secrecy and, potentially, abuse that is manifest.

Therefore the provisions of Article I, Section 11 and Article VI, Section 3 of the Constitution of the Commonwealth of Pennsylvania must be read together when determining the issue at hand. Observing one without the other would be the antithesis of constitutional democracy. In the above docketed case, unfortunately, the parties, possibly improvidently, chose to publicly expose their personal activities to public scrutiny by embedding all manner of allegations and counter allegations concerning their private lives in their pleadings. That is unfortunate. However, it certainly now, after the fact of public exposure at their own hands, does not justify from a constitutional perspective the sealing of their records and we decline to do so.


