KEYSTONE HEARINGS AND APPEALS, LLC v. FEDERAL HEARINGS AND APPEALS SERVICES, INC. AND KEITH J. SAUNDERS (2013 CV 1703)

In June 2011, the PA Dept. of Public Welfare ("DPW") terminated a services contract it had with Keystone and replaced Keystone with Federal. Keystone alleged that Federal, and its principal Saunders, improperly interfered with Keystone's contractual relationship with DPW and defamed Keystone. Defendants deny any and all liability, alleging DPW approached Federal about replacing Keystone and denying any defamatory statements. Plaintiff filed suit against Defendants asserting a claim for Intentional Interference with a Contractual Relation and Defamation.

As he began standing from the crouched position, he slipped and his left, nondominant hand was drawn into the in-running nip point created between the in-feed drive cylinder roller and the idle cylinder roller. His hand was crushed. Plaintiff filed suit against Dauphin Graphic Machines asserting a claim for products liability based on negligence, strict liability and failure to warn.

KEITH WAGNER v. PENNSYLVANIA CAPITOL POLICE DEPARTMENT DEPARTMENT OF GENERAL SERVICES v. GREGORY GREEN. RICHARD SHAFFER AND ROBERT DILLARD (2009 CV 13930).

Plaintiff had been employed since 1988 with the Capitol Police when he developed a seizure disorder. This prevented Plaintiff from carrying a weapon, driving or directing traffic per order of his neurologist. Plaintiff was off work during September and October 2005 and although he received permission from his doctor to return to work on light duty, Defendants did not accommodate him with a desk job until January 2006.

MARILYN E. TAYLOR AND GREGORY L. TAYLOR, HUSBAND AND WIFE v. JOANNA M. DELEO, D.O. (2009 CV 5258).

Plaintiff Marilyn Taylor alleged that the defendant doctor was negligent in performing numerous laparoscopies upon her in 2007 and 2008. Plaintiff asserted that while the purpose of the surgeries was to address chronic abdominal pain and remove adhesions, the surgeries in fact lead to more adhesions. Plaintiff later required thirteen additional surgical procedures following the last laparoscopy in May 2008, during which defendant allegedly caused a life-threatening bowel perforation. Plaintiff asserted that it was below the standard of care to repeatedly use laparoscopies to remove adhesions and treat pain. Defendant doctor denied that the decision to perform repeated laparoscopies was negligent; defendant also denied she caused the bowel perforation during the last laparoscopy. The jury found that the defendant had not violated the standard of care. This was a re-trial of a case first tried in 2011 to a defense verdict. The verdict was reversed on appeal and a new trial ordered.

On February 12, 2013, Plaintiff Jennifer Hernandez-Lerch was injured in a rear end motor vehicle collision on Interstate 83. Plaintiff was a front seat passenger in a 2012 Toyota Corolla which was operated by Iris Rivera Merced. Defendant Earl Oberholtzer was operating a 2010 Ford F150 pickup truck while in the course and scope of his employment with Defendant Cardinal Health 414. Defendant Gray was operating a 2010 Toyota Corolla. Defendant Gray struck the back of Defendant Oberholtzer's car and Defendant Oberholtzer struck the back of the car in which Plaintiff was riding. The car in which Plaintiff was riding was then pushed into the back of a FedEx truck Plaintiff alleged that she sustained chronic cervical and lumbar strain and has developed cervical radiculopathy. She also alleged that she suffers from chronic headaches and that her injuries have adversely affected her ability to perform her employment.

RONIT CHAUDHURI v. CAPITAL AREA TRANSIT, CUMBERLAND-DAUPHIN-HARRISBURG TRANSIT AUTHORITY AND MARIA MATIAS (2011 CV 6795)

On August 19, 2010, Plaintiff was struck in the face by the rear view mirror of an approaching bus. At the time Plaintiff had just exited a different bus and was preparing to cross the street behind the bus and not within a crosswalk. Injuries included facial injuries and injuries to his left hand and wrist which occurred when he fell unconscious following the collision.
