#### **Commonwealth v. Garner**

### Crimes and Criminal Procedure — Official Oppression — Impersonating a Public Servant — Weight of the Evidence.

Appellant, an elected Constable, subjected several young women, on two separate occasions, to investigative detentions. In each instance he would follow the victim in his private vehicle, pull behind their vehicle, blocking departure, and direct them to produce a driver's license, vehicle registration, and vehicle insurance documentation. Appellant never identified himself as a mere Constable, and left the victims on both occasions with the impression that he was a police officer.

1. A verdict is against the weight of the evidence only when the jury's verdict is so contrary to the evidence as to shock one's sense of justice. *Commonwealth v. VanDiver*, 962 A.2d 1170, 1177 (Pa. 2009).

2. It is the province of the jury to assess the credibility of witnesses, and an appellant will not succeed in a claim that the verdict is against the weight of the evidence merely because of a conflict in the testimony or because a trial judge could have reached a different conclusion on the same facts if he had been the trier of fact. *Commonwealth v. Blakeney*, 946 A.2d 645, 652-53 (Pa. 2008).

3. To be guilty of impersonating a public servant, a person must falsely pretend to hold a position in the public service with intent to induce another to submit to such pretended

official authority or otherwise to act in reliance upon that pretense to his prejudice. *18 Pa. C.S.A. § 4912.* 

4. To be found guilty of official oppression, a person acting or purporting to act in an official capacity or taking advantage of such actual or purported capacity, commits a misdemeanor of the second degree if, knowing that his conduct is illegal, he:

- subjects another to arrest, detention, search, seizure, mistreatment, dispossession, assessment, lien, or other infringement of personal or property rights; or
- (2) denies or impedes another in the exercise or enjoyment of any right, privilege, power or immunity.

CLARK, J., October 21, 2011. - [Pursuant to Pa. R.A.P. 1925(a)]

Before the Court is the Appellant's Statement of Matters Complained of on Appeal (hereinafter "Statement"). The Appellant has raised but one issue on appeal, to wit, that "the convictions of official oppression and impersonating a public servant are so contrary to the evidence as to shock one's sense of justice." After a full review of the Court's file, the transcript and the post-trial proceedings, this Court determines that the Appellant's claim is meritless, and should be dismissed.

On April 11, 2011, the Appellant appeared before this Court for a three day jury trial and was ultimately found guilty by that jury of the charges of official oppression and impersonating a public servant. Subsequent to the Appellant's conviction, this Court ordered a comprehensive Pre-Sentence Investigation Report (PSI) to be prepared by the Dauphin County Adult Probation and Parole Department. Upon receipt of that comprehensive PSI report, the Court reviewed the report (indeed, we read it several times) and directed counsel to likewise review the report prior to sentencing. On July 29, 2011, the Appellant, who had been represented by experienced, private counsel, Bryan S. Walk, Esquire, throughout all of the pre-trial, trial and sentencing proceedings, was sentenced to an aggregate sentence of four (4) to twenty-four (24) months of Intermediate Punishment, with the first four (4) months in restrictive confinement in the Dauphin County Work Release Center, followed by eight (8) years of probation, plus fines and costs. Those sentences were well within the parameters of

the sentencing guidelines and no exception based on those sentences has been asserted on appeal. Therefore, the Appellant's sentences are not at issue in this matter.

The Appellant's resignation as an elected Constable for South Hanover Township, Dauphin County, was accepted on the record at the June 29, 2011 sentencing proceeding and the Appellant was likewise cautioned that he is not to hold future public office. (N.T. p. 51). On July 6, 2011, the Appellant, then being represented by the Dauphin County Public Defender's Office, filed a Post-Sentence Motion for a New Trial. the basis of which was the assertion that the jury's verdict was against the weight of the evidence. This Court denied that Motion on July 11, 2011. On August 5, 2011, the Appellant filed his Notice of Appeal with the Superior Court of Pennsylvania from the denial of his Motion for a New Trial by this Court. The Appellant then filed his Statement of Matters Complained of Upon Appeal (Statement) on September 14, 2011, but did not favor this Court with any writing to illuminate the basis of that stated issue asserted within the Statement (although he was certainly not obligated to do so). Thereafter, on October 20, 2011, the Commonwealth filed a Response to the Appellant's Statement, which Response included a comprehensive discussion of the facts of the case, the statutes of the Commonwealth pertaining to the charges for which the Appellant stands convicted, the salient case law pertaining to powers and duties of constables, and more importantly, the limitations on those constable powers. Commonwealth v. Roose, 710 A.2d 1129 (Pa. 1998).

#### FACTUAL BACKGROUND

On May 18, 2010, the Appellant, who was age 54 at that time, pulled his private vehicle (which he used for constable duties) into a residential driveway located at 1175 Willoughby Road in Lower Paxton Township, Dauphin County, Pennsylvania, behind a vehicle driven by Ms. Andrea Sherman, age 17. The alleged basis for the Appellant's actions as asserted by Appellant's counsel, but never testified to by the Appellant himself, was to question the attractive, minor female driver (Ms. Sherman) about her asserted driving actions, whereby she is alleged to have cut off another vehicle while she was driving to her home. The Appellant, who was not in any type of uniform but briefly flashed his constable's badge, directed Ms. Sherman to produce her driver's license, vehicle *registration*, and vehicle *insurance documentation*. The Appellant then took the documents to his vehicle for several seconds. The Appellant returned Ms. Sherman's documents to her and got back in his vehicle and left the driveway just as Ms. Sherman's sister was being

dropped off at the end of the driveway, and she (sister) could have viewed and witnessed any further encounter between the Appellant and Ms. Sherman. When asked at trial by the prosecution whom she thought she was dealing with after the Appellant flashed his badge, Ms. Sherman answered, "I thought I was dealing with a police officer." (N.T. p. 46). At no time during this encounter with Ms. Sherman, did the Appellant ever indicate that he was only a constable. Nor did the Appellant indicate to Ms. Sherman that she was not required to comply with his commands to produce the documents, or that she was free to leave the encounter and enter her home, or that she was entitled to the presence of a parent, inasmuch as she was a minor.

Then, just two days later, the Appellant pulled his same private vehicle which he utilized for constable duties, in behind a vehicle containing three attractive, young female occupants, and driven by Lauren Christen, age 21, at the Empire Beauty School, located at 3941 Jonestown Road in Harrisburg, Pennsylvania. The positioning of the Appellant's vehicle behind Ms. Christen's vehicle was done in a fashion which prevented Ms. Christen's vehicle from being able to leave the ensuing encounter. Indeed, in this encounter as well as the prior encounter with Ms. Sherman, there is no doubt that the vehicles and their occupants were seized by the deliberate actions of the Appellant with regard to the positioning of his (Appellant's) vehicle. Again, the Appellant was not in any kind of a uniform and only briefly flashed his constable's badge to Ms. Christen. Ms. Christen specifically testified at trial that the Appellant identified himself as "Officer ... " (N.T. p. 82). According to Ms. Christen's testimony, the Appellant stated to Ms. Christen that he was following her car when he saw two females passengers flick their cigarettes out the window. He informed her that this was littering and asked Ms. Christen for her driver's license and vehicle registration. After taking her documentation to his vehicle for approximately three (3) minutes, the Appellant returned the documents to Ms. Christen and told her that he could not issue her a warning because he was "off duty." (N.T. p. 87).

Ms. Christen also testified at trial that she did not feel free to go, as the Appellant instructed her to "stay by the car" when he took her documentation to his vehicle. (N. T. p. 85). When asked at trial whether she believed the Appellant was a police officer because he showed her a badge, Ms. Christen responded in the affirmative. (N. T. p. 94). She also stated that she was sure that he never addressed himself as a constable. (N.T. p. 108). At trial, Jessica Bender, who was a passenger in the vehicle driven by Ms. Christen, testified that the Appellant asked

her for her name, address, and date of birth. Ms. Bender also stated that the Appellant addressed himself as "Officer ..." (N.T. p. 113). Similar to Ms. Christen, Ms. Bender did not feel free to leave after the Appellant pulled his vehicle in behind Ms. Christen's vehicle. (N.T. p. 114). The individual and collective testimony of Ms. Sherman, Ms. Christen, and Ms. Bender was unrebutted at trial, and this Court found their testimony to be extremely credible. Obviously, the jury likewise found the testimony of the three young women to be credible, as evidenced by the jury's verdict.

#### ISSUE

The Appellant raises the following single issue in his Statement:

"The convictions of official oppression and impersonating a public servant are so contrary to the evidence as to shock one's sense of justice."

Although the Appellant did not use the exact same language to articulate his issue on appeal as he did in his post-trial Motion for a new trial, the essence of his appeal issue is the same, namely, a challenge to the weight of the evidence, as will be discussed *infra*, and thereby concedes that sufficient evidence existed to meet the elements of the crimes of which the Appellant stands convicted. We will therefore proceed with our discussion concerning the weight of the evidence claim.

#### DISCUSSION

The law of our Commonwealth pertaining to an assertion that the jury's verdict was against the weight of the evidence has been succinctly set forth by our Supreme Court as follows:

"A motion for a new trial on the grounds that the verdict is contrary to the weight of the evidence, concedes that there is sufficient evidence to sustain the verdict. Thus, the trial court is under no obligation to review the evidence in the light most favorable to the verdict winner. An allegation that the verdict is against the weight of the evidence is addressed to the discretion of the court. A new trial should not be granted because of a mere conflict in the testimony or because the judge on the same facts would have arrived at a different conclusion. A trial judge must do more than reassess the credibility of the witnesses and allege that he would not have assented to the verdict if he were a juror. Trial judges, in reviewing a claim that the verdict is against the weight of

the evidence, do not sit as the thirteenth juror. Rather, the role of the trial judge is to determine that 'notwithstanding all the facts, certain facts are so clearly of greater weight that to ignore them or to give them equal weight with all the facts is to deny justice.'"

Commonwealth v. Widmer, 744 A.2d 745, 751 (Pa. 2000) (emphasis added) (internal citations omitted). The verdict returned in this case was a just one and should not be disturbed. Furthermore, a verdict is against the weight of the evidence "only when the jury's verdict is so contrary to the evidence as to shock one's sense of justice." Commonwealth v. VanDiver, 962 A.2d 1170, 1177 (Pa. 2009) citing, Commonwealth v. Cousar, 928 A. 2d 1025, 1036 (Pa. 2007) (emphasis added). It is specifically noted that the verbiage utilized by the Appellant to frame his issue on appeal is contained within the above cited cases. It is the province of the jury to assess the credibility of witnesses, and an appellant will not succeed in a claim that the verdict is against the weight of the evidence merely because of a conflict in the testimony or because a trial judge could have reached a different conclusion on the same facts, if he had been the trier of fact. Commonwealth v. Blakeney, 946 A.2d 645, 652-53 (Pa. 2008) citing, Commonwealth v. Edwards, 903 A.2d 1139, 1148 (Pa. 2006) and Armbruster v. Horowitz, 813 A.2d 698, 703 (Pa. 2002). The finder of fact is free to believe all, part or none of the evidence and to determine the credibility of the witnesses. Commonwealth v. Hawkins, 701 A.2d 492, 501 (Pa. 1997). As stated above, the jury is the finder of fact. The jury had a full opportunity to weigh the evidence and consequently found the Appellant guilty.

In the Appellant's case, he was convicted of the crimes of impersonating a public servant and official oppression. To be found guilty of impersonating a public servant, "A person must falsely pretend to hold a position in the public service with intent to induce another to submit to such pretended official authority or otherwise to act in reliance upon that pretense to his prejudice." 18 Pa. C.S.A. §4912. The evidence at trial clearly portrayed the Appellant as impersonating a public servant, to wit, a "police officer," as his actions amounted to conducting an investigatory detention, based on asserted violations of Pennsylvania's Motor Vehicle Code, by Andrea Sherman, Lauren Christen, and Jessica Bender, none of which he was authorized to do as a constable under Title 44, Chapter 71 of Purdon's Pennsylvania Statutes and Consolidated Statutes.

To be found guilty of official oppression, "A person acting or purporting to act in an official capacity or taking advantage of such actual

or purported capacity commits a misdemeanor of the second degree if, knowing that his conduct is illegal, he:

- subjects another to arrest, detention, search, seizure mistreatment, dispossession, assessment, lien, or other infringement of personal or property rights; or
- (2) denies or impedes another in the exercise of enjoyment of any right, privilege, power or immunity."

18 Pa. C.S.A. §5301.

The Appellant clearly intended to act in an official capacity when he subjected Andrea Sherman, Lauren Christen, and Jessica Bender to investigative detentions, even though this was not an official function he was authorized to perform under Title 44, Chapter 71 of Purdon's Pennsylvania Statutes and Consolidated Statutes. Even more compelling evidence of his intent is the mere fact that he never identified himself as a constable, but instead he introduced himself as "Officer ... " Despite Appellant's claim at trial, as asserted by Appellant's counsel but not through any testimony offered by any witnesses called to testify on behalf of the Appellant, that he did not intend to break the law, the Appellant's counsel - asserted ignorance of the well known limitations on his powers as a constable is not a defense.

Additionally, as the Commonwealth clearly pointed out to the jury during closing arguments, there was blatant evidence, indeed a "smoking gun," in the consistent conduct of the Appellant, wherein he requested both Ms. Sherman and Ms. Christen to provide him (Appellant) with not only their driver's license, but also their vehicle registration, and in the case of Ms. Sherman, her proof of vehicle insurance documentation as well. Those demands for the production of vehicle related documents could only be for the purpose of enforcing the vehicle licensing and insurance requirements of the Motor Vehicle Code, a body of Pennsylvania law which Constable Garner was expressly prohibited from enforcing in any manner whatsoever! See *Roose*. The jury was certainly entitled to reasonably infer the Appellant's true intent and motivations from such demonstrable conduct, and that is what the jury did.

THEREFORE, we find the Appellant's claim to be meritless, and recommend that his Appeal should be DISMISSED.



The duties of a magistrate judge in this court include the following: (1) To exercise all the powers and duties conferred or imposed upon United States Magistrate Judges by law or the Federal Rules of Criminal Procedure or the Federal Rules of Civil Procedure; (2) To administer oaths and affirmations, impose conditions of release under 18 U.S.C. §3146, and take acknowledgments, affidavits, and depositions; (3) To try persons accused of misdemeanors committed within this district in accordance with 18 U.S.C. §3401, order presentence investigation reports and sentence such persons; (4) To conduct proceedings in accordance with Fed.R.Cr.P. 40; (5) To conduct extradition proceedings, in accordance with 18 U.S.C. §3184; (6) To appoint attorneys under the court's Criminal Justice Act Plan; (7) To review applications by prisoners for post-trial and other relief, make such orders as are necessary to obtain appropriate information which may be of assistance in determining the merits of any complaint, submit reports and recommendations to the district judge having jurisdiction over the case; (8) To act as a special master when designated by the district court; (9) To receive indictments returned by grand juries; (10) To conduct arraignments to the extent of taking a not guilty plea or noting a defendant's intention to plead guilty or nolo contendere; and (11) Conduct trials and the disposition of civil cases on consent of the parties.
