#### Summary of Verdicts from the June 2013 Civil Jury Term

The Judges have completed the JUNE 2013 civil jury term. Three civil cases reached verdict during the June civil term and the summary is as follows:

# MARTIN ROTHSTEIN AND BETH L. ROTHSTEIN V. STERL RICHARD SIMMONS (2010 CV 2403)

This was an action for damages sustained as a result of intentional torts. Defendant followed Martin Rothstein into a parking lot, blocked his vehicle and demanded that Mr. Rothstein exit the car. Mr. Rothstein refused so Defendant dragged him from the car and punched and kicked Mr. Rothstein. Mr. Rothstein sustained a fractured leg. Plaintiff filed suit alleging assault, battery, intentional infliction of emotional distress and false imprisonment. Mrs. Rothstein brought a loss of consortium claim. The parties stipulated to dismiss the intentional infliction of emotional distress and the false imprisonment claims. Defendant denied any tortious action or assault.


