The Judges have completed the FEBRUARY 11, 2019 civil jury term. One civil case reached verdict and the summary is as follows:

MAUDRIE WHYTE-ELLIS and KENEISHA GRANT v. PAMELA PEARSON (2017 CV 03684)

Trial dates: February 11, 2019-February 13, 2019

Trial Summary:

On July 28, 2015, the vehicle driven by Defendant came in contact with the vehicle driven by Plaintiff. Defendant's vehicle exhibited no property damage and the rear bumper cover of Plaintiff's vehicle was cracked. Plaintiff claimed that as a result of the impact she suffered an exacerbation of chronic low back pain as well as post-traumatic stress disorder. Plaintiff asserted that in addition to non-economic damages she has suffered disfigurement in the form of guarded and abnormal gait. She also claimed that she has suffered a loss of earnings and capacity. Plaintiff is a registered nurse.

Plaintiff presented the testimony of treating physicians who had been actively treating her pre-existing chronic pain; some of whom claimed she had regained her baseline of chronic pain following a 2009 MVA and suffered an exacerbation of these conditions as a result of the 2015 collision. Plaintiff further treated with a therapist for anxiety who testified that Plaintiff suffered from PTSD as a result of the collision. A vocational expert retained to assess her economic loss presented evidence of her loss of earnings and reduced earning capacity based on tax returns pre and post MVA, some medical records which included weight lifting restrictions and Plaintiff's self-reported history.

Defendant admitted fault for the collision but disputed the nature and extent of Plaintiff's injuries and economic loss as a result of the minor impact. Defendant pointed to Plaintiff's extensive history of low back pain following the vehicle accident in 2009 and medical records of active treatment since, and immediately preceding the 2015 collision as demonstrating that Plaintiff experienced no exacerbation of her pre-existing conditions. Defendant further presented evidence that Plaintiff's loss of earnings was due, in part, to poor work performance prior to and unrelated to any injury she may have experienced as a result of this collision for which she was warned and ultimately terminated. On cross examination of Plaintiff's vocational expert, defense counsel revealed that the vocational expert did not consider Plaintiff's employment records or the history of her limitations prior to the 2015 collision. Defendant presented testimony of an orthopedic surgeon who had examined Plaintiff along with her history. Defendant's expert opined that Plaintiff did not experience an exacerbation of her pre-existing conditions.
