AND NOW, this 15th day of March, 2017, upon consideration of Defendants' Motion to Strike and for Injunctive Relief, the Contested Motion of Defendants to Dismiss Frivolous Pro Se Litigation, For an Injunction and Sanctions, and after conducting a hearing on November 30, 2016, it is hereby ORDERED as follows:

Commonwealth v. New Vision Management, LLC
Practice and Procedure - Jurisdiction - Summary Appeal

A Magisterial District Judge found the Defendant property owner guilty of violating City Code provisions regarding the maintenance of two properties leased by the Defendant to taxicab companies. The Defendant appealed the findings of guilt but then challenged the Court's jurisdiction, arguing that since the taxicab companies were public utilities, jurisdiction of the summary appeal was exclusively within the purview of the Pennsylvania Public Utilities Commission (PUC). The Court characterized Defendant's position as misplaced.

1. It is a longstanding principle that the courts will not originally adjudicate matters within the jurisdiction of the PUC and that initial jurisdiction in matters concerning the relationship between public utilities and the public is in the PUC - not the courts. See *DiSanto v. Dauphin Consol. Water Supply*, 436 A.2d 197, 199 (Pa. Super. Ct. 1981).
2. Leasing real properties to public utilities does not exempt the properties from local regulation, nor convert them into the primary purview of the PUC for the purposes of summary appellate jurisdiction.

COURT ORDER & MEMORANDUM

AND NOW, to wit, this 17th day of March, 2017, upon consideration of Defendant New Vision Management, LLC's (hereinafter "Defendant") challenge to the jurisdiction of this Court to be able to entertain the above-captioned matters on appeal, and the Commonwealth's response thereto (submitted by and through the Solicitor of the City of Harrisburg), we find meritless the Defendant's contention that the Pennsylvania Public Utilities Commission ("PUC"), rather than this Court, should entertain this appeal. As such, **IT IS HEREBY ORDERED AND DECREED** that a Summary Appeal Hearing in this matter is hereby scheduled for the **17th day of April, 2017**, at 9:00 AM, in Courtroom No. 8 of the Dauphin County Courthouse.

The Defendant is the undisputed owner of the two properties which are at issue in this case, namely: 515 South 13th Street, Harrisburg; and 1119 Cumberland Street, City of Harrisburg, Dauphin County, Pennsylvania (hereinafter "the subject properties"). Defendant leases both of these properties to taxi-cab companies, and the taxi-cab companies utilize these premises for storage of parts and vehicles, both operable and inoperable. With respect to the subject properties, on November 15, 2016, Magisterial District Judge Rebecca J. Margerum ("MDJ Margerum") found New Vision guilty of violating Sections 302.8¹ and 301.3² of the International Property Maintenance Code, as incorporated into the City's Property Maintenance Code (Chapter 8-107 of the City Code), and sentenced New Vision to pay fines and costs. New Vision then appealed both of MDJ Margerum's findings of guilt to this Court. A Summary Appeal Hearing before this Court was scheduled for January 23, 2017. At that Hearing, however, Defendant, through counsel, challenged this Court's jurisdiction to hear such matters, and upon such challenge we ordered that both parties file Briefs regarding this issue. We have reviewed those submitted Briefs, and we now conclude that we have primary jurisdiction over this matter.

In essence, Defendant argues that because it leases the subject properties to taxi-cab companies, which are public utilities, the subject properties are somehow transformed into properties which are exempt from local regulations such as the City's Property Maintenance Code, and said real properties are then somehow magically converted into the exclusive purview of the PUC rather than this Court for the purposes of summary appellate jurisdiction. We strongly disagree. While we acknowledge that it is a

¹ Section 302.8 of the International Property Maintenance Code (hereinafter "IPMC") provides as follows:

Except as provided for in other regulations, no inoperative, unlicensed, or uninspected motor vehicle may be parked, kept or stored on any premises; and no vehicle shall at any time be in a state of major disassembly, disrepair, or in the process of being stripped or dismantled; and no vehicle may be parked on areas of a premises unapproved for parking. Painting of vehicles is prohibited unless conducted inside an approved spray booth. Exception: a vehicle of any type is permitted to undergo major overhaul, including body work, provided that such work is performed inside a structure or similarly enclosed area designed and approved for such purpose.

² Section 301.3 of the IPMC states that "[a]ll vacant structures and premises thereof or vacant land shall be maintained in a clean, safe, secure and sanitary condition as provided herein so as not to cause a blighting problem or adversely affect the public health or safety."

longstanding “principle ‘that the courts will not originally adjudicate matters within the jurisdiction of the PUC’” and that “initial jurisdiction in matters concerning the relationship between public utilities and the public is in the PUC - not the courts” See *DiSanto v. Dauphin Consol. Water Supply*, 436 A.2d 197, 199 (Pa. Super. Ct. 1981) (quoting *Lansdale Borough v. Phila. Elec. Co.*, 170 A.2d 565, 567 (Pa. 1961)), any such deferral to the PUC’s adjudicatory function is wholly inappropriate in this case. In the instant matter, there is no dispute concerning the relationship between a public utility and the public. This is so simply because **the Defendant is not a public utility**. As the Commonwealth aptly points out in its (City’s) Brief, the Defendant admits in its own Brief that it is a limited liability company in the business of real estate management and development and that it is the owner of the two properties at issue in this matter, to wit, 515 South 13th Street, Harrisburg; and 1119 Cumberland Street, and that both locations are within the boundaries of the City of Harrisburg and Dauphin County, Pennsylvania. Furthermore, Defendant acknowledges that it is not a taxi-cab company, nor is it a common carrier providing services that are regulated by the PUC. Thus, Defendant is merely an owner of private property that would not normally be subject to PUC regulation, and the mere fact that it elected to lease its own private property to taxi-cab companies to be used for storage, repairs and related activities does not place said property within the primary purview of the PUC. The Defendant’s attempt to bootstrap itself into a protected class of PUC covered activity by means of its leases to taxi-cab companies is without foundation and misplaced. As such, we find that this Court has primary jurisdiction over the above-captioned matter.

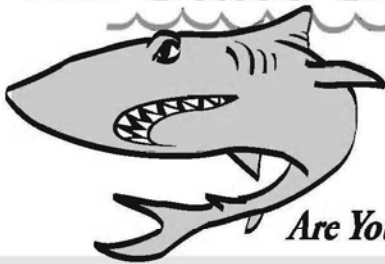
