The Judges have completed the **MARCH 2016** civil jury term. One civil case reached verdict during the March civil term and the summary is as follows:

**JOAN MAGUIRE and THOMAS J. MAGUIRE, III, wife and husband v. PEERLESS INSURANCE COMPANY and JARRAD STRAUSBAUGH (2014 CV 01036)**

This case arose from a motor vehicle accident on June 22, 2012. Plaintiff Joan Maguire was on the exit ramp from Route 283 in Middletown operating her Smart Car. Defendant Jarrad Strausbaugh was following the Maguire vehicle in his automobile in the line of traffic exiting the highway. As the traffic on the ramp moved, Maguire's vehicle approached the stop sign at North Union Street and stopped. Strausbaugh's vehicle struck the Maguire vehicle from behind. Defendant acknowledged his fault/liability in his pre-trial statement and from the witness stand. After four days of jury trial, the jury returned a verdict in favor of the Defendant by finding that the defendant's conduct was not a factual cause of harm to the Plaintiff.
