Mother's direct testimony. (N.T. 31-37, 42-47) After the offer, Mother agreed that would be her testimony, following which Father was given the opportunity to cross examine her. (N.T. 47-56) During the course of the examination, I twice explained the nature of the offer of proof to Father, who did not object on the record to this procedure either time. (N.T. 37, 47) Father claims he raised an objection but I am unable to find any on the record to the offer of proof procedure. Even if raised, however, Father provided no argument as to how he was prejudiced by this procedure.

Father's eighth and final complaint is that this court is prejudiced against him and his children and biased in favor of Mother wherein it has treated her repeated violations of court orders "with impunity," forcing Father to file a motion to recuse, which the court wrongly denied without a hearing. Father seeks that not only the current order be reviewed, but every order I ever issued in this action, in light of this alleged bias. The record does not show Father filed a motion seeking my recusal from this case. This was possibly an oversight by Father who has previously unsuccessfully sought the recusal of Judge Dowling in the PFA action and of Judge Lewis earlier in this custody action. In any event, his claim lacks any merit and is additionally not properly addressed on direct appeal.

Accordingly, I issued a my Order March 28, 2018 in this custody action.

**Hoffman v. Dept. of Transp., Bureau of Driver Licensing**

**Motor Vehicles - Driver License Suspension - Driving Under the Influence of Alcohol - Reasonable Grounds Standard - Refusal to Submit to Chemical Testing**

Appellee successfully appealed the suspension of his driver's license, which was rescinded by the trial court. The Appellant (PennDOT) then appealed the rescission to the Commonwealth Court, which affirmed the trial court order.

1. Section 1547 of the Pennsylvania Motor Vehicle Code, commonly referred to as the "Implied Consent Law," authorizes suspension of the driving privileges of a licensee for a period of twelve (12) months when the licensee is arrested for driving under the influence and the licensee refuses a police officer's request to submit to chemical testing. *75 Pa.C.S.A. § 1547(b)(1)(i)*.

2. To uphold the suspension of an individual's driver's license for refusal to submit to chemical testing, PennDOT must prove that the licensee: (1) was arrested for a violation of 75 Pa.C.S.A. § 3802 (relating to driving under the influence of alcohol or controlled substance) by a police officer who had reasonable grounds to believe that he was operating or was in actual physical control of the movement of the vehicle while under the influence; (2) was asked to submit to a chemical test; (3) refused to do so; and (4) was specifically warned that a refusal would result in the suspension of his operating or driving privilege. *Banner v. Dept. of Transp., Bureau of Driver Licensing*, 737 A.2d 1203, 1206 (Pa. 1999).

**OPINION**  
**[Pursuant to Pa.R.A.P. 1925(a)]**

The Commonwealth of Pennsylvania, Department of Transportation, Bureau of Driver Licensing (hereinafter “PennDOT” or “Appellant”), has filed an appeal in the above-captioned matter seeking reversal of our January 10, 2018 Order sustaining the statutory appeal of Eric Hoffman (hereinafter “Mr. Hoffman” or “Appellee”) and rescinding the suspension of his driver’s license.

**I. Background.**

The facts giving rise to this appeal are undisputed. On or about October 5, 2017, Susquehanna Township Police Officer Alex Wolf (hereinafter “Officer Wolf” or “the Officer”) was on routine patrol conducting standard business checks within his patrol area. (Notes of Testimony, 1/10/18 (“N.T.”) at 5). Officer Wolf normally conducts business checks between 1:00 A.M. and 5:00 A.M. (N.T. at 8). In conducting standard business checks, Officer Wolf has become familiar with what is considered “normal” within his patrol area. As it relates to the case at hand, one of the businesses within Officer Wolf’s patrol zone is the Boost Mobile on Walnut Street. (N.T. at 5). Officer Wolf stated that there is typically one (1) car parked in the Boost Mobile parking lot every night. (Id.) He went by at the beginning of the shift and noticed nothing unusual. (N.T. at 8). When he drove by toward the end of his shift, he noticed a second car, a minivan, parked in the Boost Mobile parking lot which raised his suspicions. (N.T. at 5).

When Officer Wolf pulled into the parking lot he noticed that the back sliding door of the minivan was wide open. (N.T. at 5-6). He got out of his vehicle and approached the minivan where he observed an Amstel light bottle in a cup holder in the back of the vehicle. (N.T. at 6). The driver, subsequently identified as Mr. Hoffman, was asleep in the driver’s seat with the keys to the vehicle in his hand, and an open Budweiser can in the driver’s side compartment. (Id.) Officer Wolf proceeded to bang on the window to wake Mr. Hoffman. (N.T. at 6-7). Initially, Mr. Hoffman yelled profanities, but once he opened his eyes and realized a police officer was there he became cordial. (N.T. at 7). Mr. Hoffman advised that he had been drinking with friends in Baltimore earlier that night, but denied driving the vehicle. (Id.)

Based upon the vehicle being parked sideways, the smell of alcohol on Mr. Hoffman, the open containers in the vehicle, Mr. Hoffman’s bloodshot eyes, and the oddity of the vehicle being there at that time of the night, Officer Wolf concluded that Mr. Hoffman drove the vehicle to that location shortly before he arrived. (Id.) He subsequently placed Mr. Hoffman under arrest, transported him to central

booking, and read him the DL-26 form. (N.T. at 8). When asked to give consent to a blood draw, Mr. Hoffman stated that he was not denying that he was drunk, but was denying that he drove. (N.T. at 8-9). When asked again to provide consent, Mr. Hoffman stated that a blood draw was unnecessary. (N.T. at 9).

On or about October 17, 2017, PennDOT sent a letter to Appellee, notifying him that because his refusal to submit to blood testing violated provisions of the Implied Consent Law as contained in the Pennsylvania Motor Vehicle Code, 75 Pa.C.S.A. § 1547, his driving privileges would be subjected to a twelve (12) month suspension effective November 21, 2017. On October 27, 2017, Appellee filed in this Court a *pro se* appeal of his suspension. The parties, each represented by counsel, appeared before the undersigned for a license suspension hearing on January 10, 2018. We find that Officer Wolf lacked the requisite reasonable basis to place Mr. Hoffman under arrest as he failed to show Mr. Hoffman had operative control of the motor vehicle.

## II. Discussion.

Section 1547 of the Pennsylvania Motor Vehicle Code, commonly referred to as the “Implied Consent Law”, authorizes suspension of the driving privileges of a licensee for a period of twelve (12) months when the licensee is arrested for driving under the influence and the licensee refuses a police officer’s request to submit to chemical testing. 75 Pa.C.S.A. § 1547(b)(1)(i). To uphold the suspension of an individual’s driver’s license for refusal to submit to chemical testing, PennDOT must prove that the licensee: (1) was arrested for a violation of 75 Pa.C.S.A § 3802 (relating to driving under the influence of alcohol or controlled substance) by a police officer who had *reasonable grounds* to believe that he was operating or was *in actual physical control* of the movement of the vehicle while under the influence; (2) was asked to submit to a chemical test; (3) refused to do so; and (4) was specifically warned that a refusal would result in the suspension of his operating or driving privilege. Banner v. Dept. of Transp., Bureau of Driver Licensing, 737 A.2d 1203, 1206 (Pa. 1999) (emphasis added).

Appellant is challenging this Court’s determination that Officer Wolf lacked reasonable grounds to believe that Mr. Hoffman was in actual physical control of the movement of the vehicle while under the influence of alcohol. “Reasonable grounds exist when a person in the position of the police officer, viewing the facts and circumstances as they appeared at the time, could have concluded that the motorist was operating the vehicle while under the influence of intoxicating liquor.” Id. at 1207. In determining ‘actual physical control’, the Court must consider the totality of the circumstances, including the location of the vehicle, whether the engine was running and whether there was other evidence

indicating that the motorist had driven the vehicle at some point prior to the arrival of the police. Id. At a minimum, there must be some objective evidence that the motorist exercised control over the movement of the vehicle at the time he was intoxicated. Id. Whether reasonable grounds exist is a question of law that must be determined by the court on a case-by-case basis. Id.

In the instant case, PennDOT failed to introduce any objective evidence that Mr. Hoffman exercised control over the movement of the vehicle at the time he was intoxicated. Specifically, this Court finds that Officer Wolf's belief that Mr. Hoffman was driving a motor vehicle while under the influence of alcohol was not reasonable under the totality of the circumstances. Officer Wolf jumped from an observation (Mr. Hoffman passed out in the driver's seat of a motor vehicle) to a conclusion (that Mr. Hoffman must have driven the vehicle while intoxicated before passing out) and did none of the fundamental and basic investigative techniques available to him that would have confirmed or disproved that Mr. Hoffman was in functional control of the motor vehicle. Notably, Officer Wolf did not even both to see if the hood of the motor vehicle was warm. (N.T. at 16). Further, Officer Wolf had counter-indications that Mr. Hoffman was alone – an Amstel Light bottle in the back of the vehicle, a Budweiser can in the driver's side compartment, and Mr. Hoffman repeatedly disclaiming driving the motor vehicle.

Additionally, Mr. Hoffman presented the uncontradicted testimony of James Pascotti who affirmatively stated that he was the driver of the vehicle to the parking lot on the night in question. (N.T. at 31). Mr. Hoffman and two (2) friends met at the Card Stadium parking lot<sup>1</sup> on October 4, 2017 to go to a concert in Baltimore in Mr. Hoffman's vehicle. (N.T. at 30). Mr. Pascotti drove Mr. Hoffman's vehicle back from Baltimore and returned to the parking lot around 12:30 A.M. to 1:00 A.M on October 5, 2017. (N.T. at 31-32). While this testimony is not primarily of import in determining whether Officer Wolf's belief was reasonable, however, it does signify that Mr. Hoffman understood that he was going to be drinking and could not drive, and took affirmative steps to prevent that from happening. Mr. Hoffman understood his duty and met it with that regard.

Therefore, PennDOT failed to prove that Officer Wolf possessed the requisite reasonable basis to believe that Mr. Hoffman exercised functional control of the movement of the vehicle at the time he was intoxicated. In light of the aforementioned, this Court sustained Mr. Hoffman's appeal and rescinded the suspension of his driver's license.

**III. Conclusion.**

Accordingly, we respectfully suggest that the Commonwealth Court of Pennsylvania affirm the proceedings before this Court of January 10, 2018 and the rescinding of Mr. Hoffman's license suspension, and dismiss the appeal in this matter.

You are further notified that an Amended Complaint pursuant to Pennsylvania's Disposition of Abandoned and Unclaimed Property Act, 72 P.S. § 1301.1 *et seq.*, and identifying you as a property owner has been filed by the Commonwealth of Pennsylvania, Treasury Department, in the Commonwealth Court of Pennsylvania, seeking a declaration that title to the above-described U.S. Savings Bonds has passed to the Commonwealth of Pennsylvania by way of escheatment pursuant to 72 P.S. § 1301.10b(d).

There are hundreds of millions of dollars in matured U.S. Savings Bonds which were issued to Pennsylvania citizens decades ago, most of which have become abandoned, lost, stolen, destroyed or relinquished. The U.S. Treasury Department continues to hold the proceeds of these bonds (and with respect to the U.S. Savings Bonds the Pennsylvania State Treasurer's Office sent back to the U.S. Treasury Department, the U.S. Treasury Department holds the physical bonds themselves) while making little to no effort to seek out the owners and return the proceeds. To address this inequity, the Pennsylvania legislature passed legislation to allow the Commonwealth of Pennsylvania to take title to unclaimed and abandoned U.S. Savings Bonds by a process known as title-based escheatment. The new law also provides a process for persons to file a claim for the proceeds from these bonds after redemption by the state occurs.
