Summary of Verdicts from the March 2008 Civil Jury Term

The Judges have completed the March 2008 civil jury term. A total of four cases reached verdict and one case settled after the commencement of trial. The summaries are as follows:

DIANA LOUANN STANLEY, A MINOR, BY LOUANN SPEESE-STANLEY, HER MOTHER and LOUANN SPEESE-STANLEY INDIVIDUALLY v. PINNACLE HEALTH HOSPITALS T/D/B/A HARRISBURG HOSPITAL (2884 CV 2002)

Diana Louann Stanley suffered dehydration and high sodium levels in her blood stream as a very, very young infant. Plaintiff claimed that the hospital was too aggressive in rehydrating and reducing the sodium levels in the child's system. As a result, plaintiffs claimed that the child was susceptible to seizure syndrome and suffered seizures which has left the child with life long and debilitating injuries. Defendants claimed that the hospital staff did nothing wrong and even if they did, the child had other neurological difficulties which contributed to or were responsible for the seizures.

Plaintiff asserted that the salesman represented that he could return in six months to trade the Hyundai for a larger vehicle. Plaintiff returned in six months and wanted to trade the Hyundai in for a Pontiac Grand Prix. The dealer would not permit the trade in but told the plaintiff that he could allow the Hyundai to be voluntarily repossessed. The vehicle was repossessed but there was negative equity in the amount of \$4,786.49. Plaintiff filed suit under the Unfair Trade Practices Act, Consumer Protection Law, Pennsylvania Automotive Industry Trade Practices Act and the Magnusson Moss Warranty Act. Plaintiff also asserted claims of breach of contract, defamation and negligence.
