he didn't have insurance, then his operation would have happened and he probably wouldn't have died but that's not the same thing as somebody, Hershey Medical Center or anybody else or anywhere else discriminating against him." (N.T. 6/14-16 at 64). Also on cross-examination, when posed with the question, "If he had the money, he would have gotten the operation and he wouldn't have died? Isn't that what you just said?" Dr. Traill responded with "Yes." *Id*.

In light of this testimony, this court finds that sufficient evidence was presented to establish direct liability on the part of Defendants in denying the decedent medical care, and thus the issue of punitive damages was properly presented to the jury.

Accordingly, the following is entered:

ORDER

AND NOW, this 19th day of April 2006, IT IS HEREBY ORDERED that Defendants' Motion for Post-Trial Relief is DENIED.

Letteer v. Michalak

Practice — Discovery — Scope — Expert witness — Fees.

In this personal injury case which arose from a motor vehicle accident, the Defendant is appealing a discovery order requiring the production of information regarding his medical expert, who examined the Plaintiff. Specifically, the order directs the Defendant to provide the number of medical examinations performed and the number of times the expert has testified for a plaintiff, defendants generally, and for the Defendants law firm in particular over the preceding five years. The order also compells production of copies of IRS Form 1999 received by the expert from the Defendant's insurance company, all insurance companies, and/or defense law firms combined in cases involving personal injury or worker's compensation over the preceding five years. The Court disagreed with Defendant's assertion that the order was overly broad, vague, not reasonably calculated to lead to relevant admissible evidence and beyond the scope of discovery.

1. It is axiomatic that any witness may be cross-examined as to potential bias and that expert witnesses are not exempt from such scrutiny. To the extent that an expert witness derives income from his appearances as a witness – particularly for one side or another – such fact is one from which a jury could reasonably infer bias.

2. An expert witness should be required to "lift his visor so that [a] jury [might] see who he [is], what he respresent[s], and what interest, if any, he ha[s] in the results of the trial, so that [a] jury [might] appraise his credibility." *Goodis v. Gimbel Brothers*, 218 A.2d 574, 577 (Pa. 1966).

KLEINFELTER, J., April 24, 2006. – Phillip Michalak (hereinafter "Defendant") appeals to the Superior Court of Pennsylvania from our Discovery Order entered February 3, 2006, and as modified by Memorandum and Order entered February 23, 2006.

Paul L. Letteer, Sr. and Debra J. Letteer (hereinafter "Plaintiffs") brought this action in negligence seeking monetary damages for personal injuries arising out of a motor vehicle accident involving Mr. Letteer and Defendant. At Defendant's request, Mr. Letteer submitted to a medical examination with Sanjiu H. Naidu, M.D. (hereinafter "Dr. Naidu"). Dr. Naidu has subsequently been identified as a defense expert for trial.

On May 23, 2005, Plaintiffs served Defendant with expert witness interrogatories seeking information on the extent of Dr. Naidu's involvement as a witness in "medical-legal matters" during the preceding five years. More specifically, Defendant was asked to provide the number of times Dr. Naidu had performed medical examinations and/or testified for a plaintiff or defendant. Also sought was the gross income which Dr. Naidu realized from his participation in this work generally and, more particularly, at the request of Defendant's counsel and through Progressive Insurance.

On June 20, 2005, Defendant served answers admitting prior testimony for Progressive Insurance and as an expert for Defendant's counsel, but objected to information as to the number of times Dr. Naidu appeared as an expert for the defense or an insurance company, generally. Defendant also objected to any request for income derived from these endeavors.

^{1.} The Order of February 3, 2006, directed Sanjiu H. Naidu, M.D., Defendant's medical expert, to provide certain discovery requested by Plaintiff. Dr. Naidu thereafter filed objections in the nature of a motion for protective order correctly noting that he had not been a party to the discovery conference which spawned the order. Our modified Order of February 23, 2006, substituted the name of the Defendant for that of Dr. Naidu.

On October 27, 2005, Plaintiff served Defendant with a Notice of Intent to Serve Subpoena to Produce Documents and Things for Discovery Pursuant to Rule 4009.21. The Notice contained a subpoena to Dr. Naidu to produce documents which would provide answers to the questions posed in the prior interrogatories. Defendant filed an Objection to Subpoena on November 14, 2005. Plaintiff thereafter filed a Motion for Discovery Conference which we set for February 3, 2006.

At the conference, Plaintiff explained that the purpose of the requested discovery was to provide information that might be used at trial to impeach the credibility of Dr. Naidu by showing an established bias for the defense and a profit motive in doing so. Defendant argued that he had "no idea" concerning Dr. Naidu's participation in cases, other than for defendant's law firm, or regarding Dr. Naidu's income derived from participation in medical-legal matters. At the discovery conference each side presented legal authority for their respective positions following which we entered an order directing the production of:

- 1. Number of medical examinations performed in medicallegal matters during the years 2000 through 2005 for (a) plaintiff and for (b) defendants generally and (c) for Nealon, Gover and Perry in particular.
- 2. Number of times testified in medical-legal matters during the years 2000 through 2005 for (a) plaintiff and for (b) defendants generally and (c) for Nealon, Gover and Perry.
- 3. Copies of IRS form 1099 received during the years 2000 through 2005 from (a) Progressive Insurance Co., and from (b) all insurance companies and/or defense law firms combined in cases involving personal injury or worker's compensation.

Our order significantly pared down Plaintiff's request for discovery as originally contained in his interrogatories and subpoena. For example, the subpoena requested:

 Any and all documents from 2000 to the present reflecting income received, earned or derived from or as a result of your participation in Medical-Legal Matters (as defined

^{2.} In his appellate brief, Defendant curiously argues that the present order directing him to produce the information is in error in that the information should have been sought directly from Dr. Naidu by subpoena. This argument ignores the fact that Plaintiff did attempt to subpoena the information by that method only to be met by Defendant's objection.

below), including, but not limited to invoices, bills, receipts, checks, federal 1099 miscellaneous income forms, W-2 wage and income forms, and other like documents.

Our order, on the other hand, was limited to the production of 1099 forms received from insurance companies or defense law firms.

In his Statement of Matters Complained of on Appeal, Defendant asserts that "the order is overly broad, vague, and such discovery is not reasonably calculated to lead to relevant admissible evidence under Pa. R.C.P. 4003.1 and is beyond the scope of discovery permitted by Pa. R.C.P. 4003.5." We disagree.

It is axiomatic that any witness may be cross-examined as to potential bias and that expert witnesses are not exempt from such scrutiny. To the extent that an expert witness derives income from his appearances as a witness – particularly for one side or another – such fact is one from which a jury could reasonably infer bias. Thus, the admissibility of such evidence at trial is hardly a matter for debate. On the other hand, there comes a point where requests for such information may become unduly burdensome, vexatious, and overly broad. Striking the proper balance of such an inquiry falls to the trial court in the exercise of its discretion.

In Mohn v. Hahnemann Medical College & Hospital of Philadelphia, 515 A.2d 920 (Pa. Super. 1986), one finds an excellent anthology of cases tracing the development of our law defining the scope of crossexamination – and, by extension, the scope of discovery – relating to fees charged and income derived by experts. In that case, following Zamsky v. Public Parking Authority of Pittsburgh, 105 A.2d 335 (Pa. Super. 1954), the court seemed to limit the scope of the inquiry to those expert witness fees which would be realized in the case on trial. Yet, going beyond Zamsky, the Mohn court found proper inquiry into "the existence of the financial relationship between Dr. Urbach [the expert witness] and defense counsel's firm, which [in that case] spans approximately twelve (12) years and is still extant" Mohn; 519 A.2d at 923. Still, Mohn would not extend the inquiry so as to expose the "expert's total income, unrelated ... to the results of the trial" Id. at 925. In sum, Mohn would limit the income inquiry to work performed for trial counsel's law firm.

Instantly, our discovery order goes beyond *Mohn* and Defendant argues that it was error to do so. We concede that our order goes beyond *Mohn* but follows what we believe to be is an expanded scope

of discovery as announced recently in J.S. v. Whetzel, 860 A.2d 1112 (Pa. Super. 2004). In Whetzel, relying on Coward v. Owens-Corning Fiberglass Corp., 729 A.2d 614 (Pa. Super. 1999) (cross-examination of expert in asbestos case may extend to fees generated from all such cases), the court distinguished Mohn and permitted inquiry into the amount of income an expert has received from testifying in a particular type of case, e.g. asbestos or personal injury.

The facts in *Whetzel* are analogous to ours. Perry A. Eagle, M.D., defendant's expert who had performed an "independent medical exam" of the plaintiff, moved for a protective order seeking to shield his 1099 forms from discovery. The trial court denied the motion. On appeal, Superior Court framed the issue as "whether a party may obtain discovery of *all* sources and amounts of income received by the opposing party's expert witness." *Whetzel*, 860 A.2d at 1115. (*Emphasis added*).

In the instant case, the trial court ordered Dr. Eagle to produce all 1099 forms received from any insurance company or attorney from 1999 through 2002. We agree with the trial court that Dr. Eagle must produce the 1099 form related to his services for Mr. Whetzel's counsel, in this and other cases. See, Smith, supra; Mohn, supra. This information addresses any potential bias Dr. Eagle might have toward Mr. Whetzel's counsel. See, Mohn, supra. Additionally, Dr. Eagle must produce those 1099 forms related to his services for insurance companies or attorneys in personal injury cases. This information is relevant to examine any potential bias Dr. Eagle might have in favor of personal injury plaintiffs or defendants. See, Coward, supra. However, the court erred to the extent it permitted unfettered production of any and all of Dr. Eagle's 1099 forms. See, Mohn, supra. Some of these documents may contain payments from insurance companies or other sources where no litigation was involved, or payments by attorneys in cases unrelated to personal injury. See, Id.

Id. at 1121. (Emphasis added).

It is clear that *Whetzel* has expanded the scope of discovery of professional fees beyond the case on trial and beyond those fees received from the law firm representing defendant in a particular case.

The order appealed instantly does not require Dr. Naidu to produce *any* and *all* 1099s from any source but only those related to personal injury litigation. This information is absolutely relevant to develop a potential for bias in a case such as the one before us. In the words of Mr. Justice Musmanno, Dr. Naidu should be required to "lift his visor so that [a] jury [might] see who he [is], what he represent[s], and what interest, if any, he ha[s] in the results of the trial, so that [a] jury [might] appraise his credibility." *Goodis v. Gimbel Brothers*, 218 A.2d 574, 577 (Pa. 1966). On the other hand, our order does not encompass "the emptying of one's pockets and turning them inside out so that [Dr. Naidu's] financial worth can be open to scrutiny." *Mohn, supra*, 515 A.2d 924. We believe that our present order strikes this balance and is in accord with the present state of the law of discovery in this area.
