WHEREFORE, pursuant to our Order of even date herewith, the Plaintiff's Motion for Partial Summary Judgment shall be GRANTED and Patt's Motion for Partial Summary Judgment and the Legion's Motions for Summary Judgment must be DENIED.

ISSUED AT HARRISBURG, this 7th day of June, 2007.

#### ORDER

AND NOW, to wit, this 7th day of June, 2007, IT IS HEREBY ORDERED that ROOM ONE CORPORATION'S (Room One) Motion for Partial Summary Judgment which requests judgment in its (Room One's) favor on its claim for Breach of Contract, and which further requests that the Counterclaims filed by P. JULES PATT (Patt) be dismissed, is GRANTED. As a result, the Partial Motion for Summary Judgment filed by Patt and the Motion for Summary Judgment filed by the HUMMELSTOWN POST NO. 265, AMERICAN LEGION DEPARTMENT OF PENNSYLVANIA (Legion) are DENIED.

The Legion IS HEREBY ORDERED to immediately execute a Deed to the title of its land and convey such title to Room One. Room One IS ORDERED to immediately pay to the Legion the original sales price offered by Patt to the Legion, and also comply with any other provisions of that original offer.

Inasmuch as Room One has also sought damages for claims sounding in Fraud and Breach of Duty of Good Faith against Legion, as well as Intentional Interference with Contractual Relations against Patt, Room One is granted TEN (10) days to withdraw those claims if Room One is satisfied with the relief granted herein, or it (Room One) may move for a hearing on those issues.



#### State Farm Mutual Automobile Insurance Co. v. Ferster, et al.

Contracts — Insurance — "Non-owned Car" — Employee.

This was a declaratory judgment action arising out of an automobile accident in which the 16 year old driver was operating a vehicle registered to her father's employer. The child's parents were divorced at the time of the accident. A passenger in the vehicle who was injured in the accident sued the minor child, claiming that an insurance policy issued

to her mother as the insured of an automobile not involved in the accident provided liability coverage for the injuries. Under the terms of that policy, this question depended upon whether the child was an employee of her father's company.

- 1. The Pennsylvania Rules of Civil Procedure provide that summary judgment is appropriate "whenever there is no genuine issue of any material fact as to a necessary element of the cause of action" and the moving party is therefore entitled to judgment as a matter of law. *Pa. R. Civ. P. 1035.2(1)*.
- 2. Whether a loss is within policy coverage is an issue of law, which may be decided on motion for summary judgment. Where the policy provisions are unambiguous, the courts must give effect to the language used. *Maney v. Lloyd*, 634 A.2d 1139, 1143 (Pa. Super. 1993).
- 3. Receipt of valuable consideration both in cash and the use of a vehicle for services rendered 10-15 hours per week performing necessary tasks in the regular course of a business, qualifies the recipient as an employee.

Motion for Summary Judgment. C.P., Dau. Co., No. 3123 CV 2002. Motion granted.

KLEINFELTER, J., July 12, 2007. – Before the court for disposition is the motion for summary judgment filed by plaintiff State Farm Mutual Automobile Insurance Company (hereinafter "State Farm"). This is a declaratory judgment action arising out of an automobile accident on August 25, 2000, in which Ashley Bachert (hereinafter "Ashley"), 16 years old, was driving a Ford Mustang owned by her father, Clyde Bachert (hereinafter "Mr. Bachert"). The Mustang was registered to Mr. Bachert's company, Courteous Rental, Inc. (hereinafter "Courteous"). Loretta Ferster (hereinafter "Ms. Ferster"), then Mr. Bachert's girlfriend, was a passenger in the Mustang.

At the time of the accident, Ashley was living with her mother, Cathy Bachert<sup>1</sup> (hereinafter "Ms. Bachert"), and was insured under a policy issued by State Farm which named Ms. Bachert as the insured of an automobile not involved in this case. Subsequent to the accident, Ms. Ferster filed a civil action in the Court of Common Pleas of Philadelphia County naming Ashley as a defendant and claiming that Ms. Bachert's State Farm policy provides liability coverage to her for injuries she suffered in the accident.

<sup>1.</sup> Clyde and Cathy Bachert were divorced at the time of the accident. Clyde Bachert and Loretta Ferster married subsequent to the accident. They are now divorced.

State Farm filed a complaint for declaratory relief in this court on July 12, 2002, alleging that it is not bound to provide coverage for personal injuries sustained by Ms. Ferster. On July 23, 2002, Ms. Ferster filed her answer. State Farm filed the instant motion for summary judgment on January 8, 2007. Ms. Ferster filed her response on February 5, 2007. State Farm filed a brief in support of its motion on March 30, 2007, and Ms. Ferster filed a brief in opposition on April 24, 2007.

The Pennsylvania Rules of Civil Procedure provide that summary judgment is appropriate "whenever there is no genuine issue of any material fact as to a necessary element of the cause of action" and the moving party is therefore entitled to judgment as a matter of law. Pa. R.Civ. P. 1035.2(1). The relevant elements necessary to permit summary judgment are as follows:

First, the pleadings, depositions, answers to interrogatories, admissions on file, together with any affidavits, must demonstrate that there exists no genuine issue of fact. Second, the moving party must be entitled to judgment as a matter of law. The moving party has the burden of proving that no genuine issue of material fact exists. However, the non-moving party may not rest upon averments contained in its pleadings; the non-moving party must demonstrate that there is a genuine issue for trial. The court must examine the record in the light most favorable to the non-moving party and resolve all doubts against the moving party. Finally, an entry of summary judgment is granted only in cases where the right is clear and free of doubt.

Blackman v. Federal Realty Inv. Trust, 664 A.2d 139, 141-142 (Pa. Super. 1995).

Whether a loss is within policy coverage is an issue of law, which may be decided on motion for summary judgment. In making this determination, we examine and resolve the intent of the parties as expressed in the insurance contract. Where the policy provisions are unambiguous, the courts must give effect to the language used.

Maney v. Lloyd, 634 A.2d 1139, 1143 (Pa. Super. 1993).

The instant policy, under Section I – Liability – Coverage A, includes a subsection titled "Coverage for the Use of Other Cars." This

subsection provides that "liability coverage extends to the use, by an insured,<sup>2</sup> of a newly acquired car, a temporary substitute car or a non-owned car." "Non-owned car" is defined as "a car not owned by, registered or leased to:

- (1) you, your spouse;
- (2) any relative unless at the time of the accident or loss:
  - a. the car currently is or has within the last 30 days been insured for liability coverage; and
  - b. the driver is an insured who does not own or lease the car;
- (3) any other person residing in the same household as you, your spouse or any relative; or
- (4) an employer of you, your spouse or any relative."

Ms. Ferster contends that Ashley should be covered under the instant policy because the Mustang was a "non-owned car." State Farm, however, claims that its coverage is excluded because, at the time of the accident, Ashley was employed by her father's company, Courteous. Thus, State Farm asserts that the Mustang is not a non-owed car for purposes of the instant policy and that it is therefore entitled to summary judgment.

We note that the instant policy does not define "employee." That being the case, State Farm refers us to Black's Law Dictionary: "a person who works in the service of another person (the employer) under an express or implied contract of hire, and where the employer has the right to control the details of work performance." Black's Law Dictionary 543 (7th Ed. 1999). Ms. Ferster, on the other hand, references the Workers Compensation Act, which defines an employee as, "[a]ll natural persons who perform services for another for a valuable consideration, exclusive of persons whose employment is casual in character and not in the regular course of the business of the employer. ..." 77 P.S. §22.

In support of its contention that Ashley was an employee of Courteous at the time of the accident, State Farm cites Ashley's March 2002 deposition testimony, wherein she stated that during the summer of 2000 she

<sup>2. &</sup>quot;Insured" is defined as including "the relatives of the first person named in the declarations." State Farm evidently does not dispute that this would include Ashley, as the daughter of policy owner Cathy Bachert.

performed tasks at Courteous relating to accounts receivable and data entry "whenever [she] had time to go." N.T., Ashley Bachert Deposition, pg. 6. Ashley stated that she worked approximately 10-15 hours per week and was paid in cash, never receiving a W-2. *Id.*, at pp. 15, 6-7. She had been performing such tasks at Courteous since she was 13 years-old. *Id.* at pg. 6. Ashley considered the Mustang to be part of her pay and determined that "[i]t was a gift as long as I worked there." *Id.* at pg. 14.

In support of her contention that an issue of fact exists as to whether or not Ashley was actually employed by Courteous, Ms. Ferster avers that Ashley was simply performing favors for her father for which she received small gratuities. Ms. Ferster also emphasizes that Ashley was paid by her father, not Courteous, and that she received no reportable income. Further, Ms. Ferster claims that Courteous had no power over Ashley because she worked at her own convenience and was not expected to fulfill any particular obligations.

We find that the record before us compels a decision that Ashley was employed by Courteous. Ashley received valuable consideration – both cash and the use of a vehicle – for services rendered in the regular course of her father's business. She was not merely casually employed, but worked 10-15 hours per week performing necessary business tasks.

Ms. Ferster's contention that Ashley was not an employee of Courteous because she was paid in cash and because she enjoyed certain privileges associated with being the owner's daughter is without merit. We are aware of no authority, and Ms. Ferster cites none, to suggest that one who labors in the service of another is not an employee merely because he is paid "under the table" and does not work on a fixed schedule. Thus, we conclude as a matter of law that the Mustang was not a "non-owned car" under the terms of the instant policy.

Accordingly, we enter the following:

#### ORDER

AND NOW, this 12th day of July 2007, upon consideration of State Farm's Motion for Summary Judgment,

IT IS HEREBY ORDERED that said motion is granted.
