degree of Mrs. Urmann's burden there. Here, the 58% - 42% split is not nearly so disproportionate in favor of the consortium claim, reflecting the evidence presented to this court.

Accordingly, I issued an order approving the settlement reached between the Walters and Donald McNany.

Estright v. Harrisburg Hospital, et al.

Compromise and Settlement — Wrongful Death and Survival Claims — Settlement Allocation.

The Court was asked to approve a \$100,000 settlement for wrongful death and survival claims, but not a related \$300,000 individual claim for negligent infliction of emotional distress, which was reached in conjunction with the wrongful death and survival claims. The Court determined that judicial approval was required for the global settlement of all the claims.

1. Claims under the Wrongful Death Act, 42 Pa. C.S. §8301, include pecuniary loss suffered by the statutory beneficiaries as a result of the death, based upon the value of expected future enjoyment of services, maintenance or gifts from the decedent. *See, Hodge v. Loveland*, 456 Pa. Super. 188, 690 A.2d 243 (1997).

2. A survival action is "intended to protect the interests of the estate, taxing authorities, unborn heirs, other interested third parties, and the creditors and the beneficiaries thereof." *Moore v. Gates*, 398 Pa. Super. 211, 580 A.2d 1138 (1990).

3. Settlement petitions should fully disclose, not only to the Court, but to taxing authorities and creditors, the full amount of a global settlement, including apportionment to an individual claim.

HOOVER, J. September 10, 2009. – This matter comes before the court on the Petition to Settle Wrongful Death and Survival Claims Under 42 Pa. C.S.A. §2206, ("Petition"). The Petition presents the issue of whether court approval is required for a settlement of an independ-

individual claim reached in conjunction with wrongful death and survival claims. We find that such approval is required, for the reasons set forth herein. While we approve the instant proposed settlement, based solely on the facts presented herein, we deem it necessary to further discuss the complete nature of such settlement, and the duties of the parties thereto.

The claims underlying the settlement arise out of the tragic death of ten year old Damien Estright. Damien's mother, Yvette Estright ("Plaintiff) alleges that Defendant Harrisburg Hospital, and the named nurses, physician and physician's assistant, negligently diagnosed and cared for Damien's knee injury on December 30, 2005. Damien died two days later, after being transported to the emergency room on January 2, 2006, following complications from a soft tissue infection.

Ms. Estright asserted wrongful death and survival actions ("wrongful death/survival"), in her capacity as Administratrix of the Estate of Damien Estright. In addition, in her individual capacity, she asserted a personal claim for negligent infliction of emotional distress.

The Petition reflects that the total amount of the settlement ("global settlement") was \$400,000. However, in the Petition and proposed Order submitted to the court, Plaintiff merely seeks approval of settlement of the wrongful death/survival claims, in the amount of \$100,000. We therefore consider the appropriateness of Plaintiff's unilateral apportionment of \$300,000 to her personal claim, and \$100,000 to the wrongful death and survival claims, an apportionment for which no court approval was sought.

Plaintiff filed the Petition in accordance with Pa. R.C.P. 2206, Settlement, Compromise, Discontinuance and Judgment which provides, in relevant part:

(b)(1) When as the result of a verdict, judgment, compromise, settlement or otherwise it has been determined that a sum of money is due the plaintiff in an action for wrongful death, the court, upon petition of any party in interest, shall make an order designating the persons entitled to share in the damages recovered and the proportionate share to the net proceeds to which each is entitled.

Further, Dauphin County Local Rule of Procedure 2206, Petitions for Approval of Wrongful Death and Survival Settlements, requires that a Petition for Approval of a Wrongful Death and Survival Action set forth

"the proposed apportionment between wrongful death and survival recoveries, including the factual basis for said apportionment." Dauphin County Local Rule 2206 (b)(2)(j). The petition must include as an exhibit "[a] copy of correspondence from the Department of Revenue approving the proposed allocation of settlement funds between the wrongful death and survival actions." Dauphin County Local Rule 2206 (3)(c).

The distinction between the types of claims recoverable under a wrongful death and a survival action bear reminder. Claims under the Wrongful Death Act, 42 Pa. C.S §8301, include pecuniary loss suffered by the statutory beneficiaries as a result of the death, based upon the value of expected future enjoyment of services, maintenance or gifts from the decedent. See, Hodge v. Loveland, 456 Pa. Super. 188, 690 A.2d 243 (1997). Other claims properly included in a wrongful death action are intangible losses relating to the services, guidance, society and comfort that the deceased person would have provided, as well as reasonable medical, funeral, and estate administration expenses. See, Kiser v. Schulte, 538 Pa. 219, 648 A.2d 1 (1994). Under the Survival Act, 42 Pa. C.S. §8302, the representative of the decedent may claim the loss of the decedent's earnings between the time of injury and death, from death to the date of settlement or verdict, as well as future earning capacity, less personal maintenance expenses. See, Kiser v. Schulte, 538 Pa. 219, 648 A.2d 1 (1994) and Tuleweiz v. SEPTA, 529 Pa. 588, 606 A.2d 427 (1992). A survival action is "intended to protect the interests of the estate, taxing authorities, unborn heirs, other interested third parties, and the creditors and the beneficiaries thereof." Moore v. Gates, 398 Pa. Super. 211, 580 A.2d 1138 (1990).

In this case, the decedent was survived by his parents, his sole intestate beneficiaries under Pennsylvania's Intestate Succession Statute, 20 Pa. C.S. §2103.

In considering the Petition, we look to how the larger allocation to the personal, individual claim, impacts the respective interests of the estate, the statutory beneficiaries, and potential creditors. Three fourths of the global settlement having been apportioned to the individual claim, only one fourth remains to be distributed between the child's estate, specifically, a mere \$9,950.43 as the survival claim, and \$89,553.90 to the wrongful death claim.

Pursuant to *Moore v. Gates, supra,* we must consider the tax consequences of such allocation. The Petition includes, as an exhibit, a letter from Pennsylvania Department of Revenue. However, the letter reflects

that the Plaintiffs sought Revenue's approval, not for the global settlement of \$400,000, but for settlement in the amount of \$100,000. The Department of Revenue concluded that inasmuch as the parents are the sole heirs to decedent's estate, pursuant to 72 P.S. §9116(a)(1.2), "proceeds paid to settle the survival action would pass to decedent's parents and would be subject to a zero percent inheritance tax. Accordingly, regardless of the subject proceeds, there would be no inheritance tax consequences." (Letter from the Commonwealth of Pennsylvania Department of Revenue, Bureau of Individual Taxes, Shannon E. Baker, Trust Valuation Specialist, June 2, 2009) Nonetheless, we find it disturbing that the request for approval to Revenue makes no mention of the global settlement.

Apart from consideration of potential tax consequences, allocation of \$300,000 to the individual claim reduces to \$100,000 the amount to be shared by the mother and father as intestate beneficiaries. We acknowl-edge that in the instant matter, the father has joined in the Petition, such that he affirms by affidavit an understanding that he shares as intestate beneficiary, \$100,000, not \$400,000. Such joinder by the natural father in the apportionment to the mother's individual claim eliminates the need to conduct an evidentiary hearing as to the fairness of the amount of his recovery.

We do note that were it the design of the parties to reduce or bar recovery based upon any alleged abandonment of parental responsibilities, absent clear notice to and joinder of the father in the Petition, the proper means by which to raise such issue would be a Forfeiture Action. Pursuant to Pa. C.S. \$2106 (b)(1), any parent who, for one year or more prior to the date of the death of the child, has failed in the duty to support the child, or has deserted the child, shall have no right or interest in the estate of the minor. Pa. C.S. \$2106 (b)(1).

Finally, we are cognizant that the amount apportioned to an individual claim, as opposed to the wrongful death and survival claims, may have a bearing upon the amount reimbursed to a lien holder, such as the Department of Public Welfare. It would not be unusual for a lien holder to compromise and accept less than the full amount of a lien, taking into consideration the gross amount recovered in a settlement. In the case at bar, the Pennsylvania Department of Public Welfare has compromised its relatively small lien by 33 1/3, presumably, the amount of counsel fees, for recovery its lien. (Letter of Commonwealth of Pennsylvania Department of Public Welfare, Barbara E. Witmer, Claims Investigation Unit, May 27, 2009) Complete candor to lien holders such as the

Department of Public Welfare, as well as to the Department of Revenue, requires full disclosure of the amount of a global settlement which includes amount paid to an individual claimant.

Having determined that no tax consequences exist by the small apportionment to wrongful death and survival claims, and in consideration of the joinder of the natural father in reduction of his intestate share, on these facts alone, we are constrained to approve the settlement.

However, we caution that future petitions should fully disclose, not only to the court, but to taxing authorities and creditors, the full amount of a global settlement, including apportionment to an individual claim.

Accordingly, we enter the following:

ORDER

AND NOW, this 10th day of September, 2009, upon consideration of the Petition to Settle Wrongful death and Survival Claims Under 42 Pa. C.S.A. §2206, it is hereby ORDERED that Petitioner is authorized to enter into a settlement with Defendants, Harrisburg Hospital, Pinnacle Health at Harrisburg Hospital, Pinnacle Health Hospitals, Michelle L. Latsha, PA-C, Jennie Canfield, R.N. and Lynn Reckford, L.P.N., in the amount of \$400,000, to be distributed as follows:


