WCAC is our collaboration with MidPenn Legal Services to provide a full-time specialized attorney, handling approximately 546 domestic violence and child custody cases annually. 100% of all donations benefit WCAC and do not support administrative fees. YOUR SUPPORT AT WORK:

REUNITED WITH LILLY!

All Becky wanted was to see her five-year-old daughter, Lilly. It was the end of spring and Becky did not know where Lilly's father, Rob, and her daughter were located. Despite having joint custody with Rob, this was the longest Becky had ever gone without seeing her daughter. She felt hopeless and did not know what to do next. Children and Youth Services became involved and were able to locate Rob's address. She discovered that he did not have Lilly enrolled in school during that time she was unable to locate them. The WCAC-sponsored family law attorney explained the court process and the specific steps involved in gaining custody. In August 2020, Becky filed the first petition. She learned that Lilly was still not attending school and filed a second petition in December 2020. The final hearing took place in March 2021 in front of a judge. As a result of the hearing, Becky was granted primary custody of Lilly. Becky said having a family law attorney, in partnership with WCAC, was essential to securing Lilly's safety and reuniting with her permanently. Lilly is now living primarily with her mother, attending school full-time, and is thriving!



Sandy's Celebratory Send-off! WCAC Virtual Fundraising Event Honors Sandy Ballard November 16, 2021

Harvard Law defines poverty law as, "the legal statutes, regulations and cases that apply particularly to the financially poor in his or her day-to-day life". In a commonsense understanding and in practice, the goal of poverty law is to protect the disadvantaged poor from unfair treatment by the law.

Sandy Ballard, a product of Harvard Law but the heart and soul of the Dauphin County Bar Association public interest community for the past 19 years, was celebrated in a virtual retirement ceremony on November 16, 2021. Videos, live remarks, written praise, and unique graphics came together in a wonderful event that honored the longtime DCBA staffer, a true champion of access to justice, while raising more than \$14,000 for WCAC of the Dauphin County Bar Foundation. WCAC supports a full-time family law lawyer at MidPenn Legal Services dedicated to helping Dauphin County families, handling more than 500 domestic violence and child custody cases annually. Ballard's event was part of the DCBF's 11 days for 11 Years effort that commemorates the 11th year of the We Care About Children Campaign.



The impact of Sandy's work was reflected in the diversity of those who honored her, starting with the Masters of Ceremony for the event, noted by pro bono volunteers Mark Silliker and John Frommer. Dauphin County Court President Judge John Cherry, former President Judge Richard Lewis, and retired Judge and CASA Board President Lori Serratelli all lauded Ballard's work. Many noted pro bono lawyers also cheered Ballard on, from the venerable Corky Goldstein, to Doreen McCall, from Jim DeAngelo, whose challenge grant lifted the fundraising, to Tracy Updike and Ed Spreha. Past DCBA Executive Director Liz Simcox joined current Executive Director Patrice Merzanis and the entire DCBA staff in thanking Ballard for her service over the years. MidPenn Legal Aid Executive Director Rhodia Thomas harkened back to being involved in interviewing Ballard nearly two decades ago as Ballard applied for the position, a position Ballard has made uniquely her own, noting that even then Thomas knew it would be special having such a colleague. Former Pennsylvania Legal Aid Network Executive Director Sam Milkes joined his successor, Patrick Cicero, and IOLTA's Stephanie Libhart in heartfelt messages of similar sentiments.

Ballard's peers in the statewide pro bono network, the Pennsylvania Bar Association's David Trevaskis, Allegheny County Bar Foundation's Barbara Griffin and Sylvia Hahn of Lackawanna Pro Bono, Inc., all shared how honored they were to work with Ballard. The event concluded with remarks from the honoree, with Ballard ending the evening by sharing a prayer a friend had recently sent her:

May God bless you with a restless discomfort about easy answers, half-truths and superficial relationships, so that you may seek truth boldly and love deep within your heart.

May God bless you with holy anger at injustice, oppression, and exploitation of people, so that you may tirelessly work for justice, freedom, and peace among all people.

May God bless you with the gift of tears to shed with those who suffer from pain, rejection, starvation, or the loss of all that they cherish, so that you may reach out your hand to comfort them and transform their pain into joy.

May God bless you with enough foolishness to believe that you really CAN make a difference in this world, so that you are able, with God's grace, to do what others claim cannot be done.
