## MEMORIAL RESOLUTION UPON THE DEATH OF NORMAN M. YOFFE

Norman Yoffe died on April 9, 2010 at the age of 80 years. He was born on July 27, 1929.

Norman was a 1947 graduate of William Penn High School in Harrisburg. He received a Bachelor of Arts degree from Bucknell University in 1951. At Bucknell, he was selected for membership in Phi Beta Kappa.

Norman graduated from Harvard Law School in 1954 with a L.L.B degree and later received a Doctor of Laws degree from Harvard.

Service in the U.S. Navy as well as in the U.S. Army was something of which Norman was very proud. Norman trained in the army as a member of the 101<sup>st</sup> Airborne Infantry Division and was thereafter assigned to V Corps Headquarters in Frankfurt, Germany, in the Office of the Assistant Chief of Staff for G-2, Counterintelligence.

Norman practiced law for over 50 years. Most recently, from 1990 until his death in 2010, he was a member of the firm of Yoffe & Yoffe, P.C. in Camp Hill. He was a member of the Dauphin County and Pennsylvania Bar Associations and a former member of the Cumberland County Bar Association.

For over 30 years, Norman was the Solicitor for the Dauphin County Prothonotary and the Susquehanna Township Zoning Hearing Board. Formerly he was a hearing officer for the Pennsylvania State Labor Relations Board. He was a hearing officer for the Pennsylvania Bureau of Professional and Occupational Affairs and heard cases involving the Medical, Realtor and Engineering Boards or Commissions.

Norman was a lifelong member of Ohev Sholom Temple, a past Board Member of Ohev Sholom Temple and a former Sunday School Teacher.

Traveling and gardening were Norman's primary hobbies. Norman traveled to every continent on the Earth, including Antarctica and the Arctic. In fact, while in the Arctic, Norman was at both the geographic and the magnetic north pole.

On December 21, 1958, Norman married Deborah Serata. Norman was survived by Deborah, his children named Nancy and Jeffrey, as well as his grandchildren named Meriellyn, Evan, Mikel, Sarah and Matthew.

Therefore, be it resolved, that Norman's aforementioned family members have lost a loved and respected leader of their family.

Be it further resolved that the bar has lost a member who loved the practice of law.
