

## MEMORIAL RESOLUTION UPON THE DEATH OF TODD CHRISTOPHER HOUGH

Our friend and colleague, Todd Christopher Hough, died on January 25, 2015. He was survived by his wife, Kimberly, and by his three children, Elias, Ava and Lily.

On behalf of Todd's Memorial Committee and family I would like to thank the Judges of this Court, the Dauphin County Bar Association and all of you for allowing us this opportunity to honor Todd.

Todd passed away far too soon at the age of 40 after a courageous battle with metastatic melanoma. Hough was tough. On his high school soccer team his nickname was "rough tough Hough." We saw this toughness in his battle with cancer. The amount of pain that he was enduring as the cancer progressed through his body was hard to witness. But, at all points during his battle, he was tough, did not complain, and kept his eye on the goal of winning the battle. Unfortunately, although his battle with cancer was unsuccessful, he was successful in showing everyone how truly tough Todd Hough was.

He will be remembered by all those he touched as an honorable man, a really sweat guy, and a tremendous father. He will be sorely missed.

After Todd graduated from Boiling Springs High School but before he did anything else Todd married his high school "sweetheart," Kimberly Diehl. Shortly thereafter, he enlisted in the United States Army and received training at the Defense Institute of Language in Monterey, CA and learned to speak Russian. After further training Todd was recognized as a member of the Military Intelligence Corps. Todd further served a tour as a member of the Defense Attaché's Office, of the United States Embassy in Cairo, Egypt. Todd was honorably discharged in 1997.

Todd received his Bachelor of Science in Public Policy in 1999 from the Penn State University Capital Campus. He earned the Kenneth P. Masters Prize in Public Policy for academic excellence.

Todd received his Juris Doctor from the Dickinson School of Law in 2002. In his legal carrier, Todd worked primarily on behalf of employers in Workers Compensation cases. Early in his carrier he also handled family law matters. Todd brought his military intelligence background to the practice of law, always insisting that we can win the case if we just do enough research and investigation. He taught us a lot.

Todd volunteered for several years as a board member of the Amelia Given Library.

Todd was blessed with three children and was devoted to his family. Family was very important to Todd and he attempted to instill his love for the Pittsburgh Penguins, the Chelsea Football Club, the Michigan Wolverines and the Atlanta Braves to his children. Todd simply loved spending time with his family from watching them participate in sports to fishing, boating and playing cards games with them. Todd's passing leaves a large hole in our lives and he will forever be missed.

No memorial of Todd would be complete with referencing one of Todd's true passions; donuts. Todd loved donuts of any kind. He named his Pug Fasnacht. Dennis Cullen tells the story of how he first learned of Todd's love of donuts while on a business trip to Boston together. Dennis learned that Dunkin Donuts was headquartered in Boston and they stopped at what seemed like every Dunkin Donuts along their route to and around Boston. In fact, on the way home, after eating copious amounts of donuts, they had their last stop for gas as they were entering Pennsylvania, which they knew would be their last stop before returning home. As it turned out, the gas station was a combination Dunkin Donuts and gas station. Having already eaten more calories than they should have that day, Dennis was surprised when Todd announced that he was going in to get a donut. To which he replied "really?" And without hesitation, Todd replied "Really!"

THEREFORE, BE IT RESOLVED, that in the passing of Todd C. Hough, the community has lost a true gentleman, a professional colleague and a respected citizen and the family has lost an affectionate and devoted father and husband.
