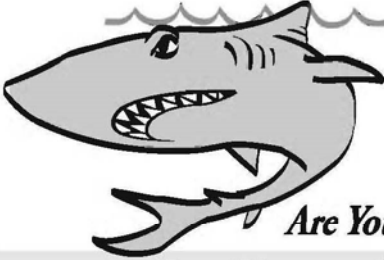
Tentative Selection of Henry W. Van Eck
