The Judges have completed the DECEMBER 2017 civil jury term. One civil case reached verdict during the December civil term and the summary is as follows:

**SHAUN BITNER and LORI BITNER, Husband and Wife v. JONAS SHEEHAN, M.D. and THE MILTON S. HERSHEY MEDICAL CENTER d/b/a PENN STATE MILTON S. HERSHEY MEDICAL CENTER d/b/a MILTON S. HERSHEY MEDICAL CENTER PHYSICIANS GROUP (2015 CV 01861 MM)**  
**SHAUN BITNER and LORI BITNER, Husband and Wife v. JONAS SHEEHAN, M.D., T. THOMAS ZACHARIAH, M.D., and THE MILTON S. HERSHEY MEDICAL CENTER d/b/a PENN STATE MILTON S. HERSHEY MEDICAL CENTER d/b/a MILTON S. HERSHEY MEDICAL CENTER PHYSICIANS GROUP, PENN STATE HERSHEY RADIOLOGY (2016 CV 02239 MM)**

This is a medical malpractice case involving the L4-5 laminectomy and fusion. The surgery was performed in March 2014. The plaintiff, Shawn Bitner, had a two year history of back pain radiating into his legs. Jonas Sheehan M.D., a neurosurgeon at Hershey Medical Center, allegedly caused some trauma to the dura during surgery. Injury to the dura is a known risk of a laminectomy. He repaired the dura during the surgery.

The Plaintiff continued to have back and leg problems and later went to another neurosurgeon in Lancaster who over the next few years performed eight additional back surgeries.

The Plaintiffs sued Dr. Sheehan and Dr. Zachariah (the radiologist). The allegations against Dr. Sheehan was that he did not properly repair the dura and failed to perform a foraminotomy. There was a dispute concerning the extent of damage to the dura and whether post-surgery radiographic studies show the extent of the dura damage.

Pre-trial, the defense filed a motion for summary judgment on behalf of Dr. Zachariah arguing plaintiff failed to produce expert testimony against Dr. Zachariah - the court granted the defense motion and Dr. Zachariah was dismissed from the lawsuit.

At trial, the Plaintiffs refined their argument claiming that only the first two out of eight surgeries were the result of Dr. Sheehan's negligence.

The Plaintiffs made claims for lost wages, lost earning capacity as well as non-economic damages.

**Pretrial motions**

There were numerous pretrial motions. The court excluded testimony and argument from the plaintiff that he was declared disabled by social security; denied plaintiffs' motion to preclude the defense from using Plaintiff's income tax returns on lost earning capacity; limited plaintiffs' expert liability expert to his expert reports and allegations plead in the complaint.

**Rulings during trial**

Plaintive chose to call an economist instead of a vocational expert on Plaintiff's claim of lost earning capacity. The court limited the economist from testifying in areas the economist was not qualified because he was not a vocational expert. The economist was limited to the mathematical calculations concerning the Plaintiff made pre-surgery and post-surgery.

**Experts**

Plaintiffs liability expert was Robert Beatty, M.D., a semi-retired neurosurgeon; James Argires, the subsequent treating neurosurgeon who performed eight surgeries; and Jonathan Cramer, a certified actuary.

The defense experts were Rajiv Gupta, M.D., a neuroradiologist liability expert; Paul Arnold, M.D., a neurosurgeon liability expert; and, Chad Staller, an economist.

**Verdict**

Jury answered question one - did the conduct of Dr. Sheehan fall below the standard of care - NO

Accordingly, the jury answered no additional questions. The plaintiffs have filed post-trial motions.

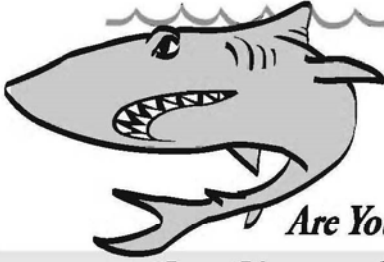
