Domestic Relations - Child Support - Income - Gestational Carrier Payments

Defendant father sought a decrease in his child support obligation, alleging that Plaintiff mother was making additional unreported income as a gestational carrier, which should be included in her monthly net income for the purpose of calculating his support obligation. Plaintiff mother did not consider payments received from the intended parents to be income because they are labeled as payments for "pain and suffering" under her Gestational Carrier Agreement and she will not be receiving a 1099 form from the intended parents.

- 1. Under the Domestic Relations Code and the Support Guidelines promulgated by the Pennsylvania Supreme Court, support is based primarily upon the parties' monthly net incomes or earning capacities. 23 Pa.C.S.A. § 4322(a); Pa.R.C.P. 1910.16-2. Monthly net income is derived from the parties' monthly gross income or earning capacity, less certain limited authorized deductions. Pa.R.C.P. 1910.16-2(c). See, Arbet v. Arbet, 863 A.2d 34, 40 (Pa. Super. 2004). The court must consider all forms of income when determining income available for support.
- 2. Tax definitions of income are not controlling with respect to defining income under the Domestic Relations Code. *Darby v. Darby*, 686 A2d 1346 (Pa. Super. 1996); *appeal denied*, 698 A.2d 594 (Pa. 1997); *Stamerro v. Stamerro*, 889 A.2d 1251, 1261 (Pa. Super. 2005). It is actual income and not taxable income which constitutes the basis for calculating support. *Flory v. Flory*, 364 Pa. Super. 67; 527 A.2d 155 (1987).
- 3. There is widespread agreement among legal commentators that compensation received by a woman for carrying and bearing a child is taxable income. See, Bridget J. Crawford, *Authentic Reproductive Regulation*, 96 Minn. L. Rev. Headnotes 31, 41 (2012).

OPINION

The issue before the court is whether under Pennsylvania support law, a \$40,000 payment due to Plaintiff mother for acting as a gestational carrier for an anonymous couple is income to her for the purpose of calculating Defendant father's child support obligation. The issue appears to be one of first impression in Pennsylvania. For the reasons set forth below, I find gestational carrier payments fall within the broad definition of "income" set forth under the Domestic Relations Code and the Support Guidelines.

Background

Mother and father are the parents of one child who will turn three years old this Fall. Mother has primary physical custody and in November 2016 she sought and obtained an order directing father pay her child support. That order was amended effective September 2017, under which terms father was directed to pay \$1,126 per month plus \$113 per month on arrears. On December 26, 2018, father filed a petition seeking a decrease in his child support obligation alleging that mother was making additional unreported income as a gestational carrier which should be included in her monthly net income for the purpose of calculating his support obligation. Following a conference with a domestic relations section officer, I issued orders dated February 21, 2019, as recommended by the conference officer, which directed that effective December 26, 2018, father pay \$540 per month plus \$54 on arrears and that effective January 21, 2019, he pay \$1,109 per month plus \$111 on arrears. In calculating support, the conference officer

assigned monthly net incomes of \$2,897 and \$2,817 to mother and father, respectively, which reflected their employment income. The conference officer did not include as income to mother any funds received as a gestational carrier because mother refused to verify she was receiving such monies. (N.T. 5/22/19 at 4-7) Father filed a request for *de novo* review and the hearing was held before me on May 22, 2019.

At the hearing, mother admitted she was a gestational carrier and provided a redacted copy of her Gestational Carrier Agreement (GCA). (Court Exbt. 1 (GCA)) Under the GCA, mother is identified as the "carrier" and the anonymous couple as the "intended parents." The intended parents agreed to pay mother \$1,000 for an embryo transplant, \$1,000 upon confirmation of pregnancy and \$4,750 per month for eight months during pregnancy until the full "\$40,000 total fee" is paid. (N.T. 7-8; GCA Exbt. D) Under the GCA "Reimbursement Schedule," the monies paid to mother are "[i]n consideration of the pain and suffering, personal discomfort and other personal inconveniences and costs to be incurred by CARRIER in performance of all the terms and obligations set forth in this AGREEMENT...." (GCA Exbt. D) The GCA also sets forth an exhaustive list of expenses mother may incur during the course of embryo transfer, pregnancy and delivery that must be paid by the intended parents. (GCA Sec. VII)

At the time of the hearing, mother was pregnant with the intended parents' embryo and had been receiving periodic payments from them under the GCA, although she had not yet received the full \$40,000. Mother testified she does not consider payments received from the intended parents to be income because they are labeled as payments for "pain and suffering." (N.T. 14) She further testified that she has been informed she will not be receiving a 1099 form from the intended parents showing the monies they paid her are income and she believes that as such she need not report any of the payments on her tax returns. (N.T. 13-14)

At the conclusion of the hearing, I took the matter under advisement and gave the parties the option of submitting legal citations and authority supporting their positions. Father thereafter provided the court with a packet of information he obtained from the internet generally stating that surrogacy fees are income. Mother did not provide any supplemental materials.

Legal Discussion

Under the Domestic Relations Code and the Support Guidelines promulgated by the Pennsylvania Supreme Court, support is based primarily upon the parties' monthly net incomes or earning capacities. 23 Pa.C.S.A. § 4322(a); Pa.R.C.P. 1910.16-2. Monthly net income is derived from the parties' monthly gross income or earning capacity, less certain limited authorized deductions. Pa.R.C.P. 1910.16-2(c). The definition of "income" that governs support matters is set forth in Section 4302 of the Domestic Relations Code and states as follows:

"Income." Includes compensation for services, including, but not limited to, wages, salaries, bonuses, fees, compensation in kind, commissions and similar items; income

¹ In determining support, the conference officer also considered that both mother and father had custody of two children each from other relationships and that father was living with his partner who earned a \$2,825 monthly net income. The large increase in support due under the order effective January 21, 2019 was attributable to a significant increase in the child's daycare expenses. (N.T. 4-7)

derived from business; gains derived from dealings in property; interest; rents; royalties; dividends; annuities; income from life insurance and endowment contracts; all forms of retirement; pensions; income from discharge of indebtedness; distributive share of partnership gross income; income in respect of a decedent; income from an interest in an estate or trust; military retirement benefits; railroad employment retirement benefits; social security benefits; temporary and permanent disability benefits; workers' compensation; unemployment compensation; other entitlements to money or lump sum awards, without regard to source, including lottery winnings; income tax refunds; insurance compensation or settlements; awards or verdicts; and any form of payment due to and collectible by an individual regardless of source.

23 Pa.C.S.A. §4302 (incorporated in the Support Guidelines at Pa.R.C.P. 1910.16-2(a)²). <u>See, Arbet v. Arbet,</u> 863 A.2d 34, 40 (Pa. Super. 2004) (citation omitted) (the court must consider all forms of income when determining income available for support).

While the question of whether money paid to a gestational carrier or surrogate is income under Pennsylvania law does not appear to have been addressed before by our appellate courts, the issue is easily resolvable through application of the clear and unambiguous language set forth in the Domestic Relations Code income definition. See 1 Pa.C.S.A. § 1903 (statutory interpretation requires that words and phrases be accorded

Rule 1910.16-2. Support Guidelines. Calculation of Monthly Net Income.

Generally, the support amount awarded is based on the parties' monthly net income.

- (a) Monthly Gross Income. Monthly gross income is ordinarily based on at least a six-month average of a party's income. The support law, 23 Pa.C.S. § 4302, defines the term "income" and includes income from any source. The statute lists many types of income including, but not limited to:
 - (1) wages, salaries, bonuses, fees, and commissions;
 - (2) net income from business or dealings in property;
 - (3) interest, rents, royalties, and dividends;
 - (4) pensions and all forms of retirement;
 - (5) income from an interest in an estate or trust;
 - (6) Social Security disability benefits, Social Security retirement benefits, temporary and permanent disability benefits, workers' compensation, and unemployment compensation;
 - (7) alimony if, in the trier-of-fact's discretion, inclusion of part or all of it is appropriate; and
 - (8) other entitlements to money or lump sum awards, without regard to source, including:
 - (i) lottery winnings;
 - (ii) income tax refunds;
 - (iii) insurance compensation or settlements;
 - (iv) awards and verdicts; and
 - (v) payments due to and collectible by an individual regardless of source.

Note: The trier-of-fact determines the most appropriate method for imputing lump-sum awards as income for purposes of establishing or modifying the party's support obligation. These awards may be annualized or averaged over a shorter or longer period depending on the case's circumstances. The trier-of-fact may order all or part of the lump sum award escrowed to secure the support obligation during that period.

² The Support Guidelines define "income" as follows:

their plain meaning). The monies paid to mother fall squarely under at least three parts of that definition including as (i) "compensation for services, including, but not limited to, ... fees," (ii) "other entitlements to money ... without regard to source," and (iii) "any form of payment due to and collectible by an individual regardless of source." 23 Pa.C.S.A. § 4302. The contract mother entered into with the intended parents specifically identifies the \$40,000 maximum payment available to mother to be a "fee," due to her as compensation for her services as a gestational carrier. It is also clearly an entitlement to money arising from a contract due to and collectible by mother under the terms thereof upon fulfillment of her contractual obligations.

The fact that the intended parents who pay the gestational carrier fees will purportedly not be filing a 1099 with the IRS (and providing a copy to mother), reflecting that they paid mother for her services, is certainly not determinative of whether the gestational carrier fees qualify as "income" under our Domestic Relations Code. The Superior Court has explicitly held that tax definitions of income are not controlling with respect to defining income under the Domestic Relations Code. <u>Darby v. Darby</u>, 686 A.2d 1346 (Pa. Super. 1996); <u>appeal denied</u>, 698 A.2d 594 (Pa. 1997); <u>Stamerro v. Stamerro</u>, 889 A.2d 1251, 1261 (Pa. Super. 2005).

In <u>Darby</u>, father argued that his lump sum award from settlement of a personal injury tort claim should not be included as income in determining his child support obligation under support law. He argued that the federal tax law excluded personal injury awards from treatment as income for federal tax purposes (citing 26 U.S.C.A. § 104(a)(2)). He similarly argued that Pennsylvania did not include damage awards within its definitions of classes of income for tax purposes (citing 72 P.S. § 7303). The Superior Court rejected his arguments stating:

We are not persuaded that the tax definitions of income are controlling with regard to defining income for purposes of support. Tax law contains many preferences and definitions for fiscal and other purposes which have no relationship to support. We specifically have held that taxable income is not the same as net income used to determine support obligations. See Flory v. Flory, 364 Pa.Super. 67, 527 A.2d 155 (1987) (it is actual income and not taxable income which constitutes the basis for calculating support). Moreover, the support law contains no reference to tax law. Accordingly, we reject appellant's assertion that federal or Pennsylvania tax treatment of personal injury awards is persuasive with respect to classifying money for support purposes.

Id. at 1348-1349.

Thus, even if the compensation paid to mother in this case could be considered as payment for her "pain and suffering, personal discomfort and other personal inconveniences" - which might arguably render the award excludable from federal or state taxation if paid as "damages" - such categorization is not relevant to determining income under the Domestic Relations Code. Id.

³ I note that a recent federal tax court decision, addressing an income issue similar to surrogacy fees, held that money paid to an egg donor was taxable under the Internal Revenue Code's gross income definition, rejecting the donor's argument that the fees paid to her were "damages" for her "pain and suffering," which would otherwise be excludable as gross income under the Code. See, Perez v. Comm'r of Internal Revenue, 144 T.C. 51 (2015). The holding in Perez is consistent with the nearly unanimous view amongst legal

At the time of the hearing, mother was still receiving gestational carrier fees from the intended parents and had not yet reached the maximum available fee of \$40,000. Therefore, the matter is remanded to the Dauphin County Domestic Relations Section to hold a conference verifying the final amount of payments received by mother for her gestational carrier services, less reasonable unreimbursed expenses and taxes owed. Since the final net gestational carrier income is in the nature of a one-time payment, this figure will be included only during the years received See Pa.R.C.P. 1910.16-2(a)(8)(Note).

Accordingly, I enter the following:

Nevertheless, there is no income tax law that would exclude from gross income amounts received for acting as a surrogate." (footnotes omitted)).
