The Judges have completed the SEPTEMBER 14, 2020 civil jury term. One civil case reached verdict and the summary is as follows:

D.A. NOLT, INC. v. OLD REPUBLIC INSURANCE CO., DENNIS MCDONNELL, and FORCON INTERNATIONAL-PA, LTD. (2017-CV-03583-CV)

<u>Verdict</u>: The jury found defendant Old Republic Insurance Co. (Old Republic) materially failed to perform its obligations under its Subcontract Performance Bond (Bond) entered with obligee Plaintiff D.A. Nolt (Nolt). The jury awarded Nolt \$345,921.53. By agreement, issues of interest and attorney's fees were reserved for post-trial motions.

**Background**: The matter arose out of a construction project (Project) for the Commonwealth of Pennsylvania involving the East Wing Plaza of the Capitol. General contractor Nolt entered into a Subcontract with Tilson to perform landscape work for \$492,815. In conjunction with the Subcontract, Nolt entered into the Bond with Old Republic which secured Tilson's performance "for failing to perform the Construction Work." The Bond defined "Construction Work" as "the providing of all labor and/or material necessary to complete Principal's scope of work under the Subcontract."

As part of the Subcontract, Tilson was required to provide regular maintenance for a one-year period after "substantial completion" of the Project, as determined by the Owner (the Commonwealth). Maintenance included the replacement of any landscaping work deemed unacceptable by the Owner during that time period. Tilson later ceased work and defaulted under the Subcontract on June 30, 2016, after having been paid all but \$56,942.71 thereunder.

After Tilson's default, Nolt tendered a claim under the Bond to Old Republic. Old Republic exercised its option to permit Nolt to complete the work and submit its costs to Old Republic, which could contest them for reasonableness.

Prior to Tilson's default, in December of 2015, the Owner's architect Vitetta had reviewed Tilson's work and determined that only a punch list of items remained to be completed, then valued at \$39,000. Later in April 2016, a warranty inspection indicated only minor landscaping items remained to be done by Tilson. In addition, on June 24, 2016, in response to Nolt's request, Vitetta certified that the Project was substantially complete on that date, thus commencing Tilson's one-year maintenance obligations.

After Tilson's default, Nolt performed some repairs and hired another landscaper to perform minor items. It later hired a second landscaper, Heritage, to complete Tilson's weed management obligations and remedy all items identified on the punch list, as well as Tilson's one-year maintenance obligation. The total cost of the Heritage subcontract was \$204,200. That subcontract did not include costs of items later incurred for replacing Tilson's plantings that failed during the maintenance period. Old Republic had claimed that the plant failings were the result of another contractor having improperly installed the irrigation system and were not the caused by Tilson and not recoverable under the Bond.

During the course of Heritage's completion of Tilson's work, Nolt made numerous requests to Old Republic for progress payments, as instructed and directed by its litigation consultant Forcon International. Old Republic failed to make payments. Instead, it took the position that Nolt would not be entitled to receive any amounts until the conclusion of the one-year maintenance period.

At trial, Nolt presented evidence that its cost to complete Tilson's Construction Work was \$402,514.24, less the unpaid balance of \$56,595.71 owed Tilson under the Subcontract, or total damages of \$345,921.53. Old Republic argued that the damages could not exceed \$39,000, the cost identified in the December 2015 punch list as then remaining to be completed by Tilson (i.e. when it reached substantial completion). Old Republic

also argued the damages improperly included charges for costs under the one-year maintenance contract as well as other charges that did not fall within the definition of "Construction Work."

The jury rejected Old Republic's arguments and in special interrogatories issued a verdict finding that Tilson breached its Subcontract with Nolt, the breach caused damages to Nolt, Nolt did not materially breach its Subcontract with Tilson, Nolt's claims were covered under the Bond, and Nolt did not fail to perform a condition precedent under the Bond. The jury awarded damages in the exact amount sought by Nolt, of \$345,921.53 (\$402,514.24 less \$56,595.71).

Pre-Trial Rulings: After the deadline for filing dispositive motions, Old Republic filed motions in limine that were in part, dispositive in nature and effect. Old Republic claimed a one-year Bond limitations period – requiring that any claims under the Bond be filed within one year of substantial completion - precluded Nolt's claims. The Court denied this motion on the merits as it rejected Old Republic's interpretations of the date when Subcontract work was substantially completed, accepting the Owner's architect's date of the entire Project. The Court also suggested that limine motion, seeking dispositive relief, was improper as it was filed too late

The Court additionally denied Old Republic's motion asserting that the Bond capped Nolt's recovery to the punch list items (\$39,000) finding that the scope of "Construction Work" incorporated Subcontract language that encompassed charges beyond such items. The Court also denied Old Republic's motion to preclude evidence of management fees sought by Nolt finding that they too were recoverable as the Bond incorporated Tilson's obligations under the Subcontract, encompassing such fees. The Court reserved for post-trial motions whether Nolt's claims for interest and attorney's fees were covered under the Bond. Finally, the Court granted Old Republic's motion to preclude introduction of evidence regarding offers to compromise and Nolt's motion to preclude expert testimony from Old Republic's litigation consultant, an employee of Forcon International, because he had not been previously identified as an expert.
