#### DAUPHIN COUNTY REPORTS Yost v. PennDOT, Bureau of Driver Licensing

Where the duty of good faith is breached, the breach is generally considered to be an abuse of discretion. <u>Abarbanel</u> at 865; <u>Highway Materials, Inc. v. Board of Supervisors of Whitemarsh Township</u>, 974 A.2d 539 (Pa. Commw. 2009). The remedy for the breach of good faith is generally either to reverse the denial of approval and allow the plan to go forward, or to reverse and remand with a direction that the municipality undertake a good faith review. <u>Kohr v. Lower Windsor Twp. Bd. of Sup'rs</u>, 910 A.2d 152, 161 (Pa. Commw. 2006) (affirming reversal with no remand) <u>Highway Materials, Inc. v. Bd. of Supervisors of Whitemarsh Twp.</u>, 974 A.2d 539, 545 (Pa. Commw. 2009) (reversing with remand). In this instance, it is appropriate for the matter to be remanded for the Supervisors to properly exercise their duty of good faith by granting Bears Creek II the opportunity to respond to the proposed Development Plan waiver denial as well as the need to provide a structural engineer's report in support of its Design Plan.

Accordingly, this Court enters a separate Order granting Bears Creek II's appeals and remanding the matter to the Supervisors to conduct a good faith review of the plans consistent with this Memorandum Opinion.

#### **ORDER**

AND NOW, this <u>15<sup>th</sup></u> day of January, 2020, upon consideration of the appeals filed by Bears Creek II from the denials by the Board of Supervisors of Derry Township of its Development Plan (No. 2019-CV-01344-LU) and Design Plan (No. 2019-CV-01345-LU), it is hereby directed that the appeals are **GRANTED** for the reasons set forth in this Court's Memorandum Opinion. The matter is **REMANDED** to the Board of Supervisors for it to conduct a good faith review of the plans, consistent with this Opinion.

#### Yost v. PennDOT, Bureau of Driver Licensing

#### Motor Vehicles - Driver's License Suspension Appeal

After pleading guilty to Simple Possession of Marijuana, the Petitioner was notified by the Pennsylvania Department of Transportation, Bureau of Driver Licensing, that his driver's license would be suspended for one year, pursuant to Section 1532(c) of the Pennsylvania Vehicle Code, 75 Pa.C.S. § 1532. An amended version of 75 Pa.C.S. § 1532, which took effect during the pendency of this appeal, removed the provision which mandated a license suspension for individuals convicted of possession of a controlled substance.

1. In order to sustain a statutory driver's license suspension that was imposed due to a motorist's criminal conviction, PennDOT must establish that: (1) the licensee was convicted in criminal court; and (2) PennDOT acted in accordance with applicable law. *Rawson v. Dep't of Transp., Bureau of Driver Licensing*, 99 A.3d 143, 147 (Pa. Commw. Ct. 2014).

2. Pennsylvania's Statutory Construction Act ("SCA") provides that no statute shall be construed to be retroactive unless clearly and manifestly so intended by the General Assembly. *1 Pa.C.S.A. §1926*. Our courts have repeatedly interpreted this provision as creating a strong presumption of prospective statutory application only, absent clear language to the contrary. *Johnson v. Phelan Hallinan & Schmieg, LLP*, 202

A.3d 730, 737 (Pa. Super. Ct. 2019. This presumption against retroactive application likewise applies to amendments to existing statutes. Amendatory statutes, in particular, are to be construed as retroactive only where such a construction is so clear as to preclude all questions as to the intent of the General Assembly. *Keystone Coal Min. Corp. v. W.C.A.B. (Wolfe)*, 673 A.2d 418, 420 (Pa. Commw. Ct. 1996).

#### TRIAL COURT MEMORANDUM OPINION AND ORDER

Currently before this Court is Petitioner Justis Tyler Yost's ("Petitioner") challenge to the decision of the Pennsylvania Department of Transportation, Bureau of Driver Licensing ("PennDOT") to suspend his driver's license for one (1) year pursuant to Section 1532(c) of the Pennsylvania Vehicle Code, 75 Pa.C.S. § 1532(c) (*statutory version effective May 9, 2005 to April 21, 2019*). For the reasons set forth below, we **REINSTATE** the suspension of Petitioner's license and **DISMISS** his appeal.

#### I. Factual Background and Procedural History.

The procedural history and pertinent factual background of this matter are uncontested; and therefore, we are called upon to address matters of law, specifically ones of statutory construction and application. On September 28, 2018, the Swatara Township Police Department arrested Petitioner for Possession with Intent to Deliver a Controlled Substance (specifically, marijuana). Thereafter, on November 28, 2018, Petitioner appeared before Magisterial District Judge Michael J. Smith and pled guilty to an amended charge of one count of Simple Possession of Marijuana.

On or about February 21, 2019, PennDOT mailed a letter to Petitioner, notifying him that due to the aforementioned conviction for Simple Possession of Marijuana, he would be subjected to a one (1)-year driver's license suspension pursuant to 75 Pa.C.S.A. § 1532. On March 21, 2019, Petitioner, through counsel, filed in this Court a timely appeal of his license suspension. On March 27, 2019, we issued an Order scheduling a License Suspension Appeal Hearing in this matter and ordering that the impending suspension of Petitioner's driver's license be stayed pending this Court's final decision in this matter. On May 30, 2019, the parties, each represented by counsel, appeared before the undersigned for a License Suspension Hearing ("the Hearing"). As the facts in this matter are uncontested, the parties offered no witness testimony. However, at the conclusion of the short Hearing, this Court afforded each party an opportunity to submit a

Post-Hearing Brief regarding the legal issues presented in this matter. The parties' Briefs have been submitted, and Petitioner's License Suspension Appeal is ripe for disposition.

#### II. Discussion.

As stated above, Petitioner's impending license suspension is based upon Section 1532 of the Pennsylvania Motor Vehicle Code, 75 Pa.C.S.A. § 1532. The dispute in the instant matter arises out of a recent amendment to Section 1532 that **went into law** on April 22, 2019. As it is pivotal to the legal issues presented in the instant matter, we will now proceed to discuss the procedural history of the statute and its recent amendment in further detail.

Prior to April 22, 2019, the immediately preceding version of 75 Pa.C.S.A. § 1532, which had been in effect since May 9, 2005 (hereinafter "2005 version" or "prior version"), contained a provision that imposed upon PennDOT a mandatory duty to suspend the driving privileges of a motorist who was convicted of various drug offenses, including Possession of a Controlled Substance. Specifically, the 2005 version of the statute read, in relevant part, as follows:

The Department *shall* suspend the operating privilege of any person upon receiving a certified record of the person's conviction of any offense involving the possession, sale, delivery, offering for sale, holding for sale or giving away of any controlled substance under the laws of the United States, this Commonwealth or any other state ....

75 Pa.C.S.A. § 1532(c) (version effective May 9, 2005 to April 21, 2019) (emphasis supplied). The duration of an individual's license suspension was contingent upon whether the underlying controlled-substance offense was a first offense (six-month suspension), second offense (one-year suspension), or third and subsequent offense (two-year suspension).

Recently, however, the Pennsylvania General Assembly passed an amended version of 75 Pa.C.S.A. § 1532 (hereinafter "*current version*" or "*amended version*"), which was signed by the Governor on October 24, 2018. The *current version* of 75 Pa.C.S.A. § 1532, which statutorily went into effect on April 22, 2019 (180 days after the Governor signed the statute into law), removed the provision which mandated a license suspension for individuals convicted of possession of a controlled substance.

The parties here dispute which version of Section 1532 should apply when considering the timeline of pertinent events surrounding the instant appeal. Petitioner pled guilty to Simple Possession of Marijuana on November 28, 2018. At that time, the *current version* of Section 1532 had been signed into law by the Governor, but said *amended version* of the statute was not set to officially take effect until April 22, 2019. Thus, Petitioner's criminal conduct and conviction for same occurred **before** the *current version* 

of Section 1532 officially took effect. Since the law in effect at the time of Petitioner's conviction (i.e., the 2005 version of Section 1532) mandated the imposition of a license suspension, PennDOT contends that if this Court ruled in Petitioner's favor and ordered that PennDOT rescind the license suspension, such action would in essence undermine PennDOT's duty to comport with the 2005 version of law as it was in effect at time of Petitioner's conviction. On the other hand, Petitioner argues that because the *current version* of Section 1532 officially took effect during the pendency of the instant **civil** appeal, it is now binding on the parties and constitutes the law of the present case. Petitioner, therefore, asserts that since the *current version* no longer authorizes license suspensions for offenses relating to possession of a controlled substance, his impending license suspension arising out of such a possession-related offense must be reversed. For the reasons set forth below, we agree with PennDOT; and, therefore, Petitioner's license suspension will be reinstated.

In order to sustain a statutory driver's license suspension that was imposed due to a motorist's criminal conviction, PennDOT must establish that: (1) the licensee was convicted in criminal court; and (2) PennDOT acted in accordance with applicable law. <u>Rawson v. Dep't of Transp.</u>, <u>Bureau of Driver Licensing</u>, 99 A.3d 143, 147 (Pa. Commw. Ct. 2014). In the instant matter, it is undisputed that Petitioner was convicted in criminal court, as he pled guilty to Simple Possession of Marijuana on November 28, 2018. It is also undisputed that at the time of said conviction, the *current version* of Section 1532 had not yet taken effect, and the *2005 version* of the statute was still in effect. Therefore, PennDOT acted in accordance with applicable law when it imposed Petitioner's driver's license suspension pursuant to the *2005 version* of Section 1532. Consequently, PennDOT has met its burden to sustain Petitioner's driver's license appeal. Despite the foregoing, Petitioner contends that his license suspension should be overturned because even though the *2005 version* of Section 1532 took effect during the pendency of the instant appeal of his suspension. We are not persuaded by Petitioner's argument.

Pennsylvania's Statutory Construction Act ("SCA") provides that "[n]o statute shall be construed to be retroactive unless clearly and manifestly so intended by the General Assembly." 1 Pa.C.S.A. §1926. "Our courts have repeatedly interpreted this provision as creating a strong presumption of prospective statutory application only, absent clear language to the contrary." <u>Johnson v. Phelan Hallinan & Schmieg,</u> <u>LLP</u>, 202 A.3d 730, 737 (Pa. Super. Ct. 2019) (citing <u>Brangs v. Brangs</u>, 595 A.2d 115, 119 (Pa. 1991)). This presumption against retroactive application likewise applies to amendments to existing statutes. Specifically, with regard to statutory amendments, the SCA provides that "the portions of the statute which were not

altered by the amendment shall be construed as effective from the time of their original enactment, and *the new provisions shall be construed as effective only from the date when the amendment <u>became effective</u>." 1 Pa.C.S.A. § 1953 (emphasis supplied). Therefore, "without express legislative intent that [a statutory] amendment should apply retroactively, section 1953 requires that we construe the amendment as taking effect on the date selected by the General Assembly.*" Johnson, 202 A.3d at 737; <u>see also Keystone Coal Min.</u> <u>Corp. v. W.C.A.B. (Wolfe)</u>, 673 A.2d 418, 420 (Pa. Commw. Ct. 1996) ("Amendatory statutes, in particular, are to be construed as retroactive only where such a construction is so clear as to preclude all questions as to the intent of the General Assembly.").

While there is a strong presumption against retroactive statutory application, a statute or statutory amendment may be retroactively applied where it is merely procedural and does not alter any substantive rights. Keystone Coal, 673 A.2d at 421 (citing Page's Dep't Store v. Velardi, 346 A.2d 556 (Pa. 1975)) (emphasis supplied). "A substantive right is implicated when the retroactive application of a statute imposes new legal burdens on past transactions or occurrences." Id. (citing McMahon v. McMahon, 612 A.2d 1360 (Pa. Super. Ct. 1992)) (Emphasis supplied). Procedural statutes, on the other hand, "establish the method for enforcing a right, but have no bearing on whether a claimant has a legal entitlement to relief under the facts as they exist in a particular case." Id. (emphasis supplied). "Legislation concerning purely procedural matters will be applied not only to litigation commenced after its passage, but also to litigation existing at the time of its passage." Morabito's Auto Sales, Inc. v. Com. Dep't of Transp., 715 A.2d 384, 386 (Pa. 1998).

At issue in the instant matter is an amendment to an existing statute, namely, the recent amendment to 75 Pa.C.S.A. § 1532 that removed the specific provision of said statute which mandated a license suspension for individuals convicted of possession of a controlled substance. Clearly, retroactive application of the *amended version* of Section 1532 implicates a substantive right seeing as the amended statute would impose a new legal burden on a past occurrence. Specifically, at the time of Defendant's Simple Possession conviction on November 28, 2018, PennDOT had a mandated legal duty, per the theneffective 2005 version of Section 1532, to impose a suspension on Petitioner's driving privileges. PennDOT comported with this legal duty by imposing the suspension that gave rise to the instant appeal. To retroactively apply the *amended version* of Section 1532 to the instant matter would eliminate PennDOT's legal burden to impose such a suspension, and, in fact, would appear to foreclose PennDOT from imposing such a suspension. Therefore, inasmuch as substantive rights are clearly implicated by the *amended version*

of Section 1532, said statute cannot be applied retroactively absent manifest and clear intent by the General Assembly. No such clear intent is present in the instant matter, as there is no language whatsoever in the *amended version* of Section 1532 to suggest that said amendatory statute shall apply retroactively.

While statutes and statutory amendments generally cannot be applied retroactively, the courts of this Commonwealth have held to the contrary with regard to the retroactive application of changes to decisional or case law. Specifically, the courts have noted that it is a "well-settled principle" that "changes in decisional law that occur during litigation will be applied retroactively to cases pending on appeal." <u>Merkel v. W.C.A.B. (Hoffman Indus.)</u>, 918 A.2d 190, 193 (Pa. Commw. Ct. 2007); <u>see also Christy v.</u> <u>Cranberry Volunteer Ambulance Corps, Inc.</u>, 856 A.2d 43, 51 (Pa. 2004) ("[O]ur general principle is that we apply decisions involving changes of law in civil cases retroactively to cases pending on appeal.").

In support of his position that the recent amendment to 75 Pa.C.S.A. § 1532 should apply retroactively to the instant case, Petitioner cites to the line of Pennsylvania case law which holds that changes in decisional law are generally applicable to litigation that is pending at the time of the pertinent decision. The infirmity for Petitioner in relying on these cases lies in the fact that the change in law that is pertinent to this case is not a change in **decisional** law, but instead is a change in **statutory** law. Moreover, our research on this issue does not appear to yield any decisional law upon which Petitioner could rely to buttress his position in this case. During the pendency of this appeal, the Courts of our Commonwealth have not delivered any decisional law pertaining to any version of Section 1532 that would positively impact Petitioner's case in any way. Likewise, our Courts have not held the *current version* of Section 1532 to apply retroactively, nor have they deemed the 2005 version of Section 1532 to be unconstitutional or unlawful in any way.

Because there is no decisional law to support Petitioner's position in the instant matter, he has, in essence, recast his argument to suggest that the plethora of our Appellate Courts' prior rulings pertaining to the applicability of *decisional* law to pending civil appeals should be **judicially extended** to hold that any changes in *statutory* law should also apply retroactively to pending civil appeals. We believe, however, that such expanded judicial holding would usurp the Constitutional prerogative of our General Assembly to determine whether its statutes should apply retroactively and undermine our Commonwealth's established body of case law which has consistently dictated that statutes shall not apply retroactively unless explicitly stated in the statute or unless there is a savings clause contained within said statute providing for such retroactivity. Therefore, we decline to apply the *amended version* of Section 1532 retroactively to the instant case, inasmuch as the *2005 version* of Section 1532 was still in effect at the time that PennDOT imposed Petitioner's instant license suspension. While we may empathetically appreciate the plight of the Petitioner

in this case, based upon an interim change in the law, we are not cajoled by that appreciation to allow his self-inflicted situation to affect the rule of law.

#### III. Conclusion.

In conclusion, we find that the *amended version* of 75 Pa.C.S.A. § 1532, which took effect during the pendency of the instant License Suspension Appeal, shall not apply retroactively to this case since the *prior version* of Section 1532 was in effect at both the time of Petitioner's actual drug-possession conviction and the mandated administrative action of PennDOT when it suspended his operating privileges. Therefore, this Court **DISMISSES** Petitioner's appeal of PennDOT's suspension of his operating privileges, and **REINSTATES** said suspension.
