declares the ruling to be prospective only, the new rule is to be applied retroactively to cases where the issue in question is properly preserved at all stages of adjudication up to and including any direct appeal.

Cabeza, 469 A.2d at 148.

We find the holding of Cabeza to be controlling in this matter. Since the Alexander court did not specifically declare the ruling to be prospective only, the new rule announced in Alexander shall apply retroactively to all cases where the issue has been properly preserved. As this matter is currently pending disposition at the trial level, and Defendant has filed an omnibus pretrial motion raising Alexander, we find that the issue has been properly preserved. Therefore, Alexander applies retroactively in this case and we must determine whether the warrantless search of Defendant's vehicle was justified by probable cause and exigent circumstances.

The Commonwealth concedes that there were no exigent circumstances present in this case. Although this Court finds that suppression seems to be a severe remedy when police diligently follow previously established law, we are nevertheless constrained to find that the Commonwealth has failed to meet its burden to prove that the warrantless search of Defendant's vehicle was constitutional. Accordingly, all evidence obtained as a result of the warrantless search of Defendant's vehicle must be suppressed as the fruit of the poisonous tree.

Therefore, we enter the following Order:

#### **ORDER**

**AND NOW**, this 6<sup>th</sup> day of April, 2021, in accordance with the foregoing Memorandum Opinion, **IT IS HEREBY ORDERED** that Defendant's Omnibus Pretrial Motion to Suppress is **GRANTED** and all evidence obtained as a result of the warrantless search of Defendant's vehicle shall be **SUPPRESSED**.

**Commonwealth v. Box**

#### **Crimes and Criminal Procedure – Sentencing – Compassionate Release**

Defendant filed an Emergency Petition for Release Pursuant to 42 Pa.C.S.A. § 9777 (transfer of inmates in need of medical treatment).

1. Defendant has Stage IV colon cancer with metastatic spread and has been given less than six (6) months to live. He sought compassionate release to hospice care pursuant to 42 Pa.C.S.A. § 9777.
2. A sentencing court may approve a request for compassionate release if Defendant proves all of the following factors by clear and convincing evidence: (1) the inmate is terminally ill, not ambulatory and

likely to die in the near future; (2) the licensed hospice care provider can provide the inmate with more appropriate care; (3) appropriate medical care and palliative and supportive services will be provided by the licensed hospice care provider at the proposed hospice care location; (4) the placement of the inmate does not pose an undue risk of escape or danger to the community; (5) the licensed hospice care provider has agreed to notify the department and court of any material changes in the health of the inmate; and (6) each agency representing the Commonwealth, as well as any registered crime victims, are given an opportunity to be heard.

3. Defendant failed to show by clear and convincing evidence that he would receive more appropriate care by a licensed hospice provider as opposed to the medical facility at SCI-Phoenix where he currently is housed.

#### MEMORANDUM OPINION

Presently before this Court is the Emergency Petition of Earl Eugene Box to be Released Pursuant to 42 Pa.C.S.A. § 9777, as well as the Commonwealth's response thereto. A hearing was held before this Court on April 9, 2021, and the matter is now ripe for decision.

In September of 1975, Defendant was convicted by a jury of second-degree murder and two (2) counts of robbery. He was sentenced to life on the second-degree murder conviction with consecutive sentences of ten (10) to twenty (20) years in prison for each of the robbery convictions. Defendant's judgment of sentence was affirmed by the Supreme Court of Pennsylvania on October 27, 1978<sup>1</sup>, and he did not seek review from the Supreme Court of the United States.

On March 9, 2021, Defendant filed an Emergency Petition for Release pursuant to 42 Pa.C.S.A. § 9777 based upon his diagnosis of Stage IV colon cancer and his prognosis for treatment. The Commonwealth filed an Answer on March 22, 2021. A hearing was held before this Court on April 9, 2021, wherein we heard testimony from Dr. Stephen Wiener (physician at SCI-Phoenix), Michele Vargo (director of Aseracare Hospice), and Emma Stewart (Defendant's daughter). Additionally, several family and friends of the victim were provided an opportunity to address the court and state their opposition to Defendant's release.

Since the trial and sentencing were conducted by the late Honorable Richard B. Wickersham, we will briefly state the facts as forth in Judge Wickersham's Opinion denying Defendant's post-sentence motions:

The events leading to these Motions began on the evening of Friday, September 13, 1974, when three armed men burst into Mueller's Tavern in Steelton. As the robbers ordered the frightened customers on the floor, Anne Benkovich, a cousin of Mrs. Helen Mueller, tending bar at the time, fled for safety through the kitchen and onto the staircase leading to the second-floor living quarters of the Mueller family. When Miss Benkovich was halfway up the staircase, she observed one of the masked intruders in hot pursuit. She screamed, fainted, and fell to the bottom of the stairs.

This commotion attracted the attention of John Benedict Mueller, III, the 20-year-old son of the proprietor of the tavern. Wearing only his undershorts, he wandered out to the top of the stairs to investigate the disturbance. Now at the bottom of the stairwell, the intruder aimed his .32 caliber revolver at the un-clad youngster, and shot him through the heart.

The murderer returned to the bar area, where he and his two compatriots completed emptying the cash register and the pockets of the patrons. The three men then fled, and were observed by a witness in an adjacent building as they ran towards a moving car operated by a fourth participant. The gang then sped off into the early morning darkness.

The modus operandi of this robbery followed a pattern similar to a series of robberies committed in Dauphin County taprooms during September of 1974. [fn1] Police investigations culminated in the arrest of one Frank Martin. Martin outlined to the police details of his participation in a conspiracy initiated by two recent arrivals in Harrisburg, Donald Massey and our Defendant, Earl Box. Others named by Martin were Jerome Brown, John Hyman, Reginald Charles Scott, and Leroy Willie Smith. All were arrested for murder and robbery. Earl Box was finally apprehended in Boston, Massachusetts by agents of the Federal Bureau of Investigation, returned to Pennsylvania, and brought to trial.

[fn1] These all occurred in the City of Harrisburg. On Wednesday, September 4, the gang held up John's Bar; on Friday, September 6, Abe's Tavern; Wednesday, September 11, Collins Café; Wednesday, September 18, the Parkside Café; and on Saturday, September 21, The Fireplace Bar. The last robbery resulted in a second criminal homicide when a patron, Paul Leibold, was shot and killed as he lay on the barroom floor.

At trial, testimony by Frank Martin, John Hyman, and Donald Massey identified Earl Box as the individual robber who wielded the handgun. With the aid of this, and corroborative evidence, the jury found Earl Box to be guilty of the robbery of Mueller's Tavern, and the murder of John Benedict Mueller III.

(Trial Court Opinion, December 14, 1976).

With this background, we turn to the statutory authority for which Defendant relies upon for his request for release:

The sentencing court may approve the petitioner's request to temporarily defer service of the sentence of confinement in order for the inmate to receive care from a licensed hospice care provider, proposed by the petitioner and subject to electronic monitoring by the department, if all of the following are established by clear and convincing proof:

- (i) The inmate is terminally ill, not ambulatory and likely to die in the near future.
- (ii) The licensed hospice care provider can provide the inmate with more appropriate care.
- (iii) Appropriate medical care and palliative and supportive services will be provided by the licensed hospice care provider at the proposed hospice care location.
- (iv) The placement of the inmate in the proposed, licensed hospice care location does not pose an undue risk of escape or danger to the community. In making this determination, the sentencing court shall consider the inmate's institutional conduct record, whether the inmate was ever convicted of a crime of violence, the length of time that the inmate has been imprisoned and any other factors the sentencing court deems relevant.
- (v) The licensed hospice care provider has agreed to notify the department and the sentencing court of any material changes in the health status of the inmate, the nature of the hospice care provided or other information required by the department or the sentencing court.
- (vi) Each agency representing the Commonwealth at a proceeding which resulting in an order committing or detaining the inmate, the State or local correctional facility housing the inmate and any registered crime victim have been given notice and an opportunity to be heard on the petition.

**Factor 1**

Defendant is currently housed at SCI – Phoenix. At the hearing, Dr. Wiener testified that Defendant is diagnosed with Stage IV colon cancer with metastatic spread. After being diagnosed, Defendant underwent an ileostomy and then placed on palliative care. Defendant is currently being treated as a hospice patient and resides in a special isolation room in the infirmary due to his level of care. He is currently prescribed long-acting morphine two (2) to three (3) times a day, as well as oxycodone for breakthrough pain. Dr. Wiener testified that the combination of medications being provided are strong enough that Defendant is fairly comfortable. He further testified that Defendant is terminally ill and probably has six (6) months or less to live.

**Factor 2**

The infirmary inside SCI – Phoenix is not a licensed hospice care provider. However, Dr. Wiener testified that he provides hospice care treatment inside the correctional facility. The infirmary at SCI – Phoenix is the Commonwealth’s most modern facility and can hold up to twenty-four (24) inmates at a time. Dr. Wiener testified that there are typically twelve (12) inmates in the infirmary at any given time. Defendant has been housed inside the infirmary since his diagnosis approximately six (6) months ago. During the day, inmate workers care for Defendant until 5:00 P.M. At night, there are two (2) registered nurses available, but no doctors.

**Factor 3**

Ms. Vargo testified that AseraCare is a licensed hospice provider based in Allentown, Pennsylvania and services seven (7) counties. Their goal is to keep a patient in their home as long as possible, hopefully until the end. When someone is placed in a relative’s home, the level of care is dependent upon what the patient requires. If necessary, a nurse could be present in the home seven (7) days a week and home health aides provide services Monday through Friday. A doctor is available twenty-four (24) hours a day, seven (7) days a week. After hours calls are answered by triage, who are all registered nurses, who can provide guidance over the phone and if a visit is necessary, will contact the on-call hospice nurse.

Defendant’s daughter, Ms. Stewart, is an outpatient mental health therapist who resides in a single family, four (4) bedroom home with her husband in Berks County. Ms. Stewart testified that she would supervise Defendant if he were placed in her home for hospice care. Defendant would reside on the second (2<sup>nd</sup>) floor of her home and she would cooperate with AseraCare. She further testified that she is unable to visit Defendant at SCI – Phoenix due to the current COVID-19 restrictions. If Defendant were

placed in her home, then Defendant's sister, nieces, nephews, and grandchildren would be permitted to visit and say their final goodbyes.

**Factor 4**

Dr. Wiener testified that Defendant has been wheelchair and bed bound for a while and workers will occasionally try and assist him in walking to the toilet. When visiting with Defendant, Dr. Wiener testified that he is usually alert and oriented. Dr. Wiener does not believe Defendant would pose a danger to the community because he has continually lost weight and muscle atrophy. Defendant's mobility has declined over time and his frailty will continue to worsen.

There is no dispute that Defendant was convicted of a crime of violence. He was convicted of murder, as well as robbery, and has been incarcerated for approximately forty-six (46) years. Further, Defendant's institutional conduct record shows that he has thirteen (13) misconducts, the most recent occurred in June of 2019. *See* Commonwealth's Exhibit 1.

**Factor 5**

Both Ms. Vargo and Ms. Stewart testified that they would notify the Department of Corrections, as well as this Court, of any change in Defendant's medical status. Ms. Vargo further testified if Defendant decided to opt for aggressive treatment, then he would no longer be eligible for hospice care. Additionally, Ms. Stewart testified that she works from home and would supervise Defendant.

**Factor 6**

Each Commonwealth agency, a representative from SCI – Phoenix, and all registered crime victims were provided an opportunity to be heard.

**DISCUSSION**

The current provisions of 42 Pa.C.S.A. § 9777(a)(2) became effective on October 13, 2009, and there is virtually no caselaw to assist a court in evaluating these statutory provisions. Nevertheless, the statutory language establishes that a petitioner *may* be released to an appropriate licensed hospice provider if all the criteria are proven by clear and convincing evidence.

This Court is fully satisfied that the provisions of Subsections (a)(2)(i)(iii), (iv), and (v) have been proven by clear and convincing evidence. The provisions of Subsection (a)(2)(ii) is more problematic: “The licensed hospice care provider can provide the inmate with **more appropriate** care.” (emphasis added). Not one of the witnesses testified that AseraCare can provide “more appropriate” care. Instead, the testimony



established that the care would be comparable. Further, Petitioner emphasized that the prison facility is not “licensed” as a hospice facility; however, licensing at a state prison facility would not be necessary to provide appropriate palliative and hospice care to an inmate.

To the contrary, it would appear that SCI – Phoenix, which is the Department of Corrections’ most modern facility, has the ability to provide superior palliative and hospice care in that there are a minimum of two (2) registered nurses on site at all times, and the infirmary operates with inmate numbers at approximately 50% of its designated capacity. Also, the medical records admitted as Petitioner’s Exhibit 3 reflect that on February 17, 2021, the inmate was informed “that our hospice workers are fantastic and he will be kept as comfortable as possible...” See Petitioner’s Exhibit 3. The fact that this Court is impressed with the information indicating that the infirmary at SCI – Phoenix appears to be at least equal, if not superior, to the proposed licensed hospice care provider, demonstrates that Subsection (a)(2)(ii) has not been proven by clear and convincing evidence.

Assuming for purposes of argument that Petitioner had met his burden, the decision to release would be discretionary with the court – compassionate release is more a privilege than a right. Accordingly, this Court cannot ignore the sentencing Order of the late Judge Wickersham. At sentencing, Judge Wickersham, who presided over the entire trial, stated:

Earl Eugene Box, in the late evening of Friday, September 13, 1974, John Benedict Mueller, III, age twenty-one, clad only in shorts, was shot through the heart at his residence above Mueller’s Tavern in Steelton, Pennsylvania. The victim was unarmed and died within minutes. The killing occurred during the course of a robbery of the tavern below the Mueller’s residence. Under the evidence submitted at your trial you participated in that robbery and under the evidence submitted at trial, accepted by the jury, you were the person who fired the fatal shot that killed John Benedict Mueller, III.

(Notes of Testimony, Sentencing 4/19/1977 (“N.T. Sentencing”), at p. 4).

Thereafter, Judge Wickersham proceeded to sentence Petitioner to life imprisonment on the murder charge, followed by two (2) consecutive maximum sentences of ten (10) to twenty (20) years on each count of robbery. It is clear that Judge Wickersham’s intention was that Petitioner spend his entire lifetime in prison.

Interestingly, Petitioner, at his sentencing, claimed a health issue (“... I have half a stomach, right, and my people, they live sixty-four miles from the Correctional Institution at Pittsburgh....” (N.T. Sentencing at p. 7)) in an attempt to gain control of where he would be housed. Even at the beginning of his sentence, Petitioner had attempted to use his health to his personal advantage. Similarly, during our hearing,

counsel for Petitioner conceded that this inmate wanted counsel to file a petition for release as soon as he was diagnosed with cancer almost a year ago.

Of significant concern to this Court is the victimology component. It is clear that the victim's family has not been able to heal from this horrendous crime. The testimony revealed that the entire family was traumatized by witnessing the shooting of their 21-year-old family member, as he walked down the interior stairs from his home above to the family tavern.

From their perspective, Defendant has never taken any responsibility for the crime, or expressed any compassion for the victim or his family. Not only had he filed a direct appeal, but he had pursued at least seven (7) collateral appeals prior to his present petition. Each action had apparently had a negative impact on the victim's family. Although he has an absolute right to pursue appeals, this Court cannot help but to see how such actions have continued to affect the victim's family. It is clear that they will never have closure until Defendant takes his last breath, and they clearly want that last breath to occur in prison.

On the other hand, this Court is also cognizant of the desires of Petitioner's family – a daughter, grandchildren, and other members who would like to take care of him in his last days and say their last goodbyes. After reviewing the medical records and his prognosis, this Court is concerned with the burden that his medical condition will place upon them – especially in light of the difficulties that he has been experiencing with the complications of his ileostomy bag. The prison infirmary appears to be in a better position to address Defendant's medical care needs. Hopefully, the prison will be able to make appropriate arrangements for his family to have contact with him, at least virtually, if not in person.

Accordingly, we enter the following Order:

### **ORDER**

**AND NOW**, this 16<sup>th</sup> day of April, 2021, in accordance with the foregoing Memorandum Opinion, **IT IS HEREBY ORDERED** that Defendant's Emergency Petition for Release is **DENIED**. This Court strongly encourages SCI – Phoenix to make appropriate arrangements for Defendant's family to have contact with him at least virtually, if not in person.
