**EIGHTH SUPPLEMENTAL ADMINISTRATIVE ORDER AND SEVENTH EMERGENCY  
DECLARATION**

AND NOW, THIS 20<sup>th</sup> day of May, 2021, the Eighth Supplemental Administrative

Order and Seventh Emergency Declaration is as follows:

**EMERGENCY DECLARATION**

1. Due to the COVID-19 pandemic and concern for the public health and safety, the judicial emergency is extended in the Twelfth Judicial District through **August 31, 2021**.

**MASKS**

2. The Court will continue to follow the latest CDC guidance.
  - a. **Court Employees:** Masks are not required for employees who are **fully** vaccinated. People are considered fully vaccinated two (2) weeks after they have received the second dose in a 2-dose series (Pfizer or Moderna), or two (2) weeks after they have received a single-dose vaccine (Johnson and Johnson). **Masks are required for all unvaccinated Court Employees until further notice. Vaccinated Court Employees may still wear masks based on their comfort level.** In accordance with the recommendation of the Administrative Office of Pennsylvania Courts, **vaccinated Court employees** who do not wish to wear a mask shall provide the Deputy Court Administrator-HR (Jennifer Simpson) with a copy of their vaccination card to keep in a confidential file.
  - b. **Jurors:** All jurors reporting for jury selection shall continue to wear masks in the Jury Assembly Room and in all areas required by the Jury Administrator. However, once the jurors report to a courtroom for trial, the requirement of masks is within the discretion of the presiding judge.
  - c. **Court Users:** Masks are not required for entry into a court facility including but not limited to the Dauphin County Courthouse, Human Services Building 7<sup>th</sup> and 8<sup>th</sup> floors, Children & Youth Services, Schaffner Youth Center, Magisterial District Judge Offices, and Probation Services if individuals are **fully vaccinated**. #### **IN-PERSON PROCEEDINGS (COMMON PLEAS)**


3. **Beginning June 1, 2021**, proceedings shall be in-person **unless** otherwise directed by the presiding judge, hearing officer, arbitration chair, or master that the proceeding will be conducted by advanced communication technology (ACT) (video or telephone). Counsel and parties may request that the proceedings be held using ACT, but this decision is within the discretion of the presiding judge, hearing officer, arbitration chair, or master except for the following:
  - a. Custody Conference Officers shall continue to conduct their conferences by ACT (video or telephone) unless the officer determines that cause exists to conduct the conference in-person. If a conference is to be held in-person, the conference officer shall contact Court Administration for a room assignment.
4. The public is permitted to enter the Courthouse for court proceedings. Each presiding judge shall determine the number of people that can safely be in the Courtroom at a given time. The Sheriff assigned to a specific courtroom shall enforce the courtroom capacity as directed by the presiding judge.
5. **Hearings scheduled for June, July, and August 2021 using Windstream shall proceed as scheduled unless otherwise directed by the presiding judge, hearing officer, arbitration chair, or master.**
6. All juvenile hearing officers, guardians *ad litem*, parent attorneys, and solicitors shall be present in the Courtroom for all hearings beginning June 1, 2021.
7. **Report times for all in-person proceedings shall be staggered to avoid crowding in courtrooms, hallways, and elevators.** It is the responsibility of the office scheduling the in-person proceedings to make sure that these report times are staggered.

#### **IN-PERSON PROCEEDINGS (MAGISTERIAL DISTRICT JUDGES)**

8. **Beginning June 1, 2021**, proceedings shall be in-person **unless** otherwise directed by the Magisterial District Judge that the proceeding will be conducted by advanced communication technology (ACT) (video or telephone). Counsel and parties may request that the proceedings be held using ACT, but this decision is within the discretion of the presiding Magisterial District Judge.
9. **Report times for all in-person proceedings shall be staggered to avoid crowding in courtrooms and hallways.** It is the responsibility of the office scheduling the in-person proceedings to make sure that these report times are staggered.
