Plaintiff insurance company filed a summary judgment motion seeking a declaration that it was not obligated to provide auto insurance coverage to the insured.

1. Isaac Green was killed in a motorcycle accident in July of 2018. The motorcycle was covered under a policy with non-party Progressive, under which the decedent rejected UM/UIM benefits. After decedent's estate settled for the policy limits, it sought UM/UIM benefits from Atlantic States with which decedent and his wife had an auto policy on three other vehicles and under which they had chosen to stack the UM/UIM benefits. The motorcycle was not an insured vehicle under the Atlantic States' policy.

2. The insurance company initiated a declaratory judgment action seeking a declaration that it was not obligated to cover the estate's claim, relying upon the policy's household exclusion, which it argued precluded the estate from asserting any right to inter-policy stacking with the Progressive policy. The estate countered that household exclusions had been declared invalid in *Gallagher v. GEICO Indem. Co.*, 201 A.3d 131 (Pa. 2019).

3. The Court granted the insurance company's summary judgment motion, citing a newly-issued dispositive decision by the Superior Court distinguishing *Gallagher* and rejecting the argument proffered by the estate.

MEMORANDUM

Pursuant to Pa.R.A.P. 1925(a)

Defendant Juanita Green, individually and as Administratrix of the Estate of her late husband, Isaac Green, appeals from an Order of June 24, 2021, in which this Court granted the summary judgment motion filed by Plaintiff Atlantic States Insurance Company (Atlantic States) in this declaratory judgment action. This Court's Order declared and decreed that Atlantic States was not obligated to provide Defendant uninsured (UM) or underinsured (UIM) motorists benefits under its policy with Mr. and Mrs. Green for damages suffered by Mrs. Green (individually and as Estate Administratrix) arising from a motorcycle accident on July 19, 2018, which claimed Mr. Green's life. This Memorandum is offered in support and as a supplement to this Court's Order of June 24, 2021, pursuant to Pa.R.A.P. 1925(a).

Background

At the time of the accident, Mr. Green's motorcycle was insured through Progressive Insurance. Mr. Green rejected UM and UIM benefits from Progressive by signing a valid PA MVFRL rejection of benefits form. Mrs. Green later settled her claims with Progressive for the policy limits and thereafter sought collection of additional UM/UIM benefits from Atlantic States. On the date of the accident, the Greens had been covered by an Atlantic States policy (PAG 3125738-07) insuring three other motor vehicles they owned

(a GMC Sierra, a Ford Focus, and Jeep Grand Cherokee). The Atlantic States' policy provided UIM benefits in the amount of \$100,000 per person and \$300,000 per accident, stacked times three vehicles. The motorcycle Mr. Green was operating at the time of the accident was not identified as an insured vehicle under the Greens' policy with Atlantic States.

Atlantic States filed this action in response to Defendant's demand for coverage of UM/UIM benefits, seeking that this court issue a declaration that, as a matter of law, it has no obligation to provide such benefits under its policy. Atlantic States argued, in its summary judgment motion, that the household exclusion included in its policy with the Greens precluded them from asserting any right to inter-policy stacking as between the UM/UIM benefits conferred under Atlantic States' policy and Greens' motorcycle policy, particularly since Mr. Green had explicitly rejected UM/UIM benefits under the motorcycle policy.¹

Defendant countered that the household exclusion did not apply here since such exclusions were declared invalid by the Pennsylvania Supreme Court in Gallagher v. GEICO Indem. Co., 650 Pa. 600, 201 A.3d 131 (2019). Following submission of the parties' briefs addressing Atlantic States' summary judgment motion, and prior to oral argument thereon, the Pennsylvania Superior Court issued a decision on May 10, 2021, distinguishing Gallagher and rejecting the argument proffered by Defendant. Erie Ins. Exch. v. Mione *infra*. In Mione, the Superior Court held that the household exclusion is not invalid, under facts substantively identical to those presented in this matter. As such, this Court issued the following:

ORDER

AND NOW, this 24th day of June, 2021, upon consideration of Plaintiff Atlantic States Insurance Company's Motion for Summary Judgment, Defendant's Response, briefs of record, and following oral argument, it is **ORDERED** that Plaintiff's Motion for Summary Judgment is **GRANTED** and it is hereby **DECREED and DECLARED** that Plaintiff has no obligation to provide uninsured or underinsured motorists benefits to Defendant pursuant to Atlantic States Insurance Company automobile policy PAO 3125738-07 in relation to any claim arising from the motor vehicle accident of July 19, 2018. The parties agree that the coverage issue is governed by the Superior Court's recent decision in Erie Ins. Exch. v. Mione, 2021 PA Super 91, __ A.3d __, (Pa. Super. May 10, 2021), which is dispositive and prohibits Defendant from obtaining the uninsured or underinsured motorists benefits it seeks from Plaintiff. See also, Eichelman v. Nationwide Ins. Co., 711 A.2d 1006 (Pa. 1998) (where the plaintiff did not pay for UIM coverage on his

¹ The Household Exclusions in Defendant's policy stated that: "We do not provide [Uninsured] [Underinsured] Motorists Coverage for "bodily injury" sustained: 1. By you while "occupying" or when struck by, any motor vehicle you own or lease which is not insured for this coverage under this policy."

motorcycle policy and the Supreme Court held that the “household exclusion” prevented him from recovering UIM benefits under auto policies issued to members of his household).

Accordingly, this Court issued the Order dated June 24, 2021, from which Defendant appeals.

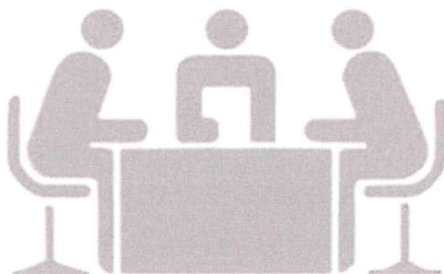
