Additional Custody Provisions Directed at Father

Finally, Father argues that this court erred by including provisions in the final custody order directing that he (a) schedule an appointment with his family physician to conduct an annual exam and shall obtain and abide by all health, nutritional and exercise recommendations, (b) enroll in a parenting class absent evidence of a lack of parenting skills, (c) enroll in psychotherapy absent evidence absent sufficient evidence of mental health needs and (d) be barred him from gaming.

All of these directives were proper and the need for them supported by substantial evidence. With regard to father's health, the evidence was that Father was not getting regular health care despite his recent history of colon cancer, as well as a cyst of long term duration. He admitted he needs to have his physical (and mental) health together to take care of children in his custody. Regarding the parenting class requirement, there existed credible testimony that Father is depressed and that as a result, he disengaged from the children while spending a lot of time playing computer and video games. He was clearly in need of improving his parenting skills on many planes. Regarding the requirement he obtain some type of mental health counseling, the evidence was that he has been depressed for some time resulting in his lack of ambition or focus and an inability to obtain employment in a field (IT) with a strong job market. His depression also seriously eroded his parenting skills and his ability to attend to his home and his personal health. Finally, there was credible evidence that Father had been spending a significant portion of his day escaping from reality by engaging in gaming and other online activities. In fact, his propensity to spend so much time gaming was a characteristic that defined him in his children's eyes.

Accordingly, I entered custody orders on October 4 and October 5, 2016.

M.S. v. J.D.

Domestic Relations - Child Custody - Grandparent Standing

Paternal Grandmother filed an amended petition to intervene in a custody action. She alleged that her relationship with the child began with the consent of the child's father; that she is willing to assume responsibility for the child; and that the child is substantially at risk due to parental emotional abuse, neglect and alcohol abuse. The Court determined that she had not met her burden of proof, but ordered a parenting course, individual therapy, and professional evaluation.

1. Grandparents of a child who are not *in loco parentis* to that child may file an action for custody if they can establish that: (i) their relationship with the child began with the consent of a parent of the child; (ii) they are willing to assume responsibility for the child; and (iii) the child is substantially at risk due to parental abuse, neglect, drug or alcohol abuse or incapacity. 23 Pa. C.S. § 5324(3),

2. Parents in Pennsylvania are permitted to discipline their children using corporal punishment. *See J.B. v. Dep't of Public Welfare*, 824 A.2d 342, 345 (Pa. Commw. Ct. 2003). Corporal punishment applied for

disciplinary purposes does not constitute per se abuse. However, the intent of the person applying the punishment and its severity have been scrutinized by Pennsylvania's appellate courts.

OPINION

Presently before this court is an Amended Petition to Intervene in the above-captioned case, filed on September 21, 2016, by Intervenor, E.S. (hereinafter "PGM Sizer"), the Paternal Grandmother to the subject child (hereinafter "MS"). A hearing was held on January 24, 2017 where the parties presented testimony in support of their respective positions to PGM Sizer's Amended Petition to Intervene.

Factual Background

Plaintiff, M.S. (hereinafter "Father"), and Defendant, J.D. (hereinafter "Mother"), gave birth to MS in 2012. Father and Mother are not and have never been married to each other. Mother currently has a boyfriend and Father is currently married to A.S. (hereinafter "Ashley"). Mother has her own threebedroom apartment where she resides with her daughter¹, age 7, and MS. Father and Ashley reside in a three-bedroom home along with Ashley's four children², ages 4, 5, 7, and 10. Father is currently employed as a chef.

PGM Sizer is a single, divorced adult, residing in Harrisburg, PA. Both PGM Sizer and MS's Maternal Grandmother, J.P. (hereinafter "MGM Pena"), have been involved in various aspects of MS's life. Mother and Father agreed to shared legal and physical custody of MS with Father having Thursday through Monday every weekend, except one weekend a month when Mother has Sunday. After originally permitting PGM Sizer to have contact with MS, Mother and Father eventually refused PGM Sizer any contact with MS.

Father's relationship with PGM Sizer is extremely toxic and tumultuous, exacerbated by a beach vacation in the summer of 2016. Father and Ashley invited PGM Sizer to a vacation stay at the beach with MS, as well as Ashley's four minor children and another child. PGM Sizer had some contact with all of these children as a babysitter over the past year, but her sincere attachment and interest was to her own grandson, MS. PGM Sizer saw the beach vacation as an opportunity to bond with her grandson, but soon realized she was thrown into a blended family situation that left her unsettled, which led to intense bickering between PGM Sizer, Father, and Ashley in front of all the children. Upon the request of Father and Ashley for PGM Sizer to leave, PGM Sizer, who had traveled to the beach with Father, Ashley, and the

children, purchased a bus ticket and returned home to Pennsylvania. Prior to December 2016, this was the last time that PGM Sizer had seen or had any contact with MS.

Procedural History

The docket entries relevant to the matter before this court begin with a July 19, 2016 entry where Mother filed a Petition for Contempt and Modification of a May 11, 2016 Custody Order seeking primary physical custody of MS and giving partial physical custody of MS to Father. PGM Sizer filed a Petition to Intervene on August 18, 2016 alleging standing pursuant to 23 Pa. C.S. § 5325(2).³ On August 29, 2016, this court issued a Rule upon Mother and Father to show cause why PGM Sizer should not be permitted to intervene. By mutual agreement between Mother and Father, on September 1, 2016 a Parenting Plan Order was issued giving Mother and Father shared legal custody of MS, Mother primary physical custody of MS, and Father partial physical custody of MS. The Order also instructed the parties to enroll MS in pre-school.

On September 9, 2016, Father filed a Response to PSG Sizer's Petition to Intervene in which he alleged that PGM Sizer maintained a "sporadic unstable relationship with [MS]". Also on September 9, 2016, the Pennsylvania Supreme Court rendered a decision in *D.P. v. G.J.P.*, 146 A.3d 204, 216-17 (Pa. 2016) where it held 23 Pa. C.S. § 5325(2) unconstitutional and severed the provision that referred to grandparent standing based on the parents of the child [having] been separated for a period of at least six months.

Mother filed her Preliminary Objections to PGM Sizer's Petition to Intervene on September 14, 2016 wherein she cited *D.P. v. G.J.P.*, 146 A.3d 204 (Pa. 2016) and requested that PGM Sizer's Petition be dismissed because she "lacks the capacity to sue as she lacks standing under 23 Pa. C.S. § 5325." Consequently, PGM Sizer filed an Amended Petition to Intervene on September 21, 2016. PGM Sizer's Amended Petition to Intervene alleged grandparent standing pursuant to 23 Pa. C.S. § 5324. Specifically, PGM Sizer's Amended Petition to Intervene alleged standing pursuant to 23 Pa. C.S. § 5324(3) "as [her] relationship with the child began with the consent of a parent of the grandchild; she is willing to assume responsibility for the child; and the child is substantially at risk due to parental emotional abuse, neglect and alcohol abuse." *Amended Petition to Intervene and Amend Caption to Include Paternal Grandmother Pursuant to 23 Pa. C.S. § 5324*, 09/21/16, ¶ 6.

Mother filed her Preliminary Objections to PGM Sizer's Amended Petition to Intervene on October 10, 2016 wherein she asserted that PGM Sizer has not established standing because she has failed to pled sufficient facts to show that MS is substantially at risk due to parental abuse or neglect. After multiple continuances, this court issued an Order on November 23, 2016 scheduling a hearing for January 24, 2017. On January 3, 2017, Mother filed an Emergency Petition for Special Relief in Custody seeking sole custody of MS because she alleged that Father had been physically abusive towards MS. This court granted Mother's emergency petition on January 4, 2017 awarding her "temporary, primary physical

³ PGM Sizer's Petition asserted standing on the grounds that Mother and Father "have been separated for a period of at least six (6) months." *Petition to Intervene and Amend Caption to Include Paternal Grandmother Pursuant to 23 Pa. C.S § 5325*, 08/18/16, ¶ 6.

custody and shared legal custody of [MS] until [the] hearing is held on January 24, 2017.⁹⁴ One week prior to the hearing date, Father filed a Petition for Civil Contempt of a Custody Order.

On January 24, 2017, this court held a hearing wherein Mother, Father, and PGM Sizer were all present. Father was the only party present that was not represented by counsel. Prior to reaching the merits of PGM Sizer's Amended Petition to Intervene, Mother's counsel made an oral motion to withdraw her preliminary objections to PGM Sizer's Amended Petition to Intervene on the grounds that she no longer objects to PGM Sizer intervening.

Discussion

Grandparents of a child who are not *in loco parentis* to that child may file an action for any form of physical or legal custody if they can establish that:

(i) [their] relationship with the child began either with the consent of a parent of the

child or under a court order;

(ii) [they] assume[] or [are] willing to assume responsibility for the child; and

(iii) [] one of the following conditions is met:

(A) the child has been determined to be a dependent child under 42 Pa. C.S. Ch. 63 (relating to juvenile matters);

(B) the child is substantially at risk due to parental abuse, neglect, drug or alcohol abuse or incapacity; or

(C) the child has, for a period of at least 12 consecutive months, resided with the grandparent, excluding brief temporary absences of the child from the home, and is removed from the home by the parents, in which case the action must be filed within six months after the removal of the child from the home.

23 Pa. C.S. § 5324(3).

In this case, PGM Sizer has established that her relationship with MS began with consent of Father. Specifically, PGM Sizer's testimony, along with Father's testimony, revealed that PGM Sizer would essentially babysit MS and Ashley's four children at Father's house while Father and Ashley were at work. Furthermore, neither Father nor Mother disputed that for nearly 1 ½ years, PGM had taken MS "to church every Sunday and had custody of [MS] from Friday to Sunday of most weekends." *Amended Petition to Intervene*, 09/21/16, ¶ 14. In addition, PGM Sizer was asked by Father and Ashley to accompany all of them, including MS, on a family beach vacation.

Secondly, PGM Sizer has exhibited behavior consistent with her willingness to assume responsibility of MS. For example, PGM Sizer had cared for MS while Father and Ashely were at work, including changing diapers, feeding and clothing MS. Moreover, PGM Sizer had regularly brought MS to church and Sunday school, had paid for and taken MS to swimming lessons, and most recently on the family beach vacation had offered to change, bathe, and feed MS.

⁴ This court requested a 23 Pa. C.S.A. § 5329.1 report from Dauphin County Children and Youth Services, which was reviewed and considered in this proceeding.

Lastly, PGM Sizer alleged, under 23 Pa. C.S. § 5324(3)(iii)(B), that MS is substantially at risk due to "parental *emotional*⁵ abuse, neglect and alcohol abuse." To support this claim, PGM Sizer made multiple allegations about Father's treatment of MS, including how Father spanks MS when he has an accident in his pants, drives recklessly and without a license, and uses inappropriate, vulgar language in the presence of MS.⁶ *Amended Petition to Intervene*, 09/21/16, ¶ 29-31.

During PGM Sizer's case-in-chief, PGM Sizer testified that Mother and she "ironed out" their differences during a phone call on December 2, 2016, and since that time PGM Sizer has seen MS "weekly" during Mother's physical custody time. PGM Sizer also testified on direct examination that MS told her that Father hits him with a belt. Two separate witnesses substantiated this claim, namely Mother and MGM Pena. Mother testified that MS is very reluctant to leave her to go back with Father out of fear that he may hit MS. Mother also testified that on one occasion, Ashley texted Mother that Father was extremely depressed and experiencing an anxiety attack and thus it would not be in the best interest of MS to visit Father on his scheduled custody time.

MGM Pena testified that she has seen bumps and bruises on MS. In addition, MGM Pena testified that she observed MS put his hands up in a shielded position when he "dropped a Cheerio on the floor." However, no testimony was presented to substantiate that MS was fearful *because of* Father or that the bumps and bruises on MS were *caused by* Father. During Father's rebuttal, he did not dispute that he "spanks" MS, and in fact admitted that he has used a belt to discipline MS.

Under 23 Pa. C.S. § 5322, "abuse" is defined as it is defined in 23 Pa. C.S. § 6102 (relating to definitions in the Protection From Abuse Act). The Protection From Abuse Act defines "abuse" as:

[t]he occurrence of one or more of the following acts between family or household members, sexual or intimate partners or persons who share biological parenthood:

(1) Attempting to cause or intentionally, knowingly or recklessly causing bodily injury, serious bodily injury, rape, involuntary deviate sexual intercourse, sexual assault, statutory sexual assault, aggravated indecent assault, indecent assault or incest with or without a deadly weapon.

(2) Placing another in reasonable fear of imminent serious bodily injury.

(3) The infliction of false imprisonment pursuant to 18 Pa.C.S. § 2903 (relating to false imprisonment).

(4) Physically or sexually abusing minor children, including such terms as defined in Chapter 63 (relating to child protective services).

⁵ It should be noted that 23 Pa. C.S. § 5324(3) does not contain the word or reference "emotional". PGM Sizer's Amended Petition to Intervene inserts "emotional" before the word "abuse". Given this allegation, this court presumed the testimony would be tailored toward the alleged emotional abuse that MS was suffering from while in the care of Father. However, during the hearing held on January 24, 2017, much of the testimony and evidence was oriented around *physical* abuse allegedly caused to MS by Father.

⁶ On the drive down to the beach with Father, MS, Ashley, and her four children, PGM Sizer expressed her concern to Father about the children not being properly restrained in booster seats or seatbelts, and Father replied to "Shut the fuck up!" and "I'll leave you right off the side of the freeway!". Also during the family beach vacation, when MS asked Father to be permitted to sleep with PGM Sizer, Father replied "No. You're not staying with that miserable bitch."

(5) Knowingly engaging in a course of conduct or repeatedly committing acts toward another person, including following the person, without proper authority, under circumstances which place the person in reasonable fear of bodily injury. The definition of this paragraph applies only to proceedings commenced under this title and is inapplicable to any criminal prosecutions commenced under Title 18 (relating to crimes and offenses).

23 Pa. C.S. § 6102.

This court acknowledges that parents in Pennsylvania are permitted to discipline their children using corporal punishment. *See J.B. v. Dep't of Public Welfare*, 824 A.2d 342, 345 (Pa Commw. Ct. 2003); *see also Boland v. Leska*, 454 A.2d 75, 78 (Pa. Super. Ct. 1982) ("[p]arents or guardians may use corporal punishment to discipline their children so long as the force used is not designed or known to create a substantial risk of death, serious bodily injury, disfigurement, extreme pain or mental distress or gross degradation"). Numerous Pennsylvania courts have been called upon to establish a boundary defining when a parent's use of corporal punishment rises to the level of abuse.

In *Chronister ex rel. Morrision v. Brenneman*, 742 A.2d 190, 193 (Pa. Super. Ct. 1999), Father's conduct in disciplining his 16-year-old daughter by administering corporal punishment in the form of hitting her four or five times with a folded belt across the buttocks after she admitted lying to him did not constitute "abuse" under the Protection From Abuse Act's definition of abuse. Likewise, in *J.B.*, the Pennsylvania Commonwealth Court confirmed Pennsylvania's long-established principle that a parent's use of corporal punishment is a permissible means of discipline within certain boundaries. *J.B.*, 824 A.2d at 345. The testimony presented in *J.B.* showed the subject child had bruises on his bottom and expressed difficulty sitting for a few days. *Id.* Ultimately, the Pennsylvania Commonwealth Court affirmed the trial court's position that this did not rise to abuse. *Id.* Additionally, in *D.G. v. D.B.*, 91 A.3d 706, 712-13 (Pa. Super. Ct. 2014), the Superior Court held that there was not substantial risk of abuse or neglect even though the record contained evidence that Mother exhibited "poor parenting skills", such as inability to maintain employment and inability to get child to school and medical appointments.

On the other hand, in *B.T.W. ex rel. T.L. v. P.J.L.*, 956 A.2d 1014, 1016 (Pa. Super. Ct. 2008), the subject child had been smacked and hit with a belt, had her hair pulled, had bruising and marks on her back because she did not help around the house. The Superior Court upheld the trial court's finding that a sufficient amount of evidence existed "to demonstrate that [the subject child] had been abused, suffering bodily injury in the process, and had been placed in fear of serious bodily injury, all of which warranted issuance of a protection from abuse order." *B.T.W.*, 956 A.2d at 1016-17.⁷ Ultimately, the Superior Court found that the stepmother's conduct "constituted abuse, not permissible corporal punishment for misbehavior." *Id.* at 1015.

In summary, corporal punishment applied for disciplinary purposes does not constitute *per se* abuse. However, the intent of the person applying the use of corporal punishment and the severity of it

⁷ Since the definition of "abuse" under 23 Pa. C.S. § 5322 references the definition of "abuse" under the Protection From Abuse Act, then this case comparison is relevant to whether MS is substantially at risk of parental abuse here.

have been scrutinized by Pennsylvania's appellate courts. Here, as noted above, multiple witnesses expressed concern that MS was being abused physically and emotionally by Father.⁸ Following the testimony and evidence presented at the hearing on January 24, 2017, this court makes the findings of fact listed below.

Findings of Fact

- Mother is the mother of MS and a daughter, age 7. She lives in a three-bedroom apartment in Carlisle, Pennsylvania.
- Despite Father's accusation that Mother either smokes or exposes MS to marijuana, no evidence was presented to substantiate this claim. Mother denied using the substances.
- 3. Mother obtained a Protection From Abuse order against Father in 2013.
- 4. On December 1, 2016, Ashley texted Mother that Father was not emotionally fit to exercise his partial custody and that she should not bring MS over. Ashley indicated that she had taken her four children to their respective fathers for their safety.
- Mother filed an Emergency Petition on January 3, 2017 asking for Father's partial custody to be suspended based on a belief that Father was excessively disciplining MS.
- 6. MGM Pena testified that she heard MS state he was afraid to go to his Father's home and that his step-brother (age 4) had hurt him.
- 7. Father is the father of MS. He is married to Ashley, who is the mother of four small children with four separate fathers.
- 8. Father and Ashley live in Highspire, Pennsylvania in a three-bedroom home with Ashley's four children, MS (when he is with them), and a sixth child who is a "godchild". Sleeping arrangements are shared by the six children between the two bedrooms, a couch and the floor. Father and Ashley have their own bedroom.
- Father has three DUI convictions and does not have a driver's license. He is currently on probation. He has a fairly extensive criminal history, including disorderly conduct and use of obscene gestures following an incident with his neighbor in July 2016.
- 10. Ashley was also convicted following the incident with the neighbor in July 2016.
- 11. Father takes medication for anxiety and admitted he is overwhelmed at times with the custody situation involving Mother and PGM Sizer.
- 12. PGM Sizer testified regarding her great concern and fear for MS's safety due to Father's use of a belt on MS for discipline, as well as concerns about his erratic driving, especially when he has no license.
- PGM Sizer is concerned that the other children in Father's household, especially Ashley's fouryear-old son, is bullying and hurting MS.
- PGM Sizer currently has a good relationship with Mother and is seeing MS regularly during Mother's custodial time with MS.
- 15. PGM Sizer stated emphatically she is "done" with her relationship with Father.

⁸ According to the CYS caseworker's statements in the §5329.1 Report, MS stated that he had been spanked on the butt, but could not express the level of pain. However, the CYS caseworker also observed that MS appeared to be happy while in Father's presence and did not want to leave.

Ultimately, this court makes the following conclusions of law based upon all of the testimony and information presented to and considered by this court.

Conclusions of Law

Applying the appellate rulings to the finding of fact in the case at bar, this court holds that PGM Sizer has not met her burden to prove that MS is substantially at risk due to parental abuse, neglect, drug or alcohol abuse or incapacity.

In reaching this holding, the court did consider the testimony of Mother, Father, PGM Sizer, and MGM Pena. While they were credible in their sincere concern and reaction to MS's behaviors, Father was also credible in his explanation of events and was candid in recognizing his stress, which was clearly exacerbated by PGM Sizer's interaction with Father and his newly- blended family. That is not to say that Father always exercises good judgment when interacting with MS. In fact, by Father's own admission, he is frequently "stressed out" to the point he knows he should not be around MS or his stepchildren. To his credit, he decided not to exercise his physical custody rights of MS while he was feeling emotionally overwhelmed. Since Father testified that MS is "a good boy" and the only time he is spanked is when he has an accident in his pants, Father clearly needs therapeutic intervention to teach him positive parenting skills.

The court met briefly with MS to determine his capacity to testify and found that the child was not competent to testify due to his young age and timidity. MS presented to the court in chambers as a shy, diminutive, endearing little boy who is caught up in the noise and commotion of a large family of stepsiblings and the toxic, mutually-antagonistic relationship between Father and PGM Sizer. Therefore, Father will be ordered to attend a parenting course, and it is strongly recommended that Ashley attend the course as well. Further, Father should immediately begin individual therapy addressing disciplining methods other than corporal punishment to help Father distinguish between what behaviors in MS require discipline versus positive reinforcement or behavior modification to help MS become fully toilet trained. Additionally, Father's therapy should address coping methods to control his own stress in light of the number of children in his household and their interactions with each other and MS.

Finally, the court will order an evaluation of MS by a licensed psychologist for the purpose of determining if MS would benefit from therapeutic intervention in light of his issues with toilet training. If recommended by the psychologist, Mother and Father should comply with attending such therapy session with the child either separately or together, depending on the recommendation of the therapist.

Accordingly, this court enters the attached Order.
