1. The sale will be cancelled if you pay back to Nationstar Mortgage LLC, the amount of the judgment plus costs or the back payments, late charges, costs, and reasonable attorneys fees due. To find out how much you must pay, you may call: (610) 278-6800.

2. You may be able to stop the sale by filing a petition asking the Court to strike or open the judgment, if the judgment was improperly entered. You may also ask the Court to postpone the sale for good cause.

3. You may be able to stop the sale through other legal proceedings.

4. You may need an attorney to assert your rights. The sooner you contact one, the more chance you will have of stopping the sale. (See notice below on how to obtain an attorney.)

6. You may be able to petition the Court to set aside the sale if the bid price was grossly inadequate compared to the value of your property.

7. The sale will go through only if the buyer pays the Sheriff the full amount due in the sale. To find out if this has happened you may call 717-255-2660.

8. If the amount due from the buyer is not paid to the Sheriff, you will remain the owner of the property as if the sale never happened.

9. You have a right to remain in the property until the full amount due is paid to the Sheriff and the Sheriff gives a deed to the buyer. At that time, the buyer may bring legal proceedings to evict you.

10. You may be entitled to a share of the money, which was paid for your house. A schedule of distribution of the money bid for your house will be filed by the Sheriff no later than thirty days after the Sheriff Sale. This schedule will state who

will be receiving the money. The money will be paid out in accordance with this schedule unless exceptions (reasons why the proposed distribution is wrong) are filed with the Sheriff within ten (10) days after the date of filing of said schedule.

11. You may also have other rights and defenses or ways of getting your house back, if you act immediately after the sale.

The Judges have completed the JANUARY 2017 civil jury term. Two civil cases reached verdict during the January civil term and the summary is as follows:

HASSAN FLOYD, JR., a minor by his parent and natural guardian, SANDRA KOLFLEICH v. NICO ACRI (2015-CV-00992-CV)

This is a vehicle/pedestrian accident that occurred in June 2014 on Pine Street in Steelton. The parties entered into a pre-trial agreement on factual cause and damages. The only issue for the jury was whether the Defendant was negligent, whether the Plaintiff was comparatively negligent and if so, the jury was asked to assess the percentages of negligence to each party. Plaintiff's minor was 11 years old at the time of the accident.

The jury determined that both Plaintiff's minor and defendant were negligent. Defendant was 45% negligent, and the Plaintiff minor was 55% negligent.

Accordingly, the verdict was molded for judgment in favor of the Defendant.

JOHN DOE, a minor, by JOSH DOE, Guardian v. IRA TASK (2016-CV-4717-CV)

This case arose from a criminal proceeding in Cumberland County. Defendant Ira Task plead guilty to Rape of Child, Conspiracy – Rape of Child, Aggravated Assault – Victim Less Than 13 and Defendant 18 or older, Criminal Solicitation – Dissemination of Photo/Film of Child Sex Acts, Child Pornography, Criminal Use of Communication Facility, Corruption of Minors – Defendant Age 18 or Above, and plead *nolo contendere* to Conspiracy – Photograph/Film/ Depiction on Computer of a Sex Act – Knowingly or Permitting Child. Defendant was found to be a sexually violent predator and was sentenced to an aggregate term of fifteen (15) to thirty (30) years in a state correctional institution.

Plaintiff is victim of Defendant's heinous crimes and initiated this action in Dauphin County to recover civil damages. After being advised of his rights at the pretrial conference, Defendant voluntarily chose not to participate in the trial. After a one (1) day trial wherein Defendant did not appear, the jury returned a verdict in favor of Plaintiffs.
