## "EXPAND YOUR CUSTODY/DEPENDENCY PRACTICE TO REPRESENT IMMIGRANT CHILDREN AND THEIR CARETAKERS"

**Brief summary:** HIAS-Pennsylvania, with support from Stoneleigh Foundation, is pleased to present this free training, "Expand Your Custody/Dependency Practice to Represent Immigrant Children and Their Caretakers"

Many children in Pennsylvania lack legal immigration status and are at risk of being separated from their caretakers, denied services, and forcibly returned to places where they will be exploited or abused. Some of these children can apply for legal immigration status because they are Special Immigrant Juveniles ("SIJs"). But, before children can apply for this special protection, they or their caretakers must obtain certain findings of fact, which can only be made by a state or county court, often in custody or dependency proceedings.

This training teaches attorneys who handle custody/dependency proceedings to represent SIJ-eligible children or caregivers in these contexts. After the training, we'll invite interested attorneys to develop their new skill by joining our team of volunteers who accept pro bono referrals in this niche area of family/child welfare law. During the training, we'll cover:

- Who is eligible for SIJ classification
- How to represent SIJ-eligible children/caretakers in Dauphin county
- Common court concerns/Trouble shooting

Pursuant to Continuing Legal Education Rules, this program has been approved by the PA CLE Board for one (1.5) substantive credits for all attendees who participate in the complete program.
