The Pennsylvania Supreme Court has adopted a new Public Access Policy of the Unified Judicial System of Pennsylvania: Case Records of Appellate and Trial Courts, which will impact how attorneys file legal documents in the trial and appellate courts, **beginning January 6, 2018**.

This CLE course will help registrants to analyze the specific requirements under the new policy and what sanctions may be imposed for non-compliance. Ethical considerations and malpractice avoidance will also be discussed.

Pursuant to Continuing Legal Education Rules, this program has been approved by the PA CLE Board for one hour of CLE **ETHICS** credit for all attendees who participate in the complete program.
