Dauphin County has an arbitration procedure whereby attorneys sit as arbitrators for a two-year term. There are six (6) panels with each panel sitting twice a year. The cases are heard one (1) week each month with the schedule appearing on the Court Calendar. For the 2015/2016 term, the 12 associate arbitrators were paid \$2,600.00 per year, and the 6 panel chairs received \$3,300 per year. Consecutive terms are not permitted.

If you are willing to serve as an Arbitrator for a period of two (2) years, please complete the attached questionnaire and return it by <u>Friday, September 2, 2016</u> to the Dauphin County Bar Association, 213 North Front Street, Harrisburg, PA 17101. Upon receipt of the questionnaires, the Board of Directors will select approximately thirty (30) names and submit these names to the Dauphin County Court. The Court will then select attorneys from that number to serve as arbitrators.
