PRESIDENT'S MESSAGE

Over the last couple of months, my Bar friends have noticed that I decided to replace my old favorite cocktails (gin and tonic or Chardonnay) with a mocktail (cranberry and club soda). A few people have asked me about that decision, so I thought that I'd share the story in case it may help one of our members.

About three years ago, I realized that something was "off" in my life. I wasn't feeling the satisfaction from my work that I previously had experienced, I couldn't relax when I had time away from work to spend with my family, and my favorite hobby (golf) was being supplanted by wanting to go directly to the 19th Hole for a glass of wine. The things that I valued most in my life—my family, my faith, my career and my health—were in danger of moving down the priority list as "relieving" my stress through alcohol was moving up. This situation had developed over the prior years, and was getting worse.

I needed to make some changes in my life. I knew from prior attempts that I wouldn't be able to stop drinking on my own. After some research, I found a local treatment facility that emphasized a holistic, non-12 step recovery approach, and that offered a 14-day treatment program. I scheduled my stay a few months in advance so I could work around client commitments. I paid a non-refundable deposit so I wouldn't lose my courage. In February 2013, I sought help to remove alcohol from my system and to develop a plan to live and work without it. I have been following that plan ever since, with an emphasis on using healthy activities to relieve stress, staying "in the moment", and creating a better balance between work and the rest of my life.

I am blessed to work with awesome colleagues who have supported me and respected my privacy the last two years. One of my biggest impediments to getting help was the fear that I would lose friends, lose clients and lose the respect of my peers. Another major impediment was the fear that I would fail. Those fears were part of the destructive and untrue thinking that threatened to keep me stuck in a problem. Now, I know that I had very little reason to doubt the support and encouragement that I would receive from the people who really matter. I apologize to my friends who weren't in the loop, but as you can imagine, I had to work through some issues before I could be more open about this.

Looking back (and with the assistance of a good therapist). I understand that depression, anxiety and an unhealthy perfectionist streak were among the reasons that I started to self-medicate with alcohol. I continue to work on those underlying issues. I'm not sure whether I will go back to drinking some day, but I know that I won't be doing it any time soon. Currently, I like the balance that I have achieved with respect to the things that I value the most (family, faith, career and health). Plus, I am enjoying life. My golf game has even improved!

In Pennsylvania, we are very fortunate to have access to Lawyers Concerned for Lawyers. They can help with a variety of issues, including substance abuse, gambling, stress, anxiety and depression. In addition to their website materials, you also can speak with healthcare professionals to help you determine whether you have a problem, or if you think that a colleague may need help. All of this is done confidentially and discretely. If you think that you or a friend needs help, please contact LCL, or the many other organizations that provide assistance regarding addictions, substance abuse and mental health issues.

A TAX LAWYER FOR THE LITTLE GUY

MidPenn Legal Services Gets IRS Grant to Fund Low-Income Tax Clinic

The MidPenn Low-Income Tax Clinic (LITC) will provide free representation for low-income taxpayers who need legal assistance to resolve disputes with the Internal Revenue Service. Attorney Robert B. Hamilton has joined the Cumberland County MidPenn Legal Services Office to do this work. MidPenn Executive Director Rhodia D. Thomas says, "The IRS has provided these grants to better assist taxpayers and encourage voluntary compliance. It is a complicated area and they want to make it easier to get answers and resolutions."

Attorney Hamilton has over six years of experience as an attorney and for the last two he was immersed in tax filings at a local law firm. He became interested in taxes in law school. "It is a universal set of rules that affects us all. I thought it made sense to learn about taxpayers' rights and responsibilities under the law." At the MidPenn LITC, he will focus not on tax filings but on resolving tax disputes.



Taxpayer Clinic to Handle Disputes - Not a Tax Preparation Site

Unlike Volunteer Income Tax Assistance (VITA) sites which help low-income families with their income tax filings, the MidPenn LITC will focus on resolving disputes with the IRS such as:

- Helping clients in disputes with IRS audits, appeals and collection matters
- Preventing IRS collection in cases of financial hardship
- Helping taxpayers obtain reasonable payment agreements
- Tax problems arising from identity theft
- Innocent spouse cases

Services will also include outreach and education to taxpayers who speak English as a second language.

Tax Attorney to Serve Five Counties

Attorney Hamilton says he enjoys the challenge of helping low-income families navigate these difficult waters. He began work with MidPenn on February 11, 2015. He will handle cases in five counties: Cumberland, Dauphin, Perry, Lancaster and Lebanon. Bob grew up in Camp Hill and lives there with his wife and their three year-old daughter, with another daughter soon to join them.

About MidPenn Legal Services

MidPenn Legal Services provides free civil legal services for low-income clients in critical matters including custody, domestic violence, housing, foreclosures, public benefits, unemployment, consumer law, and bankruptcy. Primary funders are the Pennsylvania Legal Aid Network (PLAN), the Pennsylvania Interest on Lawyers' Trust Accounts (IOLTA) Board and the Legal Services Corporation (LSC). Additional support comes from local groups, private foundations, and individuals.

We receive funding from the Cumberland County Bar Association, the Cumberland County Commissioners, the Big Spring Community Chest, Friends of Legal Services, the United Way of Carlisle and Cumberland County and the United Way of the Capital Region. MidPenn also receives Violence Against Women funding through a subcontract with the Domestic Violence Services of Cumberland and Perry Counties.

Those who take advantage of this training and the accompanying CLE credits are required to take on one case in the following 12 months. In order to attend the training and be certified, please follow the instructions listed below.

REMINDER for Anyone seeking to practice in Veterans Law

- 1) You must get their DVA Accreditation form at http://www.va.gov/ogc/accreditation.asp and have their accreditation notice back from the DVA before the CLE.
- 2) The CLE is required pursuant to 38 C.F.R. § 14.629(b)(1)(iii) and (iv), (a qualifying CLE course must be approved for a minimum of 3 hours of CLE credit by any State bar association)



SPECIAL FUND SUPPORTS LOCAL PRO BOND EFFORTS

Since 2000, the Supreme Court of Pennsylvania has asked each lawyer to donate \$50 annually to a special fund that supports local pro bono initiatives. Make your contribution when you file your annual attorney registration this Spring or anytime online at www.paiolta.org/donate.

In 2006-07, attorneys and firms contributed more than \$85,000 to the fund. Last year, contributions fell below \$40,000. The majority of the attorneys that contribute to the fund are solo practitioners and about 27% have a mailing address outside of Pennsylvania. Of the contributing attorneys living in Pennsylvania, 58% reside in Eastern Pennsylvania, 25% reside in Western Pennsylvania and 17% reside in Central Pennsylvania. The average contribution for an attorney residing in Pennsylvania is \$60. Attorneys with a Florida address are the most generous with an average contribution of \$108. Attorneys with a New York address come in second with an average contribution of \$88.



Contributions to the fund and the associated grants are administered by the IOLTA Board. Grants are awarded to local county bar associations and nonprofit organizations that provide the administrative structure for local pro bono efforts. In the last two years, the following counties received a grant award from this fund for the administration of local pro bono representation of indigent neighbors facing a civil legal crisis: Chester, Cumberland, Delaware, Clinton, Indiana, Washington and Allegheny.

The WLJ Annual Symposium will focus, generally, on the administrative, constitutional and policy considerations in sentencing and the recent efforts to reform sentencing guidelines. In Pennsylvania, the current criminal law reform "hot topic" is Governor Tom Wolf's recent move to halt executions. In addition to serving as a panelist, participants will also have the opportunity to submit a paper on a topic relating to the Symposium, which will be published in Volume 25 (2015-16) of the Widener Law Journal.
