Since 2009, the **National Pro Bono Celebration** is held the last week of October as a means to draw attention to the need for pro bono participation. Not being content with merely a *week* to focus on Pro Bono, the Dauphin County Bar Association declared October to be **DCBA Pro Bono Month.**
