Pursuant to Mandatory CLE Rules, every attorney admitted to active practice in PA must complete twelve (12) hours of CLE each year, including two (2) ethics. Each attorney has been assigned a date for completion of the required hours. If you do not know your assigned completion date, you may call (717) 231-3380 for this information. April 30, 2026 is the next compliance date.
