

TO: All Dauphin County Attorneys
RE: Selection of 2021/2022 Dauphin County Arbitrators

Pursuant to Dauphin County Local Rule 1302, the Bar Association participates in the nomination process for the selection of Dauphin County Arbitrators to hear cases involving \$50,000 or less. **Any attorney whose practice is located in Dauphin County may apply.**

Dauphin County has an arbitration procedure whereby attorneys sit as arbitrators for a two-year term. There generally are six (6) panels with each panel sitting twice a year. The cases are heard one (1) week each month with the schedule appearing on the Court Calendar. For the 2019/2020 term, the 12 associate arbitrators were paid \$1,300.00 a week served, and the 6 panel chairs received \$1,650 a week served. **Consecutive terms are not permitted.**

If you are willing to serve as an Arbitrator for a period of two (2) years, please complete the attached questionnaire and return it by **Friday, August 28, 2020** to the Dauphin County Bar Association, 213 North Front Street, Harrisburg, PA 17101 or email to Bridgette@dcba-pa.org. Upon receipt of the questionnaires, the Board of Directors will select approximately thirty (30) names and submit these names to the Dauphin County Court. (EXCEPTION: YOU MAY NOT SERVE CONSECUTIVE BACK TO BACK YEARS)
